Subject: Increasing the Salaries of City Elected Officials

Summary

This communication recommends that the salaries of City elected officials (Mayor, Common Council Members, Common Council President, City Attorney, City Treasurer, Comptroller) be increased by 4.0% at the commencement of the 2020 term of office, and thereafter be increased 3.0% annually for the remainder of the 2020-2024 term of office. As Municipal Judges follow a staggered election calendar, it is recommended that the salaries of Municipal Judges be increased by 4% beginning in pay period 10 of 2020, and thereafter be increased by 3% annually in 2021, 2022 and 2023.

Background

The salaries of the Mayor, Common Council members, Common Council President and City Attorney have been frozen since 2008, the salaries of Municipal Judges have been the same since 2009 and the salaries of the City Treasurer and Comptroller have been unchanged since 2012.

Beyond the issue of stagnant pay, pension contributions have increased for many elected officials, the same as for many General city employees, reducing take-home pay, while pension benefits have decreased.

The Department of Employee Relations has previously recommended that the rates of pay for elected officials should fairly compensate for the work and responsibilities of the office, serve to attract qualified individuals to public service, and take into consideration



whether the salaries are appropriate in comparison to the rates and responsibilities of other elected officials in the municipality. The salaries of the elected offices of the Comptroller, City Attorney and City Treasurer must also be established taking into consideration the pay structure and pay compression considerations of directly reporting subordinate employees, who for the most part are required to possess highly technical credentials and are compensated accordingly.

In order to establish an appropriate compensation level that can serve as an incentive for individuals to run for office, and to continue to attract well-qualified candidates for City positions in future elections, it is recommended that a salary adjustment be made for City elected officials. This communication recommends that the salaries of City elected officials be increased by 4.0% at the commencement of the 2020 term of office, with 3.0% increases annually thereafter for the remainder of the 2020-2024 term of office. This report further recommends that the salaries of Municipal Judges, who follow a different election calendar, be increased by 4.0% in pay period 10 of 2020, with 3.0% increases annually thereafter in 2021, 2022 and 2023.

Action Required

To implement these salary increases, please replace Section 11 of the Salary Ordinance, relative to rates of pay of elected officials, as follows:

Pay Period 10, 2022, the salary for members of the Common Council (Aldermen) will increase by 3.0% to \$3,107.26 biweekly (\$80,788.76).
