Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

On September 25, 2017, at approx. 3:30p.m., P.O. Emmons and I (sqd 3262) were dispatched to a loitering complaint at Citgo Gas Station, 1341 W. Center St.

Upon arrival I called the caller, Kamal P. Singh (w/m, 04/20/93) who stated there was several subjects on the parking lot selling CDs and refusing to leave his business' property. It should be noted there are several signs posted on the business that states no loitering. Singh described the subjects a black male wearing white shirt and blue pants and an heavy set subject wearing a red shirt.

Upon arrival we observed the subjects loitering near the front door entrance of the business; they immediately began walking away. We were able to detain one of the subjects who was identified as Donaven M. Knox (b/m, 05/13/88). Knox stated he was there trying to get change for food. Knox was taken into custody and conveyed to District 3. He was issued a municipal citation for loitering with a future court date and released.

On Wednesday, November 1, 2017, at 1:10 p.m., Squad 3193 (C.S.O Ralph ROBY and I) was dispatched to 1341 W Center St. regarding a Theft at the CITGO Gas Station.

Upon my arrival, I spoke to caller/cashier, Kamalpreet SINGH (W/M 0/20/93) who stated on Tuesday, October 31, 2017 approximately at 2:45 p.m., three unknown suspects entered the store, intentionally and without consent took five bucket of mix candies (twixt, snickers, sweet pops and kit-Kate) and damaged an "open and closed" sign. SINGH stated that each bucket of candies cost \$20.00, in total of \$100.00. SINGH stated that an "open and closed" sign cost \$50.00. SINGH stated that the incident was caught on camera.

I viewed the security camera video and saw:

On camera counter: Approximately at 2:49 p.m., three unknown suspects entered the store.

Unknown suspect #1: B/M (about 5'5, short dark hair, dark skin, facial hair, in his 20s) were light brown boots with black pant and a black jacket with a light brown collar.

Unknown suspect #2: B/M (about 5'4, short dark hair, light brown skin, no facial hair, maybe 16 years old) wore white and brown shoes with blue or black pant, and a red jacket with big black dots.

Unknown suspect #3: B/M (about 5'5, twisting dark hair, dark skin, no facial hair, maybe 19 years old) wore red shoes with blue pant, and a black jacket with the hood on.

Approximately at 2:50 p.m. unknown suspects #1 and #2 looked around the front counter while unknown suspect #3 stand by the door to keep it opened. Unknown suspects #1 and #2 handed five bucket of mix candies to suspect #3.

Approximately at 2:51 p.m. all three unknown suspects exit the stored, and left west bound toward 13th St.

I retrieved the video and send it to Forensic Investigation.

As of right, the owner, Harjinder SINGH, is not in the United States. I am unable to get his insurance info.




