CLAIM FOR DAMAGES TO CITY OF MILWAUKEE

Dear Sir or Madam:

The following claim for damages is made pursuant to 893.80, stats.

- 1. Chase Graff is an adult resident of the State of Wisconsin, residing at 1633 West Bender Rd., Glendale, WI 53103
- 2. Chase Graff suffered severe bodily injuries when on June 10, 2018 upon information and belief, Officer KNAPP #309 observed a vehicle traveling westbound on 12800 West Hampton Avenue, with a defective driver side headlamp and speeding. Upon information and belief he attempted to catch up to the vehicle however the vehicle increased its speed. He observed a vehicle continuing west bound on Hampton Avenue from 134th St. and the vehicle speed had increased. He advised dispatch that he's trying to catch up with the vehicle. The vehicle then headed northbound on Lily Road from Hampton Avenue while Officer Knapp was still trying to catch up with the pursued vehicle.

It should be noted that Officer Knapp did not activate his emergency lights or sirens. He informed dispatch that the vehicle speed was increasing and to advise Menomonee Falls Police Department that the vehicle and he would be approaching Silver Spring Drive shortly. Officer Knapp activated his emergency lights, upon information and belief and attempted to indicate to the vehicle driver that he was conducting a traffic stop. According to Officer Knapp's report the vehicle continued to travel toward Silver Spring Drive at an unreasonable speed that was faster than the posted speed limit of 40 mile an hour based on his training and experience.

The pursued vehicle and pursuit vehicle then turned onto eastbound Silver Spring Drive from North Lilly Road. According to the officer, he activated his emergency siren, and continued eastbound on by Silver Spring Drive at approximately 100 mph or higher. Upon information and belief Office Knapp informed the dispatch that he was in pursuit of the vehicle now, due to the traffic offenses. Officer Knapp advised dispatch that he was traveling at a speed of approximately 90 miles an hour and that the vehicle was gaining distance on his squad as he approached 131st St. His pursuit was initiated on eastbound Silver Spring Drive from Lily Road.

Chase Graff was walking across the street and was hit by the pursued vehicle and then his right arm was run over by the pursuit vehicle.

- 3. The officer observed a white male with long brown hear, wearing a blue T-shirt tan/brown shorts laying in lane three of West Silver Spring Drive. The officer approached Chase Graff. The officer approached Chase Graff on foot and noticed blood on the subject's face, arms and legs. He noticed Chase Graff lying on his back his with his left leg bent in the wrong direction and that it appeared to be broken based on his training. Chase Graff Indicated to him that he was in a lot of pain and that his left arm and leg hurt and his right hand hurt as well. Chase Graff was walking across the street when he was hit. Chase Graff was transported by City of Milwaukee Police and Fire Department paramedic units to Froedtert Hospital, 9200 W. Wisconsin Ave., Milwaukee, WI 53226. The pursued vehicle fled and was then located by a Milwaukee County Deputy near Highway 41 and Silver Spring Drive in Milwaukee County, Wisconsin.
- 4. At all times material, the Village of Butler, Waukesha County, City of Waukesha And Waukesha Sheriff Department, City of Brookfield, Village of Menomonee Falls, Milwaukee County and Milwaukee Sheriff Department had notice that Chase Graff was involved in the subject accident resulting in bodily injury and damages in said multi-jurisdictional incident which upon information and belief was investigated by (Waukesha Police Department).

- 5. As a direct and proximate cause of the negligence of the Village of Butler, Waukesha County, City of Waukesha and Waukesha Sheriff Department, City of Brookfield, Village of Menomonee Falls, Milwaukee County and Milwaukee Sheriff Department Chase Graff as a direct and proximate cause of the negligence of the Village of Butler, Waukesha County, City of Waukesha and Waukesha Sheriff Department, City of Brookfield, Village of Menomonee Falls, Milwaukee County and Milwaukee Sheriff Department Chase Graff sustained injuries and damages as follows:
 - a. Past and future medical expenses \$2,000,000.00;
 - b. Past and future pain, suffering and disfigurement \$7,000,000.00;
 - c. Past loss of earning capacity \$100,000;
 - d. Future loss of earning capacity \$7,000,000.

Wherefore, Chase Graff demands compensation as itemized above against City of Milwaukee.

SUMMARY OF INCIDENT:

I observed the above vehicle traveling westbound in the 12800 W. Hampton Ave. with a defective driver's side head lamp and speeding. I attempted to catch up to the vehicle, however the vehicle increased its speeds. A pursuit was initiated on eastbound W. Silver Spring Dr. from N. Lilly Rd. The pursuit was terminated shortly after being initiated, due to the speed the vehicle was traveling. The pursuit was terminated within the Village of Butler in Waukesha County. The vehicle was later located by a Milwaukee County Deputy near HWY 41 and W. Silver Spring Dr. in Milwaukee County, abandoned. ALLEN'S cell phone and WI photo ID card were located in the front seat area of the vehicle. Report filed below.

INCIDENT REPORT:

On Sunday, June 10th, 2018, at 2:28pm, I, PO KNAPP, while in full police uniform and in marked Butler squad #723, working from 8pm to 8am, was stationed in the 12900 block of eastbound W. Hampton Ave. in the parking lane facing east running stationary radar on westbound W. Hampton Ave. traffic.

I observed a silver 4 door vehicle, unknown plate at this time of the incident, traveling westbound W. Hampton Ave. at an estimated speed of 40mph. I activated the front stationary radar and locked in the above vehicle traveling at 39mph in 25mph zone. I further observed the vehicle had a defective/burned out driver's side head lamp. I further noticed that there was no front bumper attached to the vehicle and the all the windows besides the windshield were heavily tinted dark so I could not see inside the vehicle.

I pulled from my position and did a U-turn in the median break, located directly in front of the Hampton Regency Apartment, 12999 W. Hampton Ave. I was now westbound W. Hampton Ave. I observed the vehicle continue westbound on W. Hampton Ave. from N. 134th St. and the vehicle's speed had increased.

At 2:29am, I advised dispatch that I was trying to catch up to the above vehicle. I informed dispatch that I was now northbound N. Lilly Rd. from W. Hampton Ave. still trying to catch up to the vehicle. It should be noted that I did not active my emergency lights or siren yet. I informed dispatch that the vehicle's speed was increasing and to advise the Village of Menomonee Falls Police Department that the vehicle and I would be approaching W. Silver Spring Dr. shortly.

As I passed W. Northpark Dr. I activated my squad's emergency lights in an attempt to indicate towards the vehicle's driver that I was conducting a traffic stop, however the vehicle continued to travel towards W. Silver Spring Dr. at an unreasonable speed that was faster than the posted speed limit of 40mph, based on my training and experience. The vehicle then turned onto eastbound W. Silver Spring Dr. from N. Lilly Rd.

At 2:30am, I activated my squad's emergency siren. The vehicle continued eastbound W. Silver Spring Dr. at approximately 100mph or higher. I informed dispatch that I was in pursuit on the vehicle now, due to the traffic offenses. I advised dispatch that I was traveling at a speed of approximately 90mph and that the vehicle was gaining distance on my squad still as I approached N. 131st St.

At 2:31am, I terminated the pursuit due to the speed, reckless driving and the vehicle gaining distance on my squad and making it hard for me to observe the vehicle now. I terminated the pursuit west of N. 124th St. and I deactivated my squad's emergency lights and siren.

As I slowed down and approached N. 124th St. I observed the vehicle in the far distance swerve and then moments later turn northbound onto the northbound on ramp to HWY 41 from W. Silver Spring Dr. I pulled to the right lane of eastbound W. Silver Spring Dr., which was lane #3, and came to a complete stop just east of N. 124th St. I then advised dispatch that I would

remain stationary at the above location for at least one minute per our department policy.

At 2:33am, I advised dispatch that I would continue eastbound W. Silver Spring Dr. to check the area, with no emergency lights or siren activated, to check for any accidents.

At 2:34am, while traveling eastbound on W. Silver Spring Dr. I observed a white male with long brown hair, wearing a blue t-shirt and tan/brown shorts with no shoes on lying in lane #3 of W. Silver Spring Dr. between W. Rae Dr. and N. 118th St., however closer towards N. 118th St. I further observed blood on the subjects face, arms and legs.

I did a U-turn at N. 118th St. and another one at N. Rae Ave. I positioned my squad across lanes #2 and #3 of eastbound W. Silver Spring Dr. to protect the scene and the male subject, later verbally identified as Chase E. Graff (M/W DOB: 04/08/1989), that was laying in the roadway. I requested Milwaukee Fire and Police to the scene.

I approached GRAFF on foot. He was breathing, completely alert and speaking with me. I observed GRAFF lying on his back with his head to the southwest and his legs directly to the northeast of his head. I observed GRAFF'S left leg bent in the wrong direction and it appeared to be broken, based on my training and experience. I advised dispatch of my findings. GRAFF said he was in a lot of pain and that his left leg and arm hurt. I asked GRAFF if he was a passenger in a vehicle and he said, "I don't think so." I asked if he was walking and he said, "Yeah." I asked where he was walking from and he said, "I don't know." GRAFF asked if he got hit by a car and I said, "I don't know if you got hit by a car." I asked if he was walking in the road and he said, "I don't know." I then asked if he was riding in a car at all and he said, "No." He then said, "I got hit hard, whatever happened it was hard." I then asked him again if he was walking in the road and he said, "I honestly can't remember." I asked how long he's been lying in the road and he said, "I don't know." I asked if he knew where he was coming from and he did not know. I asked GRAFF where he was working tonight and he said, "Matt's Motors." Then moments later the City of Milwaukee Police (D4), Fire and Paramedic Units arrived on scene. I then turned the scene over to them. Milwaukee Fire and Paramedic Units advised that they would be transporting GRAFF to Froedtert Hospital, 9200 W Wisconsin Ave, Milwaukee, WI

I then returned to my squad. I immediately called Chief David WENTLANDT via my cell. I informed him of the situation. While speaking with Chief WENTLANDT it was determined that he would be en route to the scene to assist.

While I was attending to GRAFF dispatch advised that a Milwaukee County Sheriff's Deputy, later verbally identified as Deputy GAREY (#179), had located a vehicle that matched my fleeing vehicle at W. Silver Spring DR. and HWY 41 that our dispatch center had provided to Milwaukee County jurisdictions earlier to be on the look out for.

I then photographed the scene where GRAFF was lying in the roadway, which was approximately the 11800 block of eastbound W. Silver Spring Dr. for our records. I attached the photos to this report.

I arrived on scene at W. Silver Spring Dr. and HWY 41. I observed a vehicle that was located off the roadway, just to the northeast of the northbound on ramp to HWY 41 from W. Silver Spring Dr. The vehicle was facing towards the north. I observed the front driver's side and rear driver's side doors were open. I observed the vehicle had no bumper, no front passenger side mirror (later located at the scene where GRAFF was by Milwaukee Police), a spider cracked windshield on the passenger side of the vehicle (the windshield was bowed inwards as if something large may have hit it), scratches along the front and rear passenger side doors and a busted rear driver's side tail lamp cover.

Deputy GAREY advised that there was no one inside the vehicle when she arrived on scene. Deputy GAREY did advise that two people, who were not identified by her, saw two male blacks running through the Mobile Gas station, 5501 N Lovers Lane Rd, Milwaukee, WI 53225, northeast. Deputy GAREY advised that the two individuals could not tell her where they were coming from and were fairly intoxicated. After looking at the vehicle, I did verbally confirm to Deputy GAREY that this was the vehicle I was in a pursuit with earlier within the village limits of Butler.

I did a records check on the vehicle. I ran the displayed rear registration, 793-YZP, and discovered that it came back no vehicle associated with a status of expired. I then did a records check on the VIN, 1G2ZF55B864260634. I learned the VIN came back to a gold 2006 Pontiac G6 with no plate associated with it and no wants. The owner of the vehicle was a William R. BELL (M/W DOB: 09/19/1997).

At this time, Chief David WENTLANDT arrived on scene. As I stood near the vehicle approximately 7-10 feet away from it smelled a strong odor of burnt marijuana emitting from inside the vehicle. I then looked over the vehicle and I observed skin pieces imbedded in some of the cracks in the windshield, some blood on the inside of the front passenger side door that was dry and a white/light tan purse on the floor in front of the front passenger side seat. I also heard a cell phone, which was an iPhone, that kept ringing. The cell phone was attached via a car mount to the center of the front dash directly above the radio.

I then photographed the vehicle and attached photos to this report. The vehicle was then turned over to PO BAKER and PO WHITERS of the City of Milwaukee Police Department. As they looked the vehicle over they discovered a Wisconsin photo ID card that belonged to a Jaylen T. ALLEN (M/B DOB: 12/01/2000). I did a records check on ALLEN and I learned he had no license issued and no wants.

PO WHITERS turned the WI ID over to me along with the black iPhone. PO BAKER located the vehicle's title inside of it, which indicated that BELL had sold the vehicle on 02/26/2018 to an unnamed person that did fill out the vehicle title. I later property inventoried the above items at the police department; except the vehicle title which remained in PO BAKER'S possession.

The City of Milwaukee Police Department advised that they would be investigating the felony hit and run to a pedestrian causing great bodily harm and the single vehicle crash on the northbound on ramp to HWY 41 from W. Silver Spring Dr. 1 then returned to the police department.

At the police department, I property inventoried the Wisconsin TD card (item #1) and the black iPhone (item #2) under PI #4121 and secured the property in locker #10. I attached that property inventory sheet to this report.

I then requested dispatch e-mail the audio recording of my pursuit to my e-mail. I later forwarded that e-mail to Chief WENTLANDT, so he could burn it to a DVD.

The pursuit distance was .09 miles from N. Lilly Rd. to just west of N. 124th St. and reached a maximum speed of 92mph. I filled out the Tracs pursuit form and attached it to this report. There was no body camera footage of the pursuit and the squad camera was not working properly, which supervisors were aware of days prior to the pursuit.

This case is still active.

SUPPLEMENT REPORT:

On Sunday, June 10th, 2018, at 8:15pm, I, PO KNAPP, while in full police uniform and in marked Butler squad #723, working from 8p to 8a, did follow up this case T18-002449.

At 8:20pm, I used the database Clear to look up ALLEN or his listed address of 4678 N. 49th St. in Milwaukee, WI 53218, to locate any phone numbers. When I searched ALLEN'S name there was nothing found for him. I then searched the address and there were several people found that lived at that address. The only name that was associated with that address that had a phone number was Tina R. ALLEN (F/B DOB: 04/04/1975). (For this report I will use TINA'S first name.) The listed phone number for TINA was 414-899-3158.

At 8:35pm, I called TINA at that above phone number. I asked if she knew a Jaylen ALLEN and she said, "Yes, he is my friend." I asked if he lived there and she said, "Yes, but he is not here now." I asked if he would be returning home soon and she was unsure. I asked if she had a phone number for ALLEN and she gave me the following phone number 414-841-9874 (Cell). I later called that phone number and it went straight to voicemail. TINA said she would tell ALLEN that I was looking to speak with him and I provided her with our dispatch phone number 262-446-5070.

At 11:45pm, I called PO BAKER at district #4. PO BAKER had not had a chance to do any follow up to the case yet. He did state he completed the accident report and primary report (18-1610039) and that the accident report number was in that report. He further stated that he was informed by Detective Rice that GRAFF was interviewed by him earlier this morning. He further said that he was advised that GRAFF had a broken left leg and left arm. He said he would be attempting a knock and talk at ALLEN'S house if he had time depending a calls for service tonight. He had no further information to report at this time and stated he would inform me of any updates.

This case is still active.

SUPPLEMENT REPORT:

On Monday, June 11th, 2018, at 8:30pm, I, PO KNAPP, while full police uniform and marked Butler squad #723, working from 8pm to 6a, did follow up to this case.

At 8:44pm, PO HERPIN (T204) and I went to 4678 N. 49th in Milwaukee, WI 53218. Upon our arrival, I knocked on the front door and TINA answered the door.

TINA invited officers into the front porch area of her house. I asked if ALLEN was home and she said no. She said she has not seen him since Saturday, June 9th, 2018. TINA did state the she has been trying to contact ALLEN via his cell phone, however it goes straight to voicemail. I asked what time she last saw him and she said it was late Saturday night, but could not remember a time. I asked if it was possible if ALLEN may of left later that night with some friends and she said it is possible, but she did not know. I gave TINA a brief summary of why I was at her house and why I wanted to speak with ALLEN. I advised TINA that ALLEN is not under arrest or wanted for a crime at this time, however that he is a person of interest in an ongoing investigation through our department and the City of Milwaukee Police Department. I asked TINA if she knew what type of clothing ALLEN was wearing Saturday night and she said she could not remember. I asked if ALLEN had access to a vehicle and she said he does not have a driver's license. She further said that ALLEN has been wanting a vehicle, but she said she would not help him buy one because he does not have driver's license. She did state he was trying to buy a smaller type vehicle, but did not know the year, make, model or color of it. I advised TINA that I wanted to speak with ALLEN and she said she would attempt to locate him for me and then call our dispatch center if she did to notify me. I provided her with my business card. PO HERPIN and I returned to the police department.

At approximately 9:30pm, I learned from PO HERPIN that PO RATZLAFF did follow up on my case (T18-002449) earlier on today's date. PO HERPIN informed that PO RATZLAFF went to the Mobil Gas Station, 5501 N Lovers Lane Rd, Milwaukee, WI 53225, to check and see if there was any CCTV surveillance footage relevant to the information provided to Deputy GAREY by the two unidentified witness that observed two people running northeast through the parking lot of the gas station. PO RATZLAFF was able to obtain surveillance footage and I later reviewed it after Lt. ENGLEMAN retrieved the DVD from Chief WENTLANDT'S desk in his office.

At 9:50pm, I reviewed the CCTV footage on my desktop computer at the police department. At 2:31:47am on 06/10/18 (date and time stamped per their system), on the "front building" camera, I observed a male black thin build approximately 5'9" to 5' 11" weight approximately 170 lbs with short black wearing a black t-shirt and black shorts with a white design on the left side, possibly wearing red/orange tennis shoes, running from the southwest corner of the Mobil Gas Station property to the northeast towards N. Lovers Lane Rd.

I then reviewed the "West Building" camera. At 2:31:48am on 06/10/18 (date and time stamped per their system), I observed a black individual wearing a yellow

head scarf or hat and blue jean jacket, running from southwest to northeast on the rear side of the gas station. End of CCTV review.

I then took a screen shot of the male subject seen on the CCTV footage and printed it out. I attached that screen shot to this report.

I then called TINA. I asked if she would be able to identify ALLEN in a photo and she said probably. I asked if she could come to the Butler Police Department tonight or tomorrow and she said probably Tuesday, June 12th, 2018, after 8pm. End of conversation.

I then called Dallas E. KVIEN (M/W DOB: 02/12/1998). I asked if he ever owned a gold 2006 Pontiac G6 and he said, "No." I then asked if he ever owned a vehicle with a plate of 793-YZP and he said, "Yeah probably I owned five vehicles at one time, however sold them all." Then said he never removed the plates from the vehicles when he sold them, however did removed the vehicle information from the plates with the DMV. KVIEN then stated he had just received a parking citation from the City of Milwaukee. KVIEN said the parking citation was issued on Thursday, April 26th, 2018, at 1:54pm. He further said the plate number on the citation was 793-YZP and the address listed for the violation location was 6206 W. Bobolink Ave. in Milwaukee, WI 53218. KVIEN had no more information at this time.

At 10:35pm, I called the City of Milwaukee Police Department District #4. I spoke to PO MUSTAF. I asked if there was any way to run the WI plate of 793-YZP to see where and how many times that vehicle plate was cited for parking violations and she said, "Yes." PO MUSTAF then confirmed the information KVIEN provided to me regarding the citation he was mailed. PO MUSTAF then provided me with a second parking citation that was issued on Wednesday, April 18th, 2018, at 4:20am, at 4825 N. 46th St. to a plate of 793-YZP.

SUPPLEMENT REPORT:

On Tuesday, June 12th, 2018, at 8:30pm, I, PO KNAPP, while full police uniform and marked Butler squad #723, working from 8pm to 6a, did follow up to this case.

I had received a DVD in my mailbox labeled "Pursuit T18-002449." I property inventoried the DVD under PI #4122 and secured the DVD in locker #10 for safe keeping. I attached that property inventory sheet to this report.

At 8:40pm, I called TINA. She advised that she has been in contact with ALLEN on today's date two different times. She then said ALLEN would be contacting her again for the third time at around 10:00pm to let her know where he is, so she could pick him up and bring him here to the police department. I asked TINA for the number that ALLEN was using to call her and she said the number appeared on her cell phone as restricted. She further told me that she does not know where he is at or is staying as of now. I told TINA to call me back if she is

unable to come to the police department tonight. End of conversation.

At 10:13pm Tina arrived at the Village of Butler Police Department with ALLEN. I escorted them into the police department lobby. I told TINA I wanted to talk to ALLEN alone in the interview and she was okay with that. I advised ALLEN in the lobby that he was free to go and was not under arrest.

It should be noted that I observed ALLEN to have the same physical descriptors as his WI ID Card indicates and from the screen shot I obtained from the Mobil Gas Station CCTV footage. I further observed ALLEN to be wearing similar, if not the same shoes the individual was wearing on the CCTV footage.

I escorted ALLEN to interview room #1, which is audio and visually recorded. Once in the interview room I had ALLEN sit in the chair closet to the door and I left the door fully open during the entire interview.

I then told ALLEN two more times that he was free to go at any time and was not under arrest. He acknowledged my statement and agreed to the interview. At this time I activated my body camera as well.

I started the interview out by ALLEN verbally identifying himself as Jaylen T. ALLEN (M/B DOB:12/01/2000) and he gave me a phone of 414-841-9834 (cell phone). I asked him if he had that phone on his person and he said, "No sir." I then asked where is the cell phone and he said, "I don't know." I then asked if it was his cell phone and he said, "Yes." (nodded his head). I then asked if he knew why he was at the police department and he shook his head side to side to indicate "No." I asked where he was at on Sunday, June 10th, 2018, at approximately 2:00am and he shook his head and shrugged his arms and shoulders as to indicate "I don't know." I asked if he owned a car and he said nothing and leaned forward and folded his arms on the table and buried his head into his arms for approximately 30 seconds. He then sat back up and said, "I don't know what your talking about. Am I under arrest?" I told him he is not under arrest. I asked if he had an ID and he said, "Yes." I asked where that ID was and he said, "I don't know." He also did not know where his cell phone was. I then asked him if there is any reason why he would be on surveillance footage at a Mobil Gas Station with the red shoes he was currently wearing and he said, "No." I then showed him a picture of his WI ID card and asked how do you think I got that and he said, "You tell me." I then asked if he was in a relationship and he said, "I don't know." I then said I know the car you were probably driving has several parking tickets and the plates did not match, at which time he got very defensive and animated by pointing his right hand at the papers on the table and towards me. He then said, "How do you know I was driving?" He then almost slipped and said that is not my vehicle. (In reference to the vehicle I was pursuing.) He asked me again if he was under arrest and I said, "No." I then showed him a picture of the individual that was seen running through the Mobile Gas Station parking lot and asked if it was him and he said, "I don't know." It should be noted that he was wearing the same shoes in the photo as he was currently wearing in the interview room. I asked if drives a car and he shook his head side to side to indicate "No." He then said, "I Uber (something along those lines) if l'm not under arrest I'm going to leave." I replied by saying, "Okay." He then said, "I don't know anything bro." I asked if he owned a car and he got very animated again with his arms and raised his voice and said, "I don't know what your talking about. I don't know." I then asked if he could explain to me why he may

be on another camera in the area? He shrugged his shoulders and shook his head side to side to indicate "No." I asked how his cell phone and WI ID got into an abandoned vehicle and he could not tell me. At 10:51pm, ALLEN said, "Hey so I'm not under arrest?" I replied, "No you're not under arrest." He then said, "All right bro whenever you need to talk to me you can call my mom." He then walked out of the interview room and into the lobby. It should be noted as he exited interview room he had a smile on his face and chuckled towards me. End of interview.

I spoke to TINA in the lobby as she requested I do prior to the interview starting. I informed her ALLEN was still not under arrest. I did tell her I believe he knows more then he saying. TINA said I'll see if I can get him to talk more. TINA then left the lobby shortly after we talked.

At 11:24pm, I was informed by dispatch that a person named "J" wanted to speak to me by phone. I called the phone number back 414-394-8343. J was ALLEN. ALLEN asked what kind of trouble he would be in if he came into the police department to speak again. I said it all depends on you and all I want to talk to you about is the pursuit part as to why you did not pull over. 1 told him I would give him another chance to speak to me freely about the incident and he would not be under arrest and free to go. He then asked about the City of Milwaukee Police Department's investigation and I said I can not speak on their behalf. ALLEN then told me to hang on, which I did for about 2 minutes. While I was waiting for him to come back on the phone line I heard ALLEN say, "This is why I'm in this mess." He then came back on the phone and stated he would come back to the police department to speak between now and Wednesday, June 13, 2018, at 6:00am. He asked or stated I cannot remember the exact quote "You were the officer behind me?" I said, "Yes." I asked if I could pick him up from wherever he was and he said, "No." I told him if he wants, I would be at the police department all night if he was willing to come back and speak. Once again I told him he would be free to go and he would not be under arrest. I asked where he was and he said, "At friends house." He would not give me an address. He further said he was not with TINA anymore. He then told me again he would come and speak with me if he could get to the police department. He then hung up the phone. End of conversation.

I called the City of Milwaukee Police Department #4 and updated them on the case. They advised if ALLEN is arrested to call district #4.

This case is still active.

SUPPLEMENT REPORT:

On Wednesday, June 27th, 2018, at 1:37am, I, PO KNAPP, while in full police uniform and in marked Butler squad #723, working from 8p to 6a, was stationary in the median break on westbound W. Silver Spring Dr. at N. 131st St. observing traffic.

I observed a white 2006 Nissan Sentra, bearing WI registration, ABG-9992, traveling eastbound on W. Silver Spring Dr. from just west of N. 131st St. at an estimated speed of 60mph. I turned on the stationary radar. I locked in the above vehicle's speed at 57mph in 45mph zone. The radar's audio was clear and not obstructed. The vehicle further maintained the 57mph speed for 3-5 seconds before it was locked in.

I pulled from my position and caught up to the vehicle at eastbound W. silver

Spring Dr. and N. 124th St. I activated my squad's emergency lights and conducted a traffic stop. I approached the vehicle on the driver's side and made contact with the driver verbally identified as Alethea T. ALLEN (F/B DOB: 02/18/1998). (For the purpose of this report I will use Alethea, not her last name.)

I had her roll down the rear driver's side window so I could see inside the vehicle for safety reasons. The windows were heavily tinted black. I observed there was a male black in the back seat on the driver's side not wearing a seat belt and he appeared to be sleeping with his head back and eyes closed. ALETHEA said she did not think she was speeding. She had no identification on her person or anything with her name on it, however she advised she was the owner of the vehicle. There was a male black in the front passenger seat, who did not identify himself.

I turned my attention the male black in the back seat, who I recognized as Jaylen Traymon ALLEN (M/B DOB: 12/01/2000). ALLEN was wearing a green t-shirt with blue jeans and red Nike shoes. I asked ALLEN what his name was and he said Traymon. I knew the subject's name was Jaylen T. ALLEN and not the name he gave to me based on prior interactions and investigations. I returned to my squad.

I requested the City of Milwaukee Police Department send a squad to my location. I knew ALLEN was a person of interest in an ongoing investigation and that the Milwaukee Police Department flagged his name in their system as someone that needed to be interviewed.

PO RAY from the City of Milwaukee Police Department arrived on scene. We approached the vehicle and asked ALLEN to exit the vehicle. He complied. PO RAY placed handcuffs on ALLEN and informed he was being detained. PO RAY then escorted ALLEN to his squad and secured him the back seat. PO RAY had no further questions for me and transported ALLEN to one of the sub stations.

ALETHEA was released from the traffic stop with two citations and advised not to drive.

This case is still ongoing.

P.O. Knapp,

Good Morning. Sorry I didn't respond sooner I was on vacation and just got back a few days ago. As you are probably aware Jaylen ALLEN was taken into custody on 06-27-18. I interviewed ALLEN who refused to make a statement regarding this

incident. He had a very guilty demeanor with me as well, but continued to avoid any questions regarding this incident. He did consent to a buccal swab DNA sample which I collected and will be submitting it to the crime lab. From our end until DNA results come back we have no PC for arrest. If anything changes I will let you know, and let me know if you guys have any updates. He was PR on his warrants with us and released. Hopefully the DNA will come back sooner rather than later. Thanks.
