My name is Norma Saldana and I reside @ 3362 S. 26th Street...Milwaukee, and I would like to appeal this motion of her being put down, she is not a harm to anyone or an aggressive dog... An incident that happen on 8/16/2018 with my dog (chucha) in or about 430pm...or 445pm.....I was just arriving from work to see that I had about 6 people starring at me.....I had asked the neighbors across the street what happened and she told me that my dog (chucha) had gotten out of the gate and bit another dog. I went up to the other neighbor on the side of my house and she told me that chucha bit a dog and it was taken to the vet, and also showed me some pictures she had and told me that they had called the police.

Even though at that point I did not know nothing about the other dog, the police came and did not mention anything about the other dog nor the incident, all he told me that if I knew why he was there and that I need to get a higher fence but that he was not going to fine me nor take my dog...

Then on 8/20 I receive a call 4 days later from the City of Milwaukee stating that they receive a complaint that my dog bit another dog and killed it and this point I still did not know what really happened to the other dog, but when she (City of Milwaukee person) started to tell me about my dog she had the wrong one, I have 2 dogs pitbulls....then she asked how did I know and I told her that the neighbor had told me what happened and had pictures....so I had told her that it was chucha the 11yr old dog. She then told me that she would get back to me cause she was going to talk to her supervisor to see what needs to be done...... After that I did not receive any calls, I received a letter on 8/24 dated 8/21 stating that I need to fix the violations get her licensed and go to a class.....then on 8/25 I receive another letter dated 8/21 that I needed to either microchip my dog and take her out of Milwaukee county or to put her down.

I have her since she was 5weeks old and now she is 11 years old... I have lived at a property where there was no fence and it was an open area, she has been around other dogs......kids...and people and nothing like this has ever happened..... and the neighbor upstairs had a small dog that she (chucha) did not even try to attack. Now I have a granddaughter that is 1year and 2 months and chucha does not do nor goes around her and she is crawling around...CHUCHA IS NOT AN AGGRESSIVE DOG...yes I had another dog that nipped not bit a dog that died but because that dog had a disease what kind I don't know....that dogs body went into shock and died yes I paid for that dog that died and ended up putting my dog down cause he changed with us......Chucha has not changed with us and has not reacted different from this incident...

Yes I am the home owner and it's my responsibility to look and check around the house, but because we DO NOT USE THAT GATE TO ENTER AND LEAVE, it did not cross my mind to even check it, I have been there at that house for about 9yrs now and never have we used that gate for nothing unless the grass or bushes are being cut.

My dog (CHUCHA) is not a harm to anyone and she is not an aggressive dog..she is family and yes she is a pitbull that everyone thinks that they are dangeres....and no they are not and it all depends on how you raise your dog weather it's a pitbull or a chihuahua.

I will like to take the time to envite someone from your office to come and see my dog and eval her if needed to just to see what kind of dog I have and deal with. I am not trying to justify what she did was right but she is a good dog and not aggressive. What happened that day and why she did what she did I don't know.....she did not attack a human or bit a human...

I am willing to go through any classes and licensing for her or what ever is need for me to keep my dog....

I went to the address of 3362 S. 26 th St. and received no answer at the door, but did notice that he fence gate, which faces the sidewalk, was knocked down and laying on the ground. On Sun. 4-13-14 I went back to that address and spoke with Norma and Gustavo SALDANA. SALDANA informed me that their 7 month old male Pit Bull mix "Mayo" was involved in the attack of Bubba. They stated that Mayo is about 70 lbs and is not licensed. They believed they got him in the summer of 2013. At that time I noticed that the fence gate had been fixed.
