



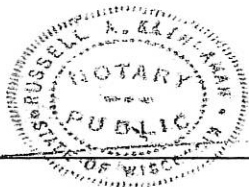

Owczarski, City Clerk of the City of Milwaukee, certify that pursuant to Section 4-06-3 of the Milwaukee City Charter, notice is given of the passage of the following ordinances by the Common Council of the City of Milwaukee on 10/16/2018, with the approval of Mayor Tom Barrett, except for 180813, which was passed on 9/25/18, vetoed by the mayor on 10/4/2018, and then passed notwithstanding the Mayor's veto on 10/16/2018. The full text of each of the ordinances listed below can be obtained at the Office of the City Clerk, Room 205, City Hall, 200 E. Wells Street, Milwaukee, Wisconsin, 53202.

180262 A substitute ordinance relating to restricted building wall materials in various zoning districts.

180571 A substitute ordinance establishing a pedestrian mall to be known as the "Westlawn Pedestrian Mall" in certain outlots in the subdivision known as Westlawn West, in a portion of Lot 1 of CSM 8895, in the eastern 14 feet of the vacated public service drive north of Lot 1 of CSM 8895, and in certain right-of-way areas in the subdivision known as Westlawn East, in the 2nd Aldermanic District.

180678 A substitute charter ordinance relating to city public debt.

180813 A substitute ordinance establishing a Milwaukee Inspector General within the Common Council-City Clerk's Office.

180856 A substitute ordinance relating to parking controls.

180857 A substitute ordinance relating to traffic controls.

180869 A substitute ordinance relating to surveys of water supply cross-connections.
