# **Background**

Preston Cole, Commissioner – Building Inspection wishes to create a new Fire Protection Section within the department and move six current positions in the department into this new section as follows:

- (1) Plumbing Inspection Supervisor
- (1) Fire Protection Engineer III
- (4) Sprinkler Construction Inspectors
- (1) Office Assistant III

In addition, the department has requested a title change for the position of Plumbing Inspection Supervisor that will lead this new section. The department indicated that with the increase in the volume of construction there is a large backlog of fire plan reviews. They wish to have this new Fire Protection Section be dedicated to these functions to address the current backlog and help prevent backlogs in the future. In studying this request, job descriptions were analyzed and discussions were held with Richard Paur, Building Construction Inspection Division Manager, and La'Neka Horton, DNS Personnel Officer.

## **Title Change Request**

This position will develop, plan, and coordinate all inspection and plan review services. Its duties and responsibilities are to:

- 25% Coordinate and supervise the plan reviews performed by the Fire Protection Engineer.
- 20% Coordinate and supervise inspectional services for the Fire Protection Section which include fire sprinkler systems, suppression systems, and standpipe systems.
- 15% Perform staff evaluations and performance reviews.
  - Evaluate and adjust inspector and district workload as necessary.
  - Monitor the workload of the Fire Protection Engineer and provide assistance to lessen excessive backlogs.
- 10% Meet with staff to review plans and projects to provide code interpretation and direction.
- 5% Review permits, records, and other section documents and ensure they are complete, accurate, and compliant with DNS policy in a timely manner.
- 5% Identify improvements and changes needed in ordinances, policies, and code provisions and draft suggested changes for review.
- 5% Provide in-person and telephone assistance to customers.

- 5% Represent DNS at governmental forums, community meetings, the Board of Standards and Appeals, and Municipal Court as necessary.
- 5% Conduct fire protection plan reviews during peak times.
- 5% Perform other job-related tasks as assigned.

Minimum requirements include a bachelor's degree or higher in fire protection engineering or a closely related field; and three to five years' experience in the field of fire protection systems or similar area. Equivalent combinations of education and experience may be considered. These requirements have not yet been assessed by the Staffing Division for purposes of recruitment.

This position, much like the Plumbing Inspection Supervisor and Electrical Inspection Supervisor, will oversee a section within the Department of Neighborhood Services. All three positions have a similar level of duties and responsibilities. They all supervise a group of employees, coordinate inspectional services, represent the department for matters pertaining to their given section, and identify changes needed to ordinances or procedures. As this position will oversee the new Fire Protection Section including the review of fire plans we agree with a new title and recommend Fire Protection Engineer Supervisor in Pay Range 1GX (\$66,435 - \$93,010).

#### Recommendation

We therefore recommend that a new Fire Protection Section be created as follows and that one position of Plumbing Inspection Supervisor in Pay Range 1GX (\$66,435 - \$93,010) be reclassified to Fire Protection Engineer Supervisor in Pay Range 1GX (\$66,435 - \$93,010). We further recommend that this position continue to have recruitment at any point in the range with the approval of DER and the Chair of Finance & Personnel.
