This is to notify you that on Wednesday, November 14, 2018, the City's Licenses Committee voted to recommend to the City's Common Council nonrenewal of your Class D Operator's license based on your second nonappearance.

On November 16, 2018 you were mailed a true and correct copy of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the renewal application for a Class D Operator's license in which the Committee recommended that the license not be renewed based on your second nonappearance. Following consideration of the report of the Licenses Committee, the Common Council voted to nonrenew your Class D Operator's license based on your second nonappearance.
