WHEREAS,

Celebrated Native American Heritage Month during a special ceremony at Milwaukee's Historic City Hall on November 20, 2018; and

WHEREAS, The Milwaukee Area has long been a cross-roads for American Indian peoples and has a large, active American Indian population for which Native American organizations, tribal foundations, and corporations, and tribal elder and youth groups are contributors to the health and wellbeing of American Indian community; and

WHEREAS, The Indian Council of the Elderly, Inc. (ICE), the Elder's and Youth Programs of the Gerald L. Ignace Indian Health Center (GLIIHC), Indian Community School of Milwaukee, Inc. WHEREAS, The health and mental health systems in the Greater Milwaukee area must continue to collaborate health/mental providers, public policy makers and information technology to improve care and information dissemination among the diverse cultural groups within the community that serve Elders; and

WHEREAS, The continued support and improvement of services for our Elders and Youth depends on outreach to community, public and private partnerships to develop policies which reduce barriers to accessing education, social services, and mental health services and health-care; now, therefore, be it
