I received my only Violation Notification of Tall Grass and Weeds 7"+, dated August 15, 2018. The notice stated that I had 5 days from the date of the notice to correct the condition, and if it was not corrected, a \$50 fee would be incurred for the 1st violation.

I have 2 properties (3433 N 15<sup>th</sup> Street and 3138 N 16<sup>th</sup> Street), both who have a regular lawn service maintaining each of them. For the inspection date on this August 15, 2018 violation, my lawn service was servicing my N 16<sup>th</sup> Street property when the inspector made the claim to fine me at my N 15<sup>th</sup> Street location. Even with this being said, \$50 should have been the most that I would be fined, not \$493.52.

I have video of residents next door and across from my N15th Street residence that I videoed to show that their lawns were higher if not worse than mine, yet they were not fined. I'm not sure how to provide you with this footage but please advise and I can provide it.

With all being said, I am asking that the \$493.52 fine be dismissed, or at the last reduced to the minimum fine of \$50.

# Your property has been found to be in violation of tall grass and weeds 7" or more in height (Sec. 80.17). You have 5 days of the date of this letter to correct this condition.

(Sec. 80.17.6) Charges and Costs: a. Any person who fails to cut turf grasses or weeds as required shall be subject to a special charge of \$50 for a first violation in a calendar year, if the violation is not abated... b. The amount of the special charge for any second and each subsequent violation in the same calendar year shall increase by \$50 from the amount of the special charge imposed for the previous violation, not to exceed \$300 for 6 or more violations in the same calendar year. c. There shall be an additional special charge of \$100 for failure to mow or otherwise abate any condition that remains in violation of this section. Upon a subsequent failure to comply with this section in the same calendar year, the person shall be subject to a special charge of \$150. d. Any costs incurred by the city in abatement or remediation shall constitute additional special charges. Costs of correction and special charges will be billed to the property owner and if not paid become a lien on the subject property...
