Summary of Documentation Submitted by ABYSS Towing

ABYSS Towing submitted a total of 58 records to the City of Milwaukee. These records consisted of various Tow Reference Numbers included in their private property invoice from the City of Milwaukee between 01/01/18 - 09/30/18 as well as paper documentation maintained for individual tows by the towing contractor. Out of the 58 records submitted by ABYSS Towing, Parking Services was only able to research 46 of the submitted records; since 12 of the records received tow authorization from a department or municipality other than the City of Milwaukee.

For each record submitted, the official tow record was reviewed for correspondence between the towing contractor and Parking Services and is included in the spreadsheet below. In addition, any associated paperwork provided by the towing contractor for each individual tow has been included to compare/contrast with the official notes in the record. It must be noted, every record will contain correspondence with the tow contractor because they are required to provide information to get authorization to tow a vehicle off of Private Property. Of the 46 records, 3 records have documented communication outside of the initial tow request.
