Dear Sir or Madam;

This is regarding an incident that happened on January 3rd, 2009. I was driving my vehicle northbound on 70th Street, when my front right tire hit a huge pothole, just before the stoplights at the ramp to I-94. There was oncoming traffic coming southbound and other cars in the lane next to me, so I had nowhere to go to avoid the pothole. The pothole was so large that it immediately punctured my tire and damaged the wheel rim itself. The repair was very costly and required a new tire and wheel rim.

The city was undoubtedly on notice that this particular pothole existed, and I imagine that there were others who had trouble with it as well. Since it was a weekend, I called the non-emergency line to the West Allis Police Department to report the incident. An officer directed me to contact City Hall on the next business day, and the Clerk's Office suggested that I write this letter to request reimbursement. The next week, the pothole was filled in. I am glad that no one else will have costly repairs to their car because of lax street maintenance.

I was then told in an official letter from the City Attorney of West Allis that the area was in the City of Milwaukee's jurisdiction.

I am attaching pictures of the aforementioned tire and wheel rim as well as the bill from the repair shop detailing the amount of repair incurred by the damage from the pothole. Citizens should be able to travel the streets safely without having to worry if hundreds of dollars of damage will be inflicted upon them by unsafe road conditions.

I request that the City of Milwaukee reimburse me for the damages incurred by the pothole. The total damages are \$638.88.
