If you feel you are unable to appear in person due to hardship you may make a written request, via [lelmer@milwaukee.gov](mailto:lelmer@milwaukee.gov) or through the mail, to appear via teleconference. This request must be submitted no later than 5 business days before the date of the scheduled hearing. This request will be approved or denied by the chair at his or her sole discretion based upon travel distance and disability. The request should also include a phone number you can be reached at during the time of your scheduled hearing.
