We are proposing (2) Two building signs.

- . One single faced wall sign which is to be hung in front of the pre approved glass sign band. Copy that reads "MAC SHACK" to be 3" deep x 20 9/16" high, face lit channel letters. Copy that reads "WOOD OVEN MAC & CHEESE" to be non-illuminated, .125 thick x 3" high, brushed aluminum, flat cut out letters. The sign is encompassed with a 3" deep x 1 1/2" wide illuminated border. The border and the SHACK copy have a perforated film on White Acrylic backed faces that is Dark Grey during the day and White when illuminated at night. \*See Projected Night View. The entire sign is on a .125 Grey Aluminum panel to facilitate the HPC's request that we mount the sign within the glass sign band.
- . One double faced Flag sign which will be installed on the West elevation. This sign to have Aluminum routed faces with Exterior, Gooseneck downlighting. The entire sign face to be opaque with the background White and the copy the same colors as the front elevation sign.
