We are not agreed with your decision to pay us \$770 and would like to get from City of Milwaukee a money for all expenses, which followed car accident on Nov 19, 2018.

Prior to this accident the car, even being 10 years old, was at excellent condition.

Gene Deroune (City official), who came to the place of accident, did not give any information on the particular price range for renting a car. Apposite, seeing my disappointments of what happened to the car, he said that City will pay all expenses related to accident. Not knowing about your price range, we rented the car from cheapest place (Enterprise).

Damage to the car was so extensive that it took for Dealership 9 days to fix it.

We look forward for your decision to return us \$1,728.92, which includes: \$500 for deductible, \$739.38 for renting a car and \$489.8 for the part, which was in working condition 2 days prior to accident during all 4 tires change and car alignment.

In conclusion, we are looking for reimbursement from City of \$500 for deductible, \$739.38 for renting a car and \$489.38 for the part, which comes to \$1,728.92.

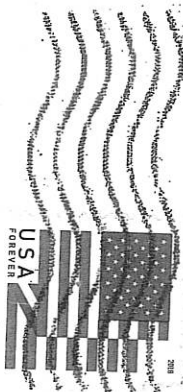

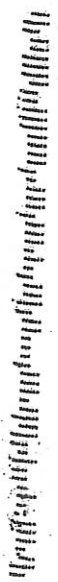
