This report is written by PO Chelsea MILLER, assigned to District Three, day shift. On Tuesday, 7/24/2018 at approximately 11:11AM squad 3120 PO Gregory BYERS and myself were dispatched to a Theft call for service at 7025 W. Main St. a Walmart Market in the city and county of Milwaukee.

Upon arrival I spoke with Larry K SANDERS (b/m, 08/19/1986) who stated his wife's phone was taken from a basket while at the location while she was shopping.

PO BYERS and I spoke to the Assistant Manager of the Walmart Market Matt DOBSON who allowed us to view the video surveillance of the incident. In the video it is shown that Tiffany SANDERS leaves her Samsung Galaxy S7 in a green handheld basket at approximately 9:12AM in the basket collection point.

At approximately 9:16AM a black female, heavier set, with dark hair tied up in a bun, wearing a dark colored shirt with an open gray jacket and pink pants with dark colored shoes. The unknown female picks up the abandoned basket with the phone in it.

Larry SANDERS used Google locator services to ping the phone's location. The phone then pinged to the area of 6852 W. Greenfield Ave. PO BYERS and I changed locations to that address and located the female that was in the video from the Walmart market.

PO BYERS and I spoke to Jodi L BERKHALTER (b/f, 02/18/1987) of 2403 W. Lloyd ST. (262)-397-6960 who matched the description of the female from the video. BERKHALTER stated she did not have any phone, she brought PO BYERS and I out to her car to show she did not have it. When walking back to the store

PO BYERS and I returned the phone to Larry SANDERS. It was determined there was no criminal event that took place, due to the phone being abandoned or left in the basket at the Walmart market and BERKHALTER found it.

- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
