This is a non-sworn law enforcement position (civilian). Under direction of the Fusion Division's Captain, the Crime & Intelligence Manager is responsible for the supervision of a staff of tactical Crime Analysts who perform short and long term analysis of crimes trends, crime patterns and crime series as well as collection and interpretation of data and criminal intelligence using quantitative and qualitative methods. The supervisor will oversee from inception through completion and dissemination, the retrieval and analysis of various crime, call for service, arrest and other data requests generated throughout the Department. The Crime & Intelligence Manager is responsible for providing analytic support to on-going investigations and assisting in the production of analytic products for presentation in law enforcement and community based forums. The Crime & Intelligence Manager will compile accurate and unbiased information for use in various internal and external forums. The job duties of this position have a direct impact on the Geographic Commands, Investigations and on outside agencies at the local, State, and Federal levels.
