We have received your claim in the amount of \$2,812.30, relating to damage allegedly sustained to your vehicle on June 19, 2009 at approximately 1:00 a.m. when it became submerged in water while you were traveling eastbound on Capitol Drive at 35th Street.

Our investigation reveals that the Infrastructure Services Division (ISD) records indicate that because of the large amount and strong intensity of the rain during this time, the City experienced flows that exceeded the capacity of the sewer system. On June 19,2009 at 12,5 a fine the ISD received a call of clogged catch basins on West Capitol Drive from North 32 to North 35th Streets. They dispatched a Sewer Jet and it opened six basins in the area and found them to be in proper working order. The City was not negligent in this matter. As such, the City would not be liable. Therefore, we are denying your claim.
