# Present new language to President Hamilton for an amended resolution...

Dana Zelanzy will work on drafting a resolution to share with President Hamilton the committee to review. This resolution will include that this committee's work will outlive the ongoing the ALCU's five year agreement, list committee members must include representatives from different organizations to include ethnically diverse communities, person with disabilities, LGBTQ, and a seat for a plaintiff. Other organizations will appoint representatives from AFSCME, African American Roundtable, Southside Organizing Center and NAACP. The committee will confirm if any other organizations following; Voces de la Frontera (Tammy), Running Rebels (Cacy), LGBTQ Center(Cacy), Independence First (Jamaal) Dominican Center (Markasa), and Metcalfe Community Bridges Association (Markasa). The committee would also like to protect the content of the ACLU language and new activities of the current Collaborative Community Committee.

Deadline for committee members to confirm organizations commitments to our proposal of having organizations commit a representative to the ongoing committee is March 21<sup>st</sup>.

Dana: The Common Council has some resources that they could possibly be earmarked for the committee's ongoing work but that depends on a Common Council vote. If the committee wants other city stakeholders to resource the ongoing work of the committee there should be a conversation sooner than later to discuss allocating resources for this committee as city departments are discussing the 2020 budget. The committee must go through the council and through the mayor with a budget request.

The committee decided we will ask the agencies that are a part of the larger committee including the Mayor's office, Fire and Police Commission, the Milwaukee Police Department, and the Common Council to put financial resources aside from their budgets to sustain this committee's ongoing work.

  - Exploration of themes and community perspectives

### 3. Data Sources

## 5. Challenges and Limitations: Dr. Decoteau Irby:

This does not have to be data in the actual community report, but for the committee's use.

Full presentation is for committee's use for determining what is useful and appropriate for inclusion in the actual community report.

<u>Research design and data collection:</u> The purpose of data gatherings was for community engagement project; not originally designed to be a research project. Insights into facilitator or note-taker training or methods were not considered. Uneven number of HUBS, finding foci, respondent methods diminished comparative analytical possibilities (e.g. 3 police hubs, online portal, etc)

<u>Secondary data sources:</u> Research team did not collect data first hand. Most substantial data source were notes from facilitators (not actual participant recordings or writings and voices; notes reflected variability in quality)

Lack of demographic data: Besides an organizational association or police department/affinity group association, the number of participants and their specific demographic information was not available. There was no way to know how many or whose voices are represented in the data sources.

The committee expressed the purpose of this work was to engage the community and researchers were brought in to assist with creating the report.

Markasa Tucker will re-share the folder with Jeff Roman from Derute to access the sign in sheets for hubs.

6. Presentation of Historical Analysis Situating Findings; Dr. Patricia Najera and Dr. Deborah Blanks, Kairo Communications

Images of the charts that showed their research mapping attached that included the following information: Police and Sheriff Leadership, Rank and File, Citizen Action, and Legal Remedy.

**Dr. Patricia Najera:** The Milwaukee Police Department's administration over the last 70 years has had systematic issues of racism and discrimination from various administration. New leadership has offered different types of community relations, but found resistance within the rank and file of the Milwaukee Police Department. More ideas about community engagement have come from the community. The divide has increased in the last 10 years.

**Dr. Deborah Blanks:** This first chart showed history of Milwaukee Police Chiefs since 1945 – The red lines indicate the police chief was not aligned with his rank and file. Green lines the police chief was aligned and connected with his rank and file. They connected with what he wanted. The second chart showed history of Milwaukee County Sheriff.

**Dr. Deborah Blanks:** Leadership and rank and file aren't on the same page. The rank and file and the police association have to buy in.

The Committee members asked that more information be added about Chief Morales and also include mapping of the roles that the Mayor, Fire and Police Commission, and Common Council (government agencies) play in all of this.

Tammy Rivera: Something that must be added to this report is that the African American Roundtable launched this work and soon after reached out to Southside Organizing Center to engage the South Side because that is missing from the report. The city came after the work of community leaders started.

# 7. Presentation of Data Findings:

**Dominique Duval-Diop:** Concerned about ensuring the data visuals represents the actual quantitative data.

Jeff Roman:

<u>Themes:</u> What people talked about most often, regardless of Department of Justice findings. E.g. participated talked about training across multiple topics.

<u>Perspectives:</u> How people talked about and responded to the Department of Justice findings, broken bout by Community voices and Police Officer voices. E.g. community members believe police should be trained on racial bias, police officers believe they should be trained in deescalation skills.
