It was very obvious that a city plow hit my Jeep when looking at the pictures that I submitted and the numerous ones the police officer took at the scene. I am requesting a hearing because there is no way I am gong to let the city get away with this. Of course a driver is not going to say they did it and did not stop. Do you think they would say oh, oh yeah I hit it but I didn't think anyone would notice so I didn't say anything.

The edge of the plow scrapped down the drivers side and snagged on the panel just in front of the door but before the front tire pushing in some of the fender. With what one of those plow trucks weigh with the salt and all it is actually unlikely that the driver would have even felt it so it makes sense that the driver would say they didn't notice hitting it. However a city plow truck did hit it and I am not dropping this.

My name is Chad Dwyer and on January 19th 2019 I was helping my father in-law with some work on a house he owns located at 4719 W Fond Du Lac Ave Milwaukee, WI.

My vehicle is a Grey 2015 Jeep Cherokee Trailhawk 4WD Vin# 1C4PJMBS9FW752738 License Plate # 21055. My vehicle was parked legally out in front of the house on the street and at about 9:15pm it was hit by a city snowplow. The plow scratched it all the way down the driver's side from behind the rear door to in front of the front door where it caught the front left fender and bent it into the front left wheel making it stuck there. Both the police officer and myself took numerous photos of the accident and you can see the fresh plow marks in the snow where the snowplow went from the curb and around my vehicle. There are no tire tracks that go up to my vehicle and there was no paint on my on my vehicle from any other vehicle and the only vehicle parts on the ground was a black piece of the trim from the front bottom of my car that was torn off. There were no parts from any other vehicle.

I discovered the that this happened after I brought stuff out to the rear hatch of my vehicle to go home. It took a few trips to get my stuff in the car and when I went to go in the driver's door to leave, I saw the driver's side was all scratched and bent in. My driver's door was really hard to open and it didn't close all the way when I went to close it.
