My name is Aaron Hoernke, resident of Wisconsin residing at the address of 1328 Waugoo Ave. Oshkosh, WI 54901. I am writing in to submit documentation for reimbursement of damages and out of pocket expenses of \$1176.70 that occurred on the night of Thursday, March 14th, 2019 after having a run-in with a family of potholes on W. Locust St.

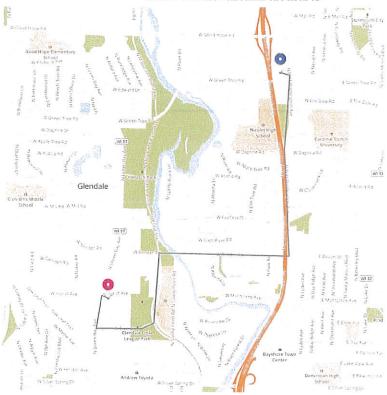
