
Staffing Vacancies





Capital Requests

There are no capital funds for the department in the 2019 Budget.

An ongoing capital project to upgrade the Court's automated tracking system and website received a total of \$888,000 in funding in 2015 and 2017. The upgrade is projected for completion in 2019.

Warrant Withdrawal Wednesdays

During these events, judges provide assistance in setting payment plans, payment extensions and alternative options to payment, while removing employment barriers like outstanding warrants and driver's license suspensions.

2 WWW were held in 2017, during which 339 individuals appeared before the court to address 2,033 cases. Approximately 67% of registrants appeared.


One WWW has been held in 2018, with another scheduled for November.

Customer Service

Convenient evening courts were offered on 12 dates in 2017, with 30 sessions scheduled for 484 defendants on 848 cases.

The Municipal Court permits individuals to walk in for unscheduled court appearances.

The Municipal Court also works to ease the burden of fines on financially-distressed individuals. Payments are waived for a first extension and additional 60-90 day extensions may be granted upon partial payments as low as \$20.



MPS Driver's Education

The 2019 Proposed Budget includes \$50,000 for the MPS Driver's Education Special Purpose Account, which will fund driver's education for 161 students. Previously, funding for this program was provided by the Common Council through a budget amendment.

During the 2017-18 school year, 1,813 students were served at 12 locations. 99% of the students passed their permit test and 91% have received their temporary permits. Each student most hold a temporary permit for 6 months prior to taking a road test and obtaining a probationary driver's license. To date, 261 students from the 2017-18 school year have received their probationary driver's license.

The classes are offered at Bradley Tech, James Madison Academic Campus, Milwaukee High School of the Arts, Milwaukee Marshall, North Division, Obama SCTE, Pulaski, Riverside, Ronald Reagan, Rufus King, South Division and Washington. MPS plans to add Bay View, Hamilton, Vincent and Milwaukee School of Languages for the 2018-19 school year.
