Let this communication serve as verification that Joseph Gauthier (DOB 5/29/68) is on active extended supervision with the State of Wisconsin, Department of Corrections, Division of Community Corrections. He was convicted of Possession of Child Pornography. He served three years in the Wisconsin State Prison System and was released on 4/9/19. In that his offense is not drug/alcohol related, there is no known nexus to the offense; his seeking a bartender's license would NOT be in violation of his Rules of his Extended Supervision. Should he engage in behavior that demonstrates performing bartending opportunities are problematic, he would then be subject to intervention by Division of Community Corrections.



It was brought to my attention that Mr. Joseph Gauthier has applied for a bartenders license from the City of Milwaukee. Mr. Gauthier is currently on an extended supervision term which is scheduled to discharge on 4/16/2024 for the offense of Possession of Child Pornography.

This letter is to inform you that such a licensure would not be in violation of his rules/conditions of supervision. If circumstances change, we will take whatever action we deem appropriate, including action which may affect such licensure. This decision was made based in part, on the following information:

- A Residence Stability: offender has maintained residence stability
- B Reporting History: offender has maintained required contacts with agent
