There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings in City Hall is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of East Kilbourn and North Water Street. Parking tickets must be validated in the first floor information booth in City Hall.



My Concerns regarding ABC Liquor Store: I have been before the council on two occasions regarding the Liquor store across the street from my home.

The first time I read my statement of concern and it was concluded that the alderman office Representative was unaware of such complaints on my part and the common council advised that Kamal (owner of ABC) and I and I talk and try to work tings out.

The second I basically re-read my statement on the opposed side against many folks that frequent ABC for the renewal of the license. On one of those occasions before the council there was one police report red.

Since the last renew of ABC Liquor License there have been various occasions of the street blocked by blinking lights from police squads.

Across the street from the store is a school and although I have been told (by a young resident last year that was adamant about not wanting to see the store closed due to" then where would he buy my groceries") there are groceries sold in the store.

The sign says Liquor Depot and children should not have the opportunity enter an establishment that is clearly for adults.

In addition to the school there is a Community Garden cared for by the school and myself and a few other residents and offered to those that want to grow produce.

But due the traffic of folks waiting to make their purchase at the ABC Liquor store they wait at the garden area and then go to the store and return to the garden leaving trash, liquor bottles mostly, there is clothing, food, cigar bagging; of which I clean up on lots of occasions even-though there is a trash can available in the garden. (Thank you Kamal).

With drinking of liguor on the lot comes loud talking and anger tones attitudes which scares the school kids and teachers from coming to attend the garden.

In front of the store there is loitering and then there is the traffic of cars of people parking on both sides of the street on N 35th to make a quick run into the liquor store.

The groups that gather in front of the store as well as the garden are of all ages.

I would like to interject that I have been doing my best to work with Kamal and he with WP. He has in the past been to our Steering committee meetings and I understand as he told me that he makes about 1.5 mil dollars off this one store of the 5 he owns in the community. And I have asked if he would not mind giving back to the community (ex; scholarship fund, setting up a entrepreneurship, some constructive for the community) and his reply was that he could only give 2% which he had already designated to other charities.

Now the traffic of folks have extended to the front of my home and the vacant property next door.

I have also received reports-e-notifications of robberies across the street on the ABC Liquor store side.

We had an agreement with the Alderman office at one point that we knew we had more than enough liquor stores in the WP area and the office would look closely at the renewal of liquor license but that is not happening or at least it has appeared to be so for the last two years.

I am sure you have many police disturbance reports, loitering reports, shots fired, robbery, regarding ABC Liquor store on N 35th street.


Just being withing 250 yards of a school should be enough.

Folks are scared to report anything, I know I should be, especially after my last appearance in front of the common council going against ABC Liquor. We would all be justified in our fears with all the traffic in and out of the store, one to two block parking on both sides of 35th (Lord help us when its the holiday) street from the time of ABC Liquor open hour to its closing hour.

I fear for the children and the teachers at the school and the community that they have not had their education on gardening come alive this year due to the traffic in front of the store and at the Bethune Community Garden (3501 W Galena). Also for the summer activities I have with our 5Day Club for kids and the rummage and the end of VBS cook out and the Garden tour and the Veteran Resource gathering, at the lot next to my house across the street from ABC Liquor store. I see that human traffiking has reupped not only at Lisbon but at our garden and around my properties.

I just don't know what more it will take other than prayer.

ROBINSON B/F 07/23/02 4321 N. MURRAY AV. MILWAUKEE, WI 53211. ROBINSON IS 16 YEARS OLD AND NOT OF LEGAL AGE TO PURCHASE TOBACCO.

AT APPROXIMATELY 1242A, ROBINSON ENTERED ABC LIQUOR III LOCATED AT 1606 N. 35TH St., AND PURCHASED A 2 PACK OF SWISHER SWEET BANANA SMASH FLAVOR CIGARS. ROBINSON DESCRIBED THE CASHIER AS: A/M WEARING A RED NBA "HAWKS" JERSEY.ROBINSON STATED HE DID NOT CHECK HER ID.

UPON ENTRANCE I IMMEDIATELY IDENTIFIED THE CASHIER BASED ON THE DESCRIPTION, WHO WAS IDENTIFIED AS: VARINDER SINGH A/M 12/31/96. 

The hearing before the Licenses Committee will take place on 7/16/2019 at 1:30 PM, in Room 301-B, Third Floor, City Hall. If you wish, you may provide testimony at the hearing regarding the request; see below for further information. You are not required to attend the hearing. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing. Please review the information below and if you have further questions regarding this process, please contact the License Division at (414) 286-2238.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
