Hupy & Abraham, S.C. alleges that on August 27, 2018 their client sustained injuries when the tire of the motorcycle operated by him became stuck in the streetcar tracks while he was traveling eastbound on St. Paul Avenue at/near North Water Street. Claimed damages total \$50.000.00.

The Infrastructure Services Division indicates that the streetcar tracks at East St. Paul Avenue and North Water Street were constructed in accordance with the standard specifications, plans, and accepted standards for streetcar infrastructure. This project was constructed and completed under a City of Milwaukee contract. The work was performed by Kiewit Infrastructure Company.

There is no evidence that the City was negligent. Therefore, we recommend that this claim be denied.
