Dear Mr. Marasco:

We have received your claim in the amount of \$839.71 relating to damage on March 21, 2019 when the Milwaukee Police Department (MPD) made forced entry to your property at 3764 South 5th Street.

The MPD indicates that officers were attempting to locate and apprehend a subject who was wanted with active warrants. This site was the subject's residence. The officers confirmed that the subject was inside. They announced themselves numerous times. Subsequently, as a female exited the front door, an officer observed the subject at the door. Another officer approached. The subject slammed the door. This officer observed the subject flee up the stairwell. Officers again announced themselves and gave the subject numerous chances to come to the door and surrender. He refused. They forced entry. The subject was arrested.

There is no evidence that the MPD was negligent in this matter. The City would not be liable. Therefore, we are denying your claim.
