The CITY hereby quit claims and conveys to Grantee, on an AS IS, WHERE IS basis, the following described facilities (the "Facilities") subject to all defects, known or unknown, discovered or to be discovered, and without any warranty or representation express or implied:

15-inch diameter combined sewer main and appurtenances located in North Prospect Avenue in that part of the Southwest one-quarter (S.W. 1/4) of Section 15, Township 7 North, Range 22 East, in the City of Milwaukee, County of Milwaukee, State of Wisconsin, more particularly described as follows:

Beginning at a combined manhole located  $10 \pm$  feet east of the easterly line of North Prospect Avenue and 33'  $\pm$  north of the southerly line of vacated East Hydraulic Avenue in said  $\frac{1}{4}$  Section, said manhole to be included in this conveyance;

Thence, southwesterly  $70 \pm$  feet along a curve to the intersection point of the 15-inch diameter combined sewer with a 30-inch diameter combined sewer, said intersection point is located at  $34 \pm$  feet east of the westerly line of North Prospect Avenue and  $4 \pm$  feet north of the southerly line of vacated East Hydraulic Avenue.
