 Re: Renewal Application of Class "B" Tavern Marcos A. Ramos-Garcia, Agent 1619 S. 1<sup>st</sup> St. – Points View Boite

Dear Members of the Milwaukee Common Council:

Werk Investments, LLC, ("Werk") through its agent, Marcos A. Ramos-Garcia, files the following objections through his attorney, Kendrick B. Yandell.

On July 19, 2019, the Licensing Committee recommended that the Class "B" Tavern and Public Entertainment Premises (PEP) Licenses of Points View Boite ("PVB") be renewed following a ten (10) day suspension. The Committee also voted to amend the capacity from 99 to 80, and to amend the plan of operation, closing the patio at 1 am, instead of 2 am.

The suspension recommendation, and decisions on capacity and patio closing, were made following a public hearing on July 16, 2019. At the hearing, police reports from July 30, 2018 and May 19, 2019 were presented. Testimony in support of the business was made by one neighbor, while Alderman Jose Perez testified as to his concerns regarding two incidents (see below).

Werk objects to the Committee's recommendation and decisions regarding capacity for the following reasons:

## 1. The suspension recommendation is a disproportionate sanction.

- a. PVB has never received a warning letter.
- b. The suspension will work an undue hardship on, and cause irreparable harm to, PVB. The suspension will coincide with Fiesta Dominicana, a family-oriented cultural community event sponsored by PVB and featuring international dance and performing artists, musicians, and local vendors. Suspension will cause PVB to lose nearly \$30,000 invested in promoting and launching the event, likely doom future "Fiestas," and potentially open Werk to legal action by disgruntled vendors and performers. This is in addition to a substantial loss of revenue for two full weekends.

- 2. The suspension recommendation does not factor in the mitigated circumstances surrounding the operations of the business, and management's proactive responses to each incident.
  - a. In response to nearly every incident, PVB has implemented preventative measures to reduce the number of negative incidents, and to promote the safety and well-being of the neighborhood.
    - i. PVB has invested more than \$5000 on additional cameras, ID scanners, and fencing (See Exs. 1-15).
    - ii. PVB has hired new management and professional security force.
    - iii. PVB has implemented standard protocols for dealing with altercations, rowdy patrons, and unforeseen incidents.
    - iv. Agent, Ramos-Garcia, requires scanned IDs for all patrons parking in the adjacent lot.
    - v. Agent Ramos-Garcia has provided his personal contact information to all residential neighbors.

## 3. The recommendation is contrary to neighbor testimony and support.

- a. Mrs. Tamalo testified that she "doesn't see[] any problems with th[e] bar at all." She testified that, since PVB opened, she has only experienced one issue, which was related to the noise during an outdoor event. Agent, Ramos-Garcia, stated that he had already decided to reorient speakers to face away from the residential area to the West of PVB. (Testimony of Gloria Tamalo, Min. 2:15:00 2:18:00, Hearing dated 7/16/2019).
- b. The Findings of Fact characterize Mrs. Tamalo's testimony only as she was "concerned about the very loud music," and disregards her approval of the business, and the fact that there was only a single incident.
- 4. The decision to reduce the capacity is not supported by any evidence or testimony given.
  - a. No testimony regarding capacity was introduced, beyond Ald. Perez's recommendation. The City did not produce any witnesses to testify regarding capacity.
  - b. No testimony or evidence presented correlated any issues described in the police reports with the capacity of PVB.

## 5. PVB was denied adequate due process.

- a. The Notice of the Committee's Meeting ("Notice") did not state that modifications to the plan of operation and reduction of capacity were likely, or even possible. Werk was not given adequate opportunity to prepare for this modification.
- b. The Notice did not state that Werk had the opportunity to present its own witnesses under oath, and to cross-examine witnesses, pursuant to

Milwaukee Ordinance 85.3.b-4. Werk was unable to confront witnesses, whose statements the Committee relied on.

c. Hearsay statements, witnesses, and officers described in the Police reports were not subject to cross-examination as required by Wis. Stat. § 125.12(7)(b)2.

Werk, and its agent, Marcos Ramos-Garcia, respectfully ask the Council to approve renewal of its permits with a warning letter, no suspension, and no reduction in its capacity.

Alternatively, if the Council is not prepared to grant Werk's first request, Werk asks the Council to vote to send this matter back to committee for a re-evaluation, considering alternate remedies proportional to the City's concerns regarding public's health, safety, and welfare. Werk asks the Council to grant a temporary extension of permit to allow PVB to continue operations while this matter is reviewed at Committee.

Werk proposes, as an alternate sanction to suspension and reduction of capacity, that it close its patio entirely.

Werk asks the Council to grant oral arguments at its next regularly scheduled meeting.
