File #090869 authorizes the Milwaukee Police Department to apply for, accept and fund a Speed Enforcement Grant from the Wisconsin Department of Transportation – Bureau of Transportation Safety in the amount of \$35,000. Proceeds are directed to police overtime costs, and necessary equipment, relating to enhanced efforts to adopt a zero tolerance for speed and aggressive driving during all motor vehicle stops. Identifying unrestrained occupants is a secondary priority of this grant program. The 100% donor funded grant is for the period October 1, 2009 through September 30, 2010.

BACKGROUND

The Wisconsin Department of Transportation – Bureau of Transportation Safety makes various grants available to law enforcement agencies for initiatives that promote and encourage safe driving.

The following table provides information on recent speed enforcement grants – termed either a "Speed and Aggressive Driving Enforcement Grant" or a "Speed Enforcement Grant" - from the Wisconsin Department of Transportation – Bureau of Transportation Safety that required Common Council approval.

DISCUSSION

Application and coordination of the Speed Enforcement Grant initiative is done within the Neighborhood Task Force. Utilizing primarily the Motorcycle Unit, a concerted effort is made to cite speeding and aggressive drivers during certain times (primarily 2:00-7:00 p.m.) and certain days (designated saturation patrols).
