This Appeal is questioning the decisions, inspections, and re-inspection fees from Inspector Mathew Jenrich of the Department of Neighborhood Services in Milwaukee, WI.; Totaling \$304.14 and any other amounts the department is claiming we owe on the Matter of ORD-19-07660 dated 05/08/2019, 06/05/2019, 06/15/2019, 07/03/2019, 08/30/2019 and 09/06/2019.

All requirements to order ORD-19-07660 request to correct on 5/8/2019; Violations under 295-503-1 and 79-12 under Milwaukee City of Ordinances; were resolved and completed by the due date of 6/15/2019, and that no subsequent storage nor Debris remained at the property, 1313-15 W. Cherry St. Milwaukee, WI 53205.

Further, that all subsequent orders beyond the 5/8/2019 request, were issued with questionable cause and intent. The reason and intent, to which, will be sought through litigation in Court.

We remit as proof Inspector's Jenrich's own Photo's released to us from his inspection on 5/8/2019 and 8/30/2019. We looked at them and are proud of how clean and organized our Yard is. Inspector Jenrich told us the reason for the fee on 9/6/2019 was for storage, His pictures show no storage, nor Violations of Milw. City Code of Ordinances 79-12. We further request the photos of the initial inspection on 6/15/2019 and all subsequent photos of Inspections and alleged violations of sections 296-503-1 and 79-12 be made available and also request all work and Cell Phone call and GPS Records of Inspector Jenrich for each alleged violation.

Upon inspection of Inspector Jenrich's photos you will see a well maintained and organized yard. We admit, we are the Center of action in our neighborhood. You will see that while active in efforts to keep our community clean and working with many City Programs to improve our Neighborhood with Clean up's April 27, May 25, June 29, Aug. 17 with Keep Greater Milwaukee Beautiful and Cherry Hill Community Gardens along with Milwaukee Urban Gardens. We do make the use of our trailers available for all our community efforts. We make sure that all items are taken to the City disposal yard in a timely manner. At no time after the 6/15/2019 deadline has the yard had storage or been full of debris, it is an organized area, clean and following all City of Milwaukee, Milwaukee Department of Sanitation, and State of Wisconsin rules for proper disposal of materials.

All Items Collected are kept properly in bins and in trash cans. Our efforts and Clean ups can be traced through the City of Milwaukee's "Click for action" page, you will find requests and the dates we were working in the neighborhood under bfriendly13@yahoo.com and 414-931-0506. All the inspector Jenrich could pick on was what he saw on our trailers, Which were materials being kept properly and disposed of quickly.

All items in our yard at all times were in a neat and organized manner, not thrown around debris as Inspector Jenrich described in his reports. We fail to see in his own photographs or understand why he even tried to issue these Violations. There has been no Liter, Solid waste, Nauseous or Offensive Substances or Materials on the property at any time, and further that all work materials for home repairs or improvements were kept in good condition and properly placed in a manner that followed City and State Regulations.

We ask that all citations and fees be forgiven and that the original order be registered as completed.


