## **Budgetary Changes**

- The 2020 Operating Proposed Budget has been decreased by approximately 1.5% from the 2019 adopted budget
  - Salary savings are due to anticipated vacancies
- Special purpose accounts
  - Insurance costs have increased by \$267,000
  - Anticipate requiring \$400,000 less in outside Counsel Expert Witness costs

# Community Goals and Department Objectives

- 1. Improve the city's fiscal capacity
  - Protect the city's interests in litigation
  - Manage risk so that liabilities do not disrupt finances
- 2. Support the city's interests and policy initiatives
- 3. Develop and sustain legal strategies to promote respect for individual civil liberties
- 4. Sustain safe and healthy neighborhoods
  - Reduce nuisances that detract from neighborhood quality of life

## **Organizational Opportunities**

#### Assistant City Attorney (ACA) turnover:

- Filling 3 ACA positions: 1 retirement and 2 attorneys that left for opportunities elsewhere
- Provides an opportunity to augment a strong roster of attorneys with promising talent and fresh perspectives
- Ongoing issues with staff retention

#### **Diversity Clerkship:**

 Participation in State Bar program to introduce law students from diverse backgrounds to the practice of law

## **Organizational Opportunities**

#### **Recruitment Successes:**

- Between October 2018 & September 2019 the department successfully hired 8 attorneys from a single ACA eligible list and 1 attorney from a eligible list from another department.
  - All new ACA hires joined the City Attorney's Office with strong experience in municipal law.
  - 5 ACA I hires and 4 ACA III hires
  - The Milwaukee City Attorney's Office continues to be an employer of choice for public sector legal positions in Southeastern Wisconsin.

## **Staffing Challenges**

- Difficulties in the retention of attorneys due to market salary competition
- Suspension of 2019 ACA merit pay plan
- Suspension of all 2020 merit pay increases
- Equity and budgetary concerns prohibit hiring at higher salary levels
- In 2019, 3 Assistant City Attorneys left the office (1 retired and 2 left after less than 7 years in the office)

## **Staffing Challenges**

- Currently 2/3 of our 34 ACA's have less than 7 years of experience in our office.
  - 9 ACA's, 26% of our 34 ACA's with less than 1 year of experience in our office.
- Only 11 of our ACAs have more than 7 years of experience in our office and 5 of those 11 are eligible for retirement.
- Of the 4 Deputy City Attorneys 2 are eligible for retirement.
- The loss of experience and institutional knowledge requires greater supervisory oversight & training and results in service delivery challenges.

- Assisting city departments with DNC related records requests.
- Drafting data sharing agreements with Secret Service & others.
- Assisting DPW with permitting and transportation matters.
- Assisting DER with employment related policies during DNC.

- Assist the City and RACM in partnering with MATC, JCP Construction and the Social Development Commission on a program to provide hands-on experience and training to unemployed residents in the rehabilitation of tax-foreclosed homes.
- Successfully defended BOZA in 5 appeals in circuit court (1 case currently on appeal and 3 others still pending).
- Filed 263 eviction cases for City and HACM-owned properties between July 1, 2018 and June 30, 2019 (evictions by HACM often remove tenants involved in criminal conduct and make housing available to others on HACM's waiting list).
- Provided approx. 18 public records / open meetings training sessions to various city departments & HACM.

#### **Claims:**

- Staffed by two adjusters and an administrative assistant
- Process all claims filed with city for investigation, analysis and any settlement
- City attorney may settle claims not involving a motor vehicle accident in an amount up to \$5,000
- City attorney may settle motor vehicle claims up to the statutory limit of \$250,000 but larger claims are submitted to Common Council for approval
- All of the adjusters' determinations reviewed by Deputy or Assistant City Attorney and ultimately by City Attorney

Matters in Litigation other than mortgage foreclosure actions:

- 212 in 2017, 203 in 2018, 117 in 2019 through September 9th
- 246 cases closed in 2017 without payment
- 110 cases closed in 2018 without payment
- 122 cases closed without payment in 2019 through September 9th

Mortgage foreclosure actions:

- 305 cases opened in 2017, 270 opened in 2018, 157 opened in 2019 through September 9th
- 173 cases closed in 2017, 384 closed in 2018, 227 closed in 2019 through September 9th
- 242 remained pending at end of 2017, 165 remained pending in 2018, and 209 remain pending in 2019 through September 9th

#### **Property Assessment Litigation:**

- 38 cases pending with potential exposure of \$22,620,864
- Only one judgment against the City in the past six years and the adverse judgment is being appealed
- In 2019, won outright eight contested cases with potential exposure of \$8,000,000

#### Significant property assessment lawsuits:

  - Assessment of office tower affirmed by Milwaukee County Circuit Court
  - Potential exposure of \$5,300,000
- Wisconsin & Milwaukee Hotel, LLC. v. City of Milwaukee
  - Assessments of hotel property affirmed by Wisconsin Court of Appeals
  - Potential exposure of \$970,400
- Lindner Terminals v. City of Milwaukee
  - Assessment of warehouse property affirmed by Milwaukee County Circuit Court
  - Potential exposure of \$275,000
- SWD Commerce, LLC v. City of Milwaukee
  - Assessment of hotel property affirmed by Milwaukee County Circuit Court
  - Potential exposure of \$256,000

## Highlights – Neighborhood Revitalization & Ordinance Enforcement Section

#### **State and Federal Litigation:**

- Exploitative Landlord cases Receiverships & property management paid for by income generated by properties.
- Serial Bankruptcy Filing Landlord cases City continues to object to automatic stays and plans, real estate valuations and adversarial proceedings.
- Human Health Hazard cases Unabated hoarding and infestations.
- Northridge Mall Raze litigation Pending in circuit court, city counterclaimed with public nuisance action.
- COM v. Bird Rides Inc. Federal litigation and mediation resulted in \$65k payment to city and \$30k in unbranded, in-kind contributions.

## Highlights – Neighborhood Revitalization & Ordinance Enforcement Section

#### **Legal Services and Outreach:**

- Community prosecution team continues to collaborate with other city departments and governmental agencies, local businesses, community based organizations and residents to holistically address chronic neighborhood and housing-related problems.
- Conducted dozens of property investigations and landlord/licensee interviews on behalf of MPD districts and DNS special enforcement.
- Monitoring & Objecting to Sheriff Sales for compliance with third party eligibility statute resulted in denial of new properties bought by problem landlords and generated \$25k in past due revenue.
- Investigated 88 In Rem Vacation applicants heard by Jud/Leg.
- 2020 Democratic National Convention preparations for free speech, civil disturbances, mass arrests, licensing and permitting.
- Continued collaboration with neighborhood associations, Legal Action of Wisconsin, Legal Aid Society and LISC regarding retaliatory evictions and substandard housing.

#### **Building & Zoning Code Prosecutions:**

- 2019 YTD: 1,638 B&Z cases
- 2018: 1,540 B&Z cases

#### **Municipal Court Prosecutions:**

- 2019 YTD: 980 trials, 6,833 pretrial conferences
- 2018 : 1,582 trials, 11,373 pretrial conferences
- 2017: 1,513 trials, 10,101 pretrial conferences
