Two firms responded to the Request for Proposals (RFP). Both proposals were evaluated per the criteria of the RFP. The highest ranked firm was Champion Commercial Structures (Champion). Travaux/HACM staff interviewed Champion's staff and visited Champion's production facility to discuss the proposal in more detail. Travaux/HACM staff determined that Champion's capabilities, capacity, and preliminary pricing are acceptable. Final pricing for each building will be further negotiated as the building is approved and scheduled for production.

The Modernization & Development Services Section recommends a total award in the amount of \$22,000,000.00 not-to-exceed to Champion. This award will be split into two parts, exact dollar amounts to be determined and adjusted as necessary. One part will be for approximately \$15,500,000.00 not-to-exceed for the factory-built housing units themselves (commodity). The other part will be for approximately \$6,500,000.00 not-to-exceed for the to-exceed for associated work on site (construction).

Award to Champion is contingent upon the execution of the contract between Travaux Inc. and Westlawn Renaissance VI LLC for Phase 4B construction.
