Dear Members of the Board:

On June 20, 2019 at 10:11pm the Milwaukee Police Department attempted to contact Mr. Brace M. Thompson regarding property damage at 6202 N 106th St., the call was not answered and Officer Gonzalez contacted the City Hall operator to have a Department of Public Works carpenter report to the location for a board-up.

As stated on the Board-up Data sheet City of Milwaukee carpenter Thomas Rowe was called to board the broken window on the south side of the garage, City of Milwaukee carpenters are directed by the Milwaukee Police Department on what should be boarded and Mr. Rowe stated he was only instructed to board this window.

City of Milwaukee carpenters are paid from the time they are called by the City Hall operator until the time they return home; Mr. Rowe stated on the Board-up Data Sheet that he was contacted at 10:15pm and returned home at 12:40 pm; he also listed materials used as 1 sheet of plywood, the billing sections charges were based on the data provided by Mr. Rowe.
