Review of Past Audits and Progress

PHF Classification System

- PHF developed a classification system to report on the status of each recommendation:
 - Completed PHF has reviewed or been able to confirm that this item is complete.
 - In Progress PHF has reviewed documentation or is able to confirm the health department is working to complete this.
 - Unknown PHF does not have the documentation or has been unable to verify information to confirm if this item is completed or in progress.
 - Incomplete PHF has reviewed documents or has confirmed with the health department that this item has not been completed.

 - 7 Corrective Actions
 - 2 Completed; 5 In Progress
- Nursing Case Management
 - 5 Corrective Actions
 - 1 Completed; 3 In Progress; 1 Incomplete
- Environmental Investigation
 - 4 Corrective Actions
 - All In Progress



Summary

- Milwaukee has a high burden of lead poisoning cases
- The Milwaukee Health Department Childhood Lead Poisoning Prevention Program has made large strides
- Additional steps are being taken to continue progress
- Continued PHF work will include:
 - Identifying standards, benchmarks, and model practices
