Milwaukee Scattered Sites No. 2, LLC ("MSS2"), a Wisconsin limited liability corporation. MSS2 is an entity of Gorman & Company, Inc. ("Gorman"), a firm founded by Gary J. Gorman in 1984 to develop multi-family housing real estate projects. Gorman has completed a variety of developments in Milwaukee, as well as throughout the State of Wisconsin, and the United States. Gorman specializes in developing affordable rental communities using the Section 42 Low-Income Housing Tax Credits (LIHTC). Entities created by Gorman have successfully acquired and rehabilitated scattered site, property-tax foreclosed properties from the City of Milwaukee in the past.

#### **SCATTERED SITE HOUSING REHABILITATION**
