We are proposing to modify the existing 12'-10" anodized storefront entry vestibule into two separate entry vestibules. (1) 3'-0" door on the south side for access to the upper space & adding (1) 3'-6" door on the north side of the storefront for entry into the lower retail space that will be remodeled. Instead of having a 90 degree corner, the new door would be flush with the existing storefront door location. Interior space (75'-0" x 33'-0") is to be remodeled into a retail location for linen/charger display with an office/conference room, small kitchenette, storage area & electrical/tele. rooms. All exterior finishes and material will match the existing adjacent finishes that currently exist.
