Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.





The hearing before the Licenses Committee will take place on 12/3/2019 at 2:30 PM, in Room 301-B, Third Floor, City Hall. If you wish, you may provide testimony at the hearing regarding the request; see below for further information. You are not required to attend the hearing. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing. Please review the information below and if you have further questions regarding this process, please contact the License Division at (414) 286-2238.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.



The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 08/18/07 at 1:42 am, Milwaukee police were dispatched to 49th/North Avenue for a Shots Fired complaint. While squads checking the area, officers were flagged down for fight possibly related to the shots fired complaint. Officers spoke to a woman who stated she was beat up in front of 4009 W North Avenue. The victim stated she was inside Connie's Nite Life Lounge when a known female approached her and began yelling at her causing a disturbance. Many patrons were escorted out of the tavern because of this and a fight erupted in front of the tavern with shots being fired by an unknown subject. Officers located five casings on the sidewalk in front of the tavern and an arrest was made regarding the battery. The suspect was charged with Substantial Battery.
- 2. On 11/16/07 at 1:48 am, Milwaukee police were dispatched to 4001 W North Avenue for a Battery complaint. Officers spoke to the caller/licensee, Connie Leland, who stated three men hit one of her security guards in the head. Leland stated she was closing the bar and the men were asked to leave. Officers spoke to the owner Connie Leland who stated a patron tried entering the tavern without paying the cover charge and security refused to let the patron in however the patron pushed his way past security. The patron was escorted out and as he left in an auto, he made a gun hand gesture pointing at Leland. Leland stated she would like the police to watch the premises. The call was advised.

5. On 11/11/10 at 12:32 am, Milwaukee police were dispatched to 4001 W North Avenue for a Fight complaint. Police spoke to the victim who stated a known female struck her on the head with a glass beer bottle causing a laceration. 7. On 04/03/11 at 2:00 am, Milwaukee police were dispatched to 4001 W North Avenue for a Fight complaint. Police spoke with Connie Leland who stated a group of females started fighting in the bar and that one of them threw a glass at the security guard, identified as Ricky Trotter, striking him in the head. Leland stated the patron is a frequent customer at the bar, but that she didn't know her name. Police obtained other witness statements regarding this incident. Trotter was conveyed to an area hospital where he was treated for cut to this forehead and the interior part of his right eye. Trotter received an undetermined amount of sutures. A copy of video surveillance was obtained and inventoried.

While outside, the one suspect demand and removed money from the guard as the other discharged his handgun several times, striking Williams in the knee. A pit-bull that had come running down the stairs from an upper apartment above the bar was also shot 5 times by one of the suspects. A second security guard, who was still inside the bar, opened the tavern exit door and was shot at by one of the suspects, with the round striking the women's bathroom door. Both suspects then fled on foot through an alley. Surveillance video was obtained and placed on police inventory. The licensee, Connie Leland, was notified of the incident.

- 9. On 01/24/13 at 1:35 am, Milwaukee police were dispatched to 4001 W. North Avenue for a Trouble With Subject complaint. While police were en-route, the call was upgraded to a Shots Fired. Officers arrived on scene and spoke to Connie Leland who stated that she originally called the police because she and her security were having trouble controlling a known patron, who was in a verbal altercation with another patron in the bar. Security was escorting the subject out of the bar when the subject grabbed a glass and threw it at the known patron. Once the subject was outside, security locked the front door, however, the subject began banging on the front door calling for the known patron to come outside. Leland stated she kept the known patron inside and called police. Leland stated the subject left the area in an auto and approximately 10 minutes later, the subject returned and stood outside the front door area of the bar, where he shot a firearm into the air one time. Leland has a functioning surveillance system, which did capture the incident on tape. A copy was provided and placed on police inventory. Reports were filed.

- 11. On 04/17/2014 Milwaukee police responded to a recklessly endangering safety complaint at 4001 West North Avenue (Connie's Nite Life Lounge). Investigation revealed that around 12:00am two subjects approached the business together, one of these subjects was denied entry because during a pat down it was discovered that he was carrying a handgun on his person. This subject went to an auto, placed the handgun inside and returned to the business. He was then allowed entry. Around 1:00am, these same subjects left the business together. Minutes later, one of these subjects returned to the bar and told security to call 911 because he had been shot. The victim, who was treated at Foredtert Hospital for a gunshot wound to the face, reported that the subject he had been at the business with earlier had shot him. Milwaukee police incident report #141070019 filed.

- 12. On 04/21/2014 a meeting attended by members of the Milwaukee police department, the applicant and one of the applicant's security guards was held at Milwaukee police district #3 regarding the shooting described in item #11. During this meeting, the business's security practices were discussed. Officers suggested that if a weapon was discovered on someone attempting to gain entry, that person should be banned from the property. The applicant discussed current security arrangements with officers and agreed to take steps to make some corrections.
- 13. On 06/21/2014 Milwaukee police responded to a battery complaint at 2466 North Teutonia Avenue. The female argued with Peoples and then struck her several times in the head with an unknown object. Peoples was later treated at Froedtert Hospital where she received two stitches to her right ear. The applicant told police she was aware of a disagreement inside the bar, but that it didn't seem too serious. Additionally, the applicant stated that when she became aware of the fight outside, Peoples told her she did not want to involve the police. The establishment's video wasn't working at the time of the incident. Milwaukee police incident report #141720035 filed.
- 14. On 10/30/2014 Milwaukee police, while on patrol, heard a gunshot in the 2200 block of North 40th Street. Security and citizen's from Connie's Nite Life Lounge told officers that the person who fired the shot had fled southbound in a dark color SUV. Security and witness's from the business told officers they had observed a fight in the middle of the street, and that one of the combatant's had fired at least one shot from a handgun into the ground. Neither the person who fired the shot, nor the other party involved was located by police. The establishment's video cameras were not operational during this incident. Milwaukee police incident report #143030012 filed.
- 15. On 11/06/2014 Milwaukee police observed a fight outside of 4001 West North Avenue (Connie's Nite Life Lounge). Investigation revealed there had been a fight inside the business and that the involved parties continued outside. The establishment's video cameras were not operation during this incident. The applicant stated they have been waiting on a part for the cameras for approximately 8 months. Four patrons were cited for disorderly conduct.
- 16. On 11/06/2014 Milwaukee police observed that there was no Maximum Occupancy Placard visible inside Connie's Nite Life Lounge (4001 West North Avenue). The applicant was cited.

- 17. On 02/12/2015 Milwaukee police were flagged down by a security guard, Steven Thompson, at Connie's Nite Life Lounge (4001 West North Avenue) regarding a fight. Thompson told officers that he barred entry to 4 males who appeared to be under the age of 25. One of the males returned a short time later, pointed at Thompson and said "he's the one from Wal-Mart get the gun". No weapons were recovered and no one was arrested.
- 18. On 03/06/2015 at 1:20am officers responded to several calls of shots fired at 4001 W. North Av. The investigation revealed the victim was inside Connie's Nite Life Lounge since about 11:00pm. He had an argument with other patrons and at about 1:15am was kicked out by security, at which point a fight with security and other patrons occurred. The fight ranged from 10-20 individuals. After the fight the victim was walking to his car and several shots were fired. At his car he was approached by an unknown subject who asked if he was okay. While talking with this person another subject walked up and shot him in the chest. The victim stated the subject who shot him was not one of the security guards he had been fighting with inside. The call came from a patron of the business who stated a subject had threatened her and was in possession of a gun. This subject was ultimately apprehended by police and issued a citation for Disorderly Conduct. No firearm was discovered.

North Av with the victim sitting in a car that the suspect shot into. There were patrons in line waiting to get into Connie's Night Life, 4001 W. North Av. None of the people in line saw anything and the security guard stated he heard the shots but did not see anything. The officers checked the video surveillance but found the system unable to record because the hard drive was full.
- 22. On 08/16/2017 at 2:08am officers observed a large crowd outside Connie's Nite Life, 4001 W. North Av. The officers observed two crowds, one in the street surrounding a fight and another around the business. The suspect in the fight was taken into custody and another disorderly subject was arrested. The officers looked at the video system but found the system was full and unable to record.

- 23. On 09/03/2017 at 2:14am officers were dispatched to a shots spotter call at 4005 W. North Av. The officers observed a large crowd outside Connie' Nite Life, 4001 W. North Av. There were cars blocking the intersection with several people fighting in the street. The subjects fled the scene when the police arrived. There were no callers regarding this incident.
- 24. On 09/15/2017 at 1:19am officers conducted a tavern check at Connie's Nite Life, 4001 W. North Av. The officers observed 25-30 people outside the premise. They then counted patrons as they exited. There were 102 people, including employees, inside the business. The official placard stated the business had an occupancy limit of 80 people. The applicant was cited for being over occupancy.

- 25. On 09/22/2017 at 12:59am officers were dispatched to a fight at N. 40th St and W. North Av. The officers observed 25-30 people outside Connie's Nite Life, 4001 W. North Av. The security guard stated there was a fight between two groups of females but they had left. The caller stated this was an ongoing problem
- 26. On 10/10/2017 there was meeting held at District 3 regarding incidents at Connie's Nite Life, 4001 W. North Av. The applicant stated she had armed security but had to let them go after a homicide. She now has unarmed security but they have come complacent and are often smoking cigarettes with the patrons. She stated she no longer has a patio which is causing patrons to smoke outside the front. This is causing problems because people in line are getting angry when they are not let inside because of capacity issues. It was suggested that she have rope line put up outside and limit the number of people waiting to get inside. 

We will schedule follow-up onsite meetings with the MPD Community Liaison Officer to review and advise us on our security and other measures.

We will be using an ID scanner.

We will institute a self-policing program, similar to MARTS, to ensure all employees are compliant with all laws and regulations surrounding the sale age-restricted products.

Cameras - We currently have a new camera system. We have twelve cameras in the premises and four cameras outside.

We will have monthly employee meetings to continue to go over these policies and procedures.

We have already invested over \$20,000.00 in making improvements to the building, and as our profits increase, we intend to continue to invest in the building.

Litter Control – We shall control and inspect the litter emanating from our site three times per day, in the morning, mid-day, and an hour before close.

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Davs.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02/18/2014 a Milwaukee police officer responded to 5007 West Center Street (Uptown Café) in an attempt to retrieve video regarding a burglary. After several failed attempts by phone and in person to contact the applicant, the officer gave up and no video was obtained regarding Milwaukee police incident report # 140460041.
- 2. On 04/27/2014 Milwaukee police responded to a shooting at 5004 West Center Street. Two subjects were struck by gunfire. These subjects told officers they were in the area to patronize Jay's Uptown Café, but they were shot prior to entering the business. Additionally, a vehicle owned by a patron of Jay's Uptown Café was struck by gunfire. Milwaukee police incident report #141170023 filed.
- 3. On 11/09/2014 Milwaukee police responded to a subject with a gun complaint at 5007 West Center Street (Jay's Uptown Café). Chuck Brady, the head of security, stated there was a fight inside the premise. Brady stated two of the subjects that were fighting were kicked out and they were armed with guns. Brady believed the subjects retrieved the guns from their cars. Brady further stated a security guard was taken to the hospital. James Perry was interviewed at St Joes Hospital. Perry stated a fight broke out and when he attempted to help other security guards he was knocked to the ground by an unknown subject. While on the ground he felt a poke to the left side of his head. Perry than used his mace and sprayed the crowd. He then felt someone bite his ear. Perry received 30 stiches to the back of his head, 4 staples to

his right hand, 4 stiches to his right ear and 3 stiches to a puncture wound. The agent was on scene but did not witness the fight. No video was available for this incident. Milwaukee police incident report #143130014 filed.

- 4. On 03/29/2015 Milwaukee police responded to a shots fired complaint in the area of North 50th Street and West Center Street. Police received calls from citizens about shots being fired in the area as well as Shotspotter activity in the same area. After the initial call for shots fired, officers were dispatched to St. Joseph's hospital to meet a shooting victim. The victim told officers he had been at Jay's Uptown Café around 11:20pm. When he exited the business around bar close and returned to his car. The victim decided to urinate outside of his vehicle when he observed an unknown subject fire numerous shots in his direction from a long gun. The victim suffered 11 wounds as a result of this incident. Officers later discovered 15 spent casings in the area of the shooting and that the victim's car sustained damage from 15 gunshots. The agent stated there was a large crowd that night for his birthday but there were no problems inside the tavern. Milwaukee police incident report #150880024 filed.
- 5. On 08/23/2015 Milwaukee police were dispatched to 5007 West Center Street for a shooting and fight complaints. While at that location, officers were informed a victim had gone to St. Mary's hospital indicating he had been shot in a tavern in the area of North 49th Street and West Center Street. The victim stated he left the business with other patrons when he heard 7-8 gunshots. The victim later realized he'd been shot and was taken to the hospital. The victim suffered a gunshot wound to the foot during this incident. A total of 17 casings and 2 bullet fragments were recovered from the shooting scene. Milwaukee police incident report #152350026 filed.
- 6. On 01/03/2016 Milwaukee police responded to a battery complaint at St. Joseph's Hospital. One witness told officers she believed the victim had been involved in an altercation at a bar named "Jays", but she could not provide a location. The victim had a laceration to his head, and indicated there had been an incident at an unknown bar on the south side. The victim declined to make any other statements. An officer determined the only tavern in the city of Milwaukee named "Jays" is Jays Uptown Café (5007 West Center Street). An officer conducted follow up on 01/06/2016 at Jays Uptown Café. The officer viewed video from inside the business on the night of the incident. The officer observed nothing on camera indicating an altercation had occurred on the premises. The applicant indicated he was on scene the night of the incident and reported no problems that night. Milwaukee police incident report #160030027 filed.
- 7. On 01/30/2016 a Milwaukee police officer observed patrons arguing and pushing each other while exiting Jay's Uptown Café (5007 West Center Street). The disturbance ceased when the officer activated the squad's lights and siren.
- 8. On 03/06/2016 Milwaukee police were dispatched to a battery complaint at 5007 West Center Street (Jay's Uptown Café). The caller told officers she was with a group of females who caused disturbance and were asked to leave. When she refused, a security guard removed her from the premise. The caller told police she was mad because security did not have to put his hands on her.

- 9. On 06/11/2016 Milwaukee police responded to a theft complaint at 5007 West Center Street (Jay's Uptown Café). There had been an altercation inside the business that was broken up by security. One of the involved parties dropped some personal property and another person picked it up with the intent of depriving the owner. Milwaukee police incident report #161630020 filed.
- 10. On 06/12/2016 Milwaukee police were dispatched to a subject with a gun complaint in the area of North 50th Street and West Center Street. Investigation revealed there had been an altercation involving patrons inside Jay's Uptown Café and this altercation moved outside the business. A security guard from the business intervened, drawing his firearm. The security guard was arrested for endangering safety by use of a dangerous weapon. Milwaukee police incident report #161640023 filed.
- 11. On 06/30/2016 Milwaukee police were dispatched to a battery cutting at St. Joseph's hospital. The victim told officers that around 2:15am there were 20-25 patrons on the sidewalk outside Jay's Uptown Café (5007 West Center Street). One person was knocked out and another person suffered a laceration on their ankle. Milwaukee police incident report #161820022 filed.
- 12. On 07/03/2016 Milwaukee police were dispatched to a trouble with the subject complaint at 5007 West Center Street (Jay's Uptown Café). Officers were told that 4-5 subjects were causing a disturbance. Police were unable to locate the subjects causing the disturbance.
- 13. On 08/28/2016 Milwaukee police conducted an investigation regarding patrons of the premise parking between construction barrels on West Center Street in front of the premise. Officers taped off a section of the street to prevent vehicles from moving prior to being cited. A security guard went under the police tape and entered the applicant's vehicle. Officers needed to physically remove the security guard from the vehicle and escort him out of the taped off area. Patrons became upset while officers cited the parked cars and additional squads responded. A total of 12 parking citations were issued for obstructing the roadway.
- 14. On 10/30/16 Milwaukee Police responded to a subject with gun call at 5007 W Center (Jays Uptown Café). Officers spoke with the agent and explained to him they had received a call that a subject wearing specific clothing was in the business and possessed a firearm. The agent was cooperative and stated he did not observe anyone matching the description. He allowed officers to check the business and they did not locate anyone matching the description.
- 15. On 11/03/16, at 1:56am, officers responded to a shot spotter call at 5001 W Center. They also received an additional call that someone was shooting inside of Jays Uptown Café. It was later determined no shots were fired from inside the establishment. Officers did locate vehicle that was struck and a casing at 4917 W Center.
- 16. On 11/06/16 a Sergeant observed a large crowd gathered in front of Jays Uptown Café(5007 W Center). She then observed a fight between multiple people break out on the sidewalk. Multiple squads arrived and were able to disperse the crowd. A bouncer stated a fight between multiple females began inside and made its wat to the front of the tavern until police arrived.

17. On 11/27/2016 at 1:57am officers were monitoring the area of Jay's Uptown Café at closing. They observed a subject in the street at 4925 W. Center St firing a gun in the air. They attempted to pursue the auto the subject got into but canceled the chase due to high speeds. Security stated the subject was upset because he was turned away at closing.

- 18. On 01/10/2017 a meeting was held at District 3 with the applicant. The applicant state he has 5-6 security personnel and 8 cameras. He has an ID scanner but does not use it for every patron. He stated all patrons are wanded at the door. The applicant was advised to use the ID scanner for all patrons, improve his camera system and to call the police before incidents became larger problems.
- 19. On 01/22/2017 at 2:10am security from Jay's Uptown Café called to report 2 males with guns and females fighting in the alley. The subject had left prior to the officers arrival.
- 20. On 02/04/2017 at 1:08am security from Jay's Uptown Café called 911 stating there was a fight and there were now 3 subjects with guns outside the premise. The officers spoke with security who stated they were at capacity and people became upset when they could not enter the tavern. Security had used pepper spray then observed three people with guns. The subjects were gone when the police arrived.
- 21. On 02/19/2017 at 1:47am officers responded to a Shotspotter call at 4933 W. Center St. The officers located two victims with graze wounds at N. 50th St and W. Center St. The witness stated all parties in the shooting were drinking at Jay's Uptown Café just prior to the shooting.
- 22. On 03/25/2017 at 1:18am officer were dispatched to Jay's Uptown Café, 5007 W. Center St for a subject with gun complaint. The officer observed a group of females being kicked out of the tavern. One female was requesting her property from inside. The applicant stated they could not locate the property. When the officers came back out the females were gone. No one approached the officers about a subject with gun.
- 23.On 04/22/2017 at 1:59am officers responded to Jay's Uptown Café, 5007 W. Center St, for a subject with gun complaint. The officer spoke with the applicant who stated there was no problem and the call was for his armed security guard escorting someone to their vehicle.
- 24. On 05/14/2017 at 10:58pm an officer observed a group of 100-150 people standing near the entrance to Jay's Uptown Café, 5007 W. Center St. and cars cruising the area. The officer observed the entrance to the bar was blocked and the bar was not letting any more patrons in the bar. The applicant was advised to have his security clear the crowd. The crowd refused and more officers responded. The large police response resulted in a back log of calls for service.
- 25. On 05/21/2017 at 11:25pm officers responded to a noise nuisance complaint at Jay's Uptown Café, 5007 W. Center St. The officer advised the premise to keep the music down and the caller was satisfied with that resolution.

26. On 02/04/2018 at 2:08am officers were dispatched to shots fired at 5007 W. Center St. The officers interviewed the caller by phone who stated one of the security guards pulled out a gun and discharged it several times. The caller was advised to return to the scene but she never returned. The officers interviewed security who stated there were two groups of females who were arguing and told to leave. None of the guards pulled a gun or discharge any rounds. There were no reports from "shotspotter" and the officers determined the call to be baseless.

- 27. On 02/08/2018 officers were conducting a tavern check at Jay's Uptown Café, 5007 W. Center St, when security flagged them down. The security guard stated a subject became upset at being denied entry because of capacity. The subject reached towards his waist band and threatened the security guard. The subject ran when police attempted to stop him and he was taken into custody a few blocks away.
- 28. On 03/03/2018 at 1:42am officers were dispatched to Jay's Uptown Café, 5007 W. Center St, to investigate the tavern possibly being over capacity and illegally parked cars. When the officers arrived the patrons were leaving because the tavern was closing. There were cars stopped on W. Center St, picking up patron, block traffic. The officers provided traffic control until the crowd left.
- 29. On 03/25/2018 at 11:10pm officers observed a large group of people and vehicles in front of Jay's Uptown Café, 5007 W. Center St. The people were blocking the front door preventing the door from opening. The officers and tavern security made announcements to clear away from the door, but the people continued to block the door. At one point security did kick out two groups of females who then started to fight outside the tavern. Additional squads were called and the business was closed for the night because security could not control the growd.
- 30. On 05/20/2018 at 1:26am officers were dispatched to three shotspotter calls in the area N. 50th and W. Center St. There were also numerous calls for shots fired with the callers referencing Jay's Uptown Café. When officers arrived they observed people running and casings in front of the business and more at the rear of the business. They also located a vehicle parked directly in front struck by a bullet. No one able to provide a description due to the number of people in the area. The business's security cameras were not functioning during the incident.
- 31. On 07/15/2018 at 1:24am officers observed a fight outside of Jay's Uptown Café, 5007 W. Center St. The officers called for addition squads to clear the crowd. The applicant closed early because of the fight and advised his security to clear the patron from the area. An additional fight occurred as people were walking to their cars. Officers had to us O.C. Spray to stop the fight and several people were arrested.
- 32. On 11/01/2018 at 1:36am officers were dispatched to Jay's Uptown, 5007 W. Center St for a Noise Nuisance and the bar being over capacity. When the officer arrived he saw a large group exiting the tavern and a fight break out. More squads arrived to restore order and the subjects fighting fled the scene.
- 33. On 11/29/2018 at 2:46am officers were dispatched to a shooting at 2670 N. 47th St. The officers located the victims in a car parked on the street. The Victim stated she was in Jay's Uptown Café and got into an argument in the bathroom with the suspect. Security removed them from the bathroom. The fight continued in the bar with the suspect throwing a drink at the victim. The suspect was removed from the bar by security. When the victim was in her car leaving for the night the suspect pulled up next to her and fired 5 shots at the victim's auto, striking the victim and her friend.
- 34. On 12/06/2018 officers investigated a shooting at 5030 W. Center St. The victim stated he was in Jay's Uptown that night. As he was leaving for the night he heard 10 gunshots outside. He ran to his car at 5030 W. Center St and heard 30 more gunshots. He then felt a burning sensation on his foot and realized he was shot. The officer went to Jay's Uptown and spoke with the applicant, who stated there were no problems in the bar that night and did not know

there was a problem outside until patrons came back inside stating there was someone shooting outside. The applicant stated the cameras at the tavern were not operating.

- 35. On 12/12/2018 an officer conducted a CPTED survey at the request of the applicant. The officer pointed out the need for additional outdoor lighting, No Loitering signs, adjusting the cameras and opening the window blinds to allow full view of the interior. The applicant was open to the suggestions stating he is in the process of getting new cameras to allow the police full access.
- 36. On 06/26/2019 at 1:14am officers were dispatched to Jay's Uptown Café for a Noise Nuisance. The call was placed at 11:40pm, with the caller stating the door was left open and patrons were in front of the bar causing a scene. When the officers arrived at 1:20am the bar was closing and the patrons were completely blocking the street with their cars. Additional squads were called to disperse the crowd and provide traffic control. The officers spoke with the applicant at 1:55am and the music was still being played inside.
- 37. On 08/29/2019 at 12:20am officers were dispatched to Jay's Uptown Café for the bar blocking the street parking with cones in front for VIP parking. When the officers arrived they did not observe any blocked areas but did see cones on the sidewalk. They did observe numerous cars illegally parked blocking driveways and crosswalks and on private property. The officer was on scene issuing parking citations when security pushed out patrons who were arguing inside. The bar then shut down and pushed a large crowd outside. Additional squads where called to shut down traffic around the bar to allow for the safe egress of the patrons. A fight broke out down the street which was broken up by officers and security. The applicant was advised of the parking issues and he could not save street parking for anyone.
- 38. On 09/25/2019 at 11:03pm an officer drove past 5007 W. Center St and observed cones blocking the parking in front of Jay's Uptown Café and directly across the street. The officer advised the applicant and security they could not block the street parking and the cones needed to be removed. On 09/26/2019 at 1:19am officers observed a large number of cars parked outside of Jay's Uptown Café. The officers spoke with security at the door and asked him what the capacity was and he stated 150. The security guard also stated there was a \$10 cover charge. The officer checked LIRA and found the capacity listed was 99. The officers then called additional squads and conducted a count of patrons. The officers counted a total of 232 patrons exiting from all doors. During the investigation the officer did not observe any signs advising patrons of the cover charge. The applicant was issued a citation for overcapacity and Tavern Charges to be Posted.
- 39. On 09/27/2019 at 4:48pm officers were dispatched to Jay's Uptown Café, 5007 W. Center St, for a Sick/Injured call. The officers were advised by MFD there was a highly intoxicated female in the bathroom that they conveyed to St. Joseph's Hospital for medical treatment. The officers spoke with the bartender who stated the subject had been in the bar about 1 hour and she served her one drink. She did not serve her any additional drinks because of her level of intoxication. The bartender was cooperative with the officers.
- 40. On 10/08/2019 a meeting was held at District 3 regarding Jay's Uptown café. Addressed at the meeting were the recent overcapacity and parking issues. The applicant was advised the capacity of the patio is included in the capacity for the building, and that security at the door should know the capacity and use a counter. The applicant stated he was concerned about the conduct of the patrons that are upset they were denied entry when the bar was at capacity. He was advised to have his security monitor the outside of the business for unruly patrons and for patrons parking on the sidewalks.

Upon arrival at 1:36 a.m., I observed a large crowd exiting from the establishment. While the crowd was walking to their autos a fight broke out. I activated my squad car lights with audible sirens. At this time I requested for more squad cars to be dispatched to the area as there were about 50-60 people in and around the street. I exited my squad car, all actors in the fight fled the area, either by foot or in vehicle; There was no complainant.

After the actors of the fight fled, all Milwaukee Police Cars involved stayed in the area to ensure safety and direct traffic. The crowd appeared confused and were causing a minor traffic jam in the area around Jays Uptown. After a brief time, traffic cleared. All squad left the area without incident.

On Thursday, November 29th, 2018, at approximately 02:46 AM, Squad 3390 (P.O. Kevin WILKE and I) was dispatched to a "Shooting" complaint located at 2670 N 47TH St, in the City and County of Milwaukee. Squad 3390 arrived at approximately 02:49 AM AM.

The shooting occurred at 2670 N. 47th St. The victims, Jermaine L. COOPER (B/F 12-01-83) and Destiny D. MCCLENDON (B/F, 05-14-1995) were the occupants of a black Chrysler Pacifica (Wisconsin plate AEJ-1486) when the shots were fired. COOPER who was seated in the front passenger seat of the parked Chrysler sustained a gunshot wound to the lower left back causing major surgery as a result of the shooting. MCCLENDON was seated in the front driver's seat of the Chrysler and sustained a graze wound to the left side of her body causing an abrasion. Both victims were conveyed to Froedtert Hospital where they received medical treatment for their injuries sustained from the shooting.

MCCLENDON stated she observed BISHOP's gold HYUNDAI Santa Fe drive alongside of her vehicle facing south. MCCLENDON stated the front passenger window was down and the driver of the gold Hyundai Santa Fe reached over the front passenger seat and intentionally fired five gunshots into her black Chrysler Pacifica. The gold Hyundai Santa Fe fled the scene southbound on 47th St. from the 2600 block.

During the course of our investigation, I determined that the shooting incident stemmed from events that took place prior that evening at "Jay's Uptown Cafe."

MCCLENDON/Victim stated that she was arguing with BISHOP/Suspect (B/F, 03-08-1984) in the bathroom at Jay's, and both parties were removed from the bathroom by security. After this occurred, MCCLENDON and BISHOP had another altercation at the bar where BISHOP threw a drink at MCCLENDON. MCCLENDON stated that security then removed BISHOP from the bar.

On Thursday, December 6, 2018, I (Sq. 7369) responded to a Shooting complaint at 5030 W. Center St., which is located in the City and County of Milwaukee. Upon arrival to the listed location I was instructed by Sq. 7310 (Sgt. Bradley DALL) to enter Jay's Uptown (5007 W. Center St.) to speak with possible witnesses.

Inside of Jay's Uptown I spoke to the manager of the business, David R. ROSE (B/M, 1/16/81), who stated that they had an uneventful and good night at the bar, and that he was not aware of an incident outside of the business until patrons started coming back inside, saying that there was someone outside shooting. ROSE stated that he did not see or hear anything regarding the incident. ROSE advised that the business' security cameras were not working at that time.

I also spoke to the owner of Jay's Uptown, Odean H. TAYLOR (B/M, 3/26/79), who advised that he was not aware of anything happening outside the bar until someone told him, and that the evening inside the bar was without incident. TAYLOR confirmed that the business' cameras were currently not working.

I spoke to the two food cooks, Thiston B. CROOKS (B/M, 12/4/78) and Devon A. GOODALL (B/M, 7/21/64), that were working at Jay's on the listed date. Both stated that they were inside the kitchen behind the bar at the time of the incident, and did not see or hear anything regarding.

It should be noted that at the time of the investigation, I observed a Class B Tavern License displayed behind the bar at the listed location. The license displayed an effective date of 12/21/2014, and and expiration date of 12/20/2015.

The victim in this incident, Darrell HOLIDAY (B/M, 7/11/93), suffered a non-fatal gunshot wound to his right foot. HOLIDAY spoke with MPD Detectives regarding the incident, and advised that he was at Jay's Uptown bar prior to the shooting. HOLIDAY stated that after leaving Jay's Uptown and while walking to his friend's car, which was located at the laundromat parking lot across the street (5030 W. Center St.), he heard about 10 gunshots. He ran to his friends car, and after getting into the car, heard about 30 more gunshots. HOLIDAY told the investigating Detective that he then felt a "burning pain" on his foot, and realized he was shot.

Taylor stated he had issues with subjects coming from the north side of street by laundromat and attempting to cause issues at his establishment. Taylor stated he was going to look into lighting up the outside of business especially the parking lot area. Taylor stated he had 6 security guards on site and he was going to take into consideration our stance on opening up the windows so police can view in. Taylor stated police wasn't able to get camera footage because the cameras are not operative at the moment but he already in the process of getting new cameras in which the department will have access without issue. Taylor also stated he was going to open the lines of communication because he really want the partnership. Taylor is contemplating on turning the business into an eat only bar type establishment the beginning of the new year. Taylor stated the capacity was 150 people. lastly Taylor stated he will fill out the standing complaint form and turn it into district 3 as well as getting a no loitering sign displayed.

Larry LEIBSLE and I, did a tavern check of 5007 W Center St, Jay's Uptown Cafe, and observed that they had over 130 vehicles in the area of the bar and per the LIRA system their capacity is 99. I contacted Squad 3412, Sgt William KINGSTON, and notified him that a capacity check should be done of this location.

Squad 3450, P.O. Taylor ZUBE and P.O. Jeremie GAINER, Squad 3430, P.O. Lydia RIVERA-HOLEY and P.O. Robert DAVIS, Squad 3321, P.O. Shacorie NASH and P.O. John DAVIS, Squad 3412, Sgt William KINGSTON, and Squad 3413, Sgt Micheal WASHINGTON, meet with us to conduct the capacity check.

Squad 3321 covered the alley located behind the tavern, Squad 3431 blocked traffic at N 50th St, nothing westbound, and watched the side of the buildings, Squad 3450 blocked traffic at N 51st St, nothing eastbound, and covered the front of the building, Squad 3412 and 3413 accompanied Squad 3465 as I contacted the Security and Owner of the location.

The bar is located on W Center St and is surround by business on W Center St which are closed at this hour. The neighborhood surrounding this location is a residential neighborhood with houses north and south of W Center St. Cars were observed parking up and down W Center St, parking lots for the local businesses that were closed at this hour were full with cars and cars were parking blocking driveways, garages and sidewalks surrounding this location.

I approached the front door at approximately 1:30 PM and spoke to Wesley T WALKER (M/B 1-3-81) who was at the door and I asked him if he was working the door he stated that another subject was taking the money but he was working security at the door. I asked him if he knew what his capacity was and he stated 150. WALKER stated that he believed they were at capacity. I advised him that their capacity was 100 and front vehicles in the area and what I could see in the bar they were over capacity. He was advised to have them shut off the music and have everyone exit the building. I positioned my self at the main entrance and counted as everyone exited the building I continued a total of 182 people that exited the main door or were still inside the bar when I entered and did a room to room count. I was advised by P.O. ZUBE that there was another door just west of the main entrance that was used by several people to exit and she counted 50 people exiting the door. I was also advised by P.O. NASH that as they were positioning themselves in the alley they observed several people having jumped the fence from the patio and running down the alley. P.O. NASH was unable to count any of the subjects.

I spoke to the owner, Odean H TAYLOR (M/B 3/26/79), who stated that their capacity was 150 people and he believed that they were close to that number. I advised him of the number that we counted of a total of 232. I also observed that they did have two posted capacities, the first stated the first floor 99 and the other was for the patio of 51. TAYLOR was advised that he would be issued a citation for being over capacity. Also while on scene WALKER pointed out the subject who was doing the count. The male who refused to identified himself stated that he had a clicker but when I asked to see it he started to say it was by the bar and then stated that it was in the office which was locked. The male also stated that he was collecting the cover charge which he stated was free at the start but later became 10 dollars. I did not observe any signage stating the cover charge anywhere in the bar.

Earlier in the night at 11:03 PM on September 25th, 2019 I drove past 5007 W Center St because of information called in on prior Wednesday nights saying that the bar has been using cones to save parking

Upon driving past I observed cones being used to block parking on both the north and south side of W Center St in front of 5007 W Center St. I spoke to the Security that was standing out front that they needed to move the cones and could not do that in the future. TAYLOR (m/b, 03/26/79)*. This meeting was scheduled due to recent citizen complaint and over capacity investigations. This meeting was conducted with Captain Jeffrey NORMAN – District Three Commander, Sergeant Chad RADEN – License Investigation Unit, Assistant District Attorney Kelly O'NEILL, Assistant City Attorney Heather HOUGH, Sergeant Guadalupe VELAZQUEZ – CPU, Police Officer Larry LIESBLE – Tavern Squad, Police Officer Michael JONES – CPU, and myself.

TAYLOR was advised about the most recent incident of over capacity at the location. TAYLOR was told of possible outcomes from having over the capacity. TAYLOR was informed that the capacity for the patio is not in addition to the capacity for the building. Capacity is only based on total for entire building (which includes the patio in the number). Another issue is the security and staff at the front door did not know where the counter was, and did not know total capacity for the building. TAYLOR stated he understood a counter should be used, and will talk to staff about it. TAYLOR stated he is concerned for when people are turned away, the problems that it will create on the street. TAYLOR was advised that he will have to continue to have security statloned outside to monitor all patrons.

Another issue brought up to TAYLOR was the patrons parking. Officers and citizens have witnessed patrons parking their cars on the sideway and illegally. TAYLOR stated he will also address this with staff to monitor and continue to stress to patrons to cooperate with.

TAYLOR was also advised to contact Department of Neighborhood Services to have the building evaluated again to capacity. TAYLOR was also notified to contact District Three ahead of time when there was an event at the location.

TAYLOR was cooperative. He was notified that District Three was going to continue to monitor the issues and calls for service at the location.


