1. Description of Grant Project/Program (Include Target Locations and Populations):

The Milwaukee Overdose Response Initiative (MORI) will take a community-wide approach towards addressing the opioid epidemic by connecting individuals who have experienced a non-fatal overdose with community resources. MORI's goals are to decrease Overdose fatalities, increase access to evidence-based treatment, and decrease emergency department usage. The partnership is led by the Milwaukee Health Department MHD) and includes the Milwaukee Fire Department (MFD) Mobile Integrated Health (MIH) Program, Medical College of Wisconsin (MCW) and Milwaukee County Behavioral Health (BHD). MORI will provide immediate follow up to all individuals in Milwaukee County who have overdosed with a team of clinicians, counselors, peer support specialists, and MFD Community Paramedics. The team will link overdose victims with appropriate education, available treatment services, and ensure victims and families are supported with the goal of connecting all patients to long-term recovery. A secondary goal of this project is to identify individuals in Milwaukee County who have engaged with the Emergency Medical System (EMS) as a result of an overdose. MORI is a functioning overdose response partnership and with a comprehensive overdose response plan. The outcomes of expanding and sustaining the MORI project include comprehensive support for overdose victims and their families as well as create a deeper understanding of the opioid epidemic in Milwaukee County through data, surveillance and analytics.

2. Relationship to City-wide Strategic Goals and Departmental Objectives:

Contributes to the Mayor goal of providing safe and healthy neighborhoods through the provision of effective emergency response services.
