

At approximately 9:13am, ROBINSON entered One Stop Mart, located at 2709 N. 28th St, and purchased a, Grape Swisher Sweet Cigar. ROBINSON stated the cashier did not check her ID and was described as: Middle Eastern, male, wearing a blue/gray shirt, gray hair, short mustache.

Upon entering the store I was able to immediately identify the cashier based on the description provided. The cashier was identified as: Belal N. ATARI (m/w 10-12-69), the listed agent of the business. ATARI stated that he usually checks ID before selling, and apologized.



5. On 08/21/13 officers investigated a Stabbing that occurred at 1:15am in the parking lot of Lisbon Gas and Food at 3033 W. BUTT is seen head-butting her and grabbing a baseball bat and swinging at DAWSON. The video does not show if DAWSON was hit during this portion due to the angle of the camera. The video then shows DAWSON leaving through the front of the gas station and later coming back into the gas station. DAWSON uses a garbage can to prop open the front door, runs in and throws store items onto the floor. The video shows BUTT run from behind the gas station counter with a baseball bat. BUTT then swings at DAWSON while she is in the front door area and hits her. DAWSON exits the gas station and we cannot see what takes place outside. On Tuesday, 06-25-2019 at approximately 12:49 a.m. I, P.O. Antonio OBREGON, Squad 3340 was dispatched to a Shooting Complaint at the location of 2624 W. Lisbon Avenue(B.P. Gas Station).

Upon arrival I observed an older model Black Chevy Tahoe leaving the gas station out of the North West drive way at a high rate of speed. The vehicle was being driven by a black male, medium complexion in his 20s with a dark colored t shirt on and black dreads that were just past his shoulders. I was able to get a description of the subject because I pulled into the same drive way the subject was leaving out of and my driver side door was roughly 5 feet away from his driver side door as we passed each other. Once I passed the vehicle I was flagged down by a older black male wearing a light colored t shirt with blue jeans who was standing outside of the gas station and appeared to be bleeding from his forehead. The citizen was pointing at the black chevy tahoe and yelling "right there!". The citizen did not seem in distress or shot, he was more concerned about pointing out the vehicle. I did not see it fitting to address the individual at that time and turn around to make a traffic stop on the black Chevy Tahoe. I did observe other squad cars approaching the gas station as I was leaving it and advised other responding squads to confirm the citizen who flagged me down was not shot. After the leaving the gas station I followed the vehicle Northbound on N. 27th Street from W. Lisbon Avenue. My lights and sirens (marked squad car) were fully activated at this time and the vehicle refused to stop. I observed the suspect vehicle pass another vehicle on the right in the bus lane just before W. Lloyd Street while on N. 27th Street. The suspect vehicle continued Northbound and increased his speeds to an even more reckless manor. The suspect then went westbound on W. Garfield Avenue from N. 27th Street, but only traveled a block before he went Northbound on N. 28th Street from W. Garfield Avenue where he disregarded a stop sign. The subject then continued Northbound on N. 28th Street until he went Westbound on W. North Avenue where he disregarded another stop sign. At this point speeds were reaching 70 mph and the suspect vehicle was 2 blocks ahead of me. We continued West on W. North Avenue until N.39th Street, but it should be noted that the suspect vehicle disregarded a red light at N. 35th Street and W. North Avenue with no hesitation what so ever. This intersection is a blind intersection and has accidents reported there all the time. So the fact that the suspect vehicle showed no regard through this intersection and went through it at an extremely reckless and high rate of speed showed me he had no regard for human life, Knowing this I had to slow down and show due regard at the intersection, once I made it through the intersection the suspect vehicle was at least 3 blocks ahead of me. The vehicle then went South bound on N, 39th Street from W. North Avenue, once I reached N, 39th Street and traveled South on it, I no longer had a visual of the vehicle and began to saturate the area for it. While doing so I

was notified by Squad 3341 P.O. Adam GONZALEZ and Jamiee WARNER that the suspect I was chasing may live in the area of N. 39th Street and W. Lloyd Street. Knowing this information I checked the alley ways near that intersection and located the vehicle at 2205 N. 39th Street in the rear. The vehicle stuck out because it was parked in the backyard on the grass with the windows open and doors unlocked. The vehicle engine was emitting heat as well as if it had just been used. Now being able to get a better description of the vehicle, it was indeed a black 2007 Chevy Tahoe bearing WI auto plate ADY-6809 with a VIN of 1GNF13057J222597. The plate given by Squad 3341 in their broad cast was the same plate on the Tahoe. While searching the near by area for the suspect, I observed vehicle keys to the Tahoe a short distance away, also in the back yard. I then stood by with the vehicle until Squad 9362 Detective Kenneth JUSTICE responded and informed me he would be assisting with the investigation. At this point it was determined that there was no shooting and it was a Armed Robbery Car Jacking. See Squad 9362's report regarding Armed Robbery Car Jacking portion under IR #19-176-0008. The B.P. Gas station had video of the incident and the clerk was very cooperative during the investigation. This incident occurred in the parking lot of the B.P.

BELLO and I were dispatched to a Theft Complaint at the BP Gas Station on 2624 W. Lisbon Avenue, located in the City and County of Milwaukee.

Upon arrival at the listed address at approximately 4:56 AM, we were met by caller/employee, later identified as Muhammad MATEEN (a/m, 05-28-92), who stated a black, 4-door Chevy SUV pulled up to the gas station at approximately 4:35 AM. MATEEN stated the Chevy parked on the south side of the gas station, on the east side of the main entrance door. MATEEN stated there were two occupants inside the vehicle, one unknown female and one unknown male. MATEEN stated the unknown male entered the gas station and grabbed approximately 6 frozen pizzas and 8 frozen dinners, totaling approximately \$90.00 USD, while the unknown female held the door open.
