On 04/21/19 at 10:00pm, PO David LETTEER and I (SQ#5468) observed a (B/F) woman who verbally identified herself as Ms. WATTS standing next to the front door with a holstered-pistol in the front of her waistband. WATTS was standing in front of posted signs stating "No Loitering". I asked WATTS if she was conducting business at the store. WATTS immediately became argumentative and was not answering simple questions. PO LETTEER exited our squad and began to explain to WATTS that the business does not want subjects standing in front of their business. WATTS stated that her family member Shemia WATTS (PS#011348) works at District 7 and informed her that she was allowed to carry a firearm in the manner she was. WATTS stated that her family member Shemia WATTS further informed her that if she gets stopped by the police and they ask if she is a valid CCW Permit holder to inform them that she was not. WATTS was argumentative and refused to understand our reason for speaking with her. WATTS stated that she was waiting for her boyfriend who was inside the store purchasing items.

At that time, the cashier identified Hardeep SINGH (W/M 10/10/97) came outside to speak with us. SINGH stated that he did not feel safe with WATTS standing with her gun in front of the store. SINGH asked PO LETTEER to inform WATTS to leave the property and never return with her firearm. PO LETTEER began to inform WATTS of the business's wishes, however WATTS continued to argue and stated she planned to file complaints on PO LETTEER and I.

PO LETTEER and I contacted the gas station owner Baljinder DHILLON (W/M 04/15/77) on 04/22/19 regarding our contact with the business. DHILLON stated that he was not aware of the situation and that he was thankful for our contact with WATTS and the store.

My name is _____ and I am addressing you in regards to the new Lounge 340 located at 340 E Reservoir Ave. in your district.

My Fiancé and I bought our first home at 1847A N Vel R. Phillips Ave. at the end of November 2018. My property is located across the intersection from the newly established Lounge 340. My fiance and I both work in the Aurora Advocate Health system and we chose the house we did because it was located in a quite neighborhood but still very close to all the amenities downtown has to offer without the noise from downtown.

Since the opening of Lounge 340 my life has been effected daily. The staff and owners of the property reached out with a letter to introduce the business to the neighborhood stating that their opening day would be Saturday March 2nd.

Thursday February 28th at 9:45 pm after trying to contact the owners about their noise level, I contacted the MPD and talked with Officer MacRae who handled the situation. Since then, the owners and I have built a relationship that I respect, and I sincerely believe they are trying to run a great business and respect the neighborhood they are in.

Since opening, I have personally contacted Kamesha about noise 4 times and she has either turned down the music or said it was somebody parked outside the bar with loud music playing in their car.

This is where my problem begins, The property has no parking lot. So

the patrons of Lounge 340 park outside my house before, during, and after business hours. The once quiet neighborhood has now turned into cars with loud music, people hanging out outside the bar being loud, and most importantly leaving the bar and sitting outside their car talking/yelling/ arguing at all hours of the night. On multiple occasions I have witnessed patrons smoking marijuana in their cars right outside my residence and I have also noticed more alcohol related litter around my residence. So far only once I have had to go outside and tell 3 intoxicated women to please be quiet and go home, which was at 2:45am on a Wednesday night.

I have been in contact with Officer MacRae on how to do my part as a homeowner in your district and here I am contacting you. Officer MacRae told me that vehicles parked out front of my residence are out of the scope of the bars control. I could understand this situation if I lived downtown but not in a residential neighborhood.

Alderman Coggs, My fiancé and I work at early hours in the morning. We are 25 years old and have worked very hard to afford the home we have. I will continue to have a respectful relationship with Lounge 340 as long as they continue to respect the neighborhood. I ask that you review my thoughts and concerns and take into consideration the location of this establishment when reissuing a license. This quite residential neighborhood is not a place for a bar, especially a bar that doesn't offer a parking lot to control its patrons in a quite residential neighborhood.

I tried leaving a voice mail last night around 11:45pm and today but the phone hangs up not allowing me to leave a voicemail message after the phone greeting.

Last night the neighbor Garrick across the street from Lounge 340 informed security he caught someone urinating on the side of his garage. Security informed him that the individual wasn't a Lounge 340 customer. Security tried to get Garrick to identify this individual but Garrick couldn't provide witness of the individual. Security stated no one was outside at that time.

Garrick had thanked security for the cars being parked at the YWCA and not in front of or around his residence. They shook hands and Garrick told security to keep up the good work.

The staff at Lounge 340 parks on the side of his residence and cones are placed in front of his residence so no one else can park in front. Garrick stated that was a great idea and agreed to the change.

Maybe 45 minutes after security spoke with Garrick the MPD (Officer Brandt and another Officer from district 3) arrived on 4/13/19 at 11:09 pm for a loud noise ordinance, the smelling of marijuana, customers hanging around his house and I believe for being over capacity.

Patrice and myself were present and provided all the necessary paperwork the Officers requested. The Officers found all allegations to be unsubstantiated. The officer stated when they pulled up they couldn't hear the music from the lounge at all, but every day we're opened Garrick is sending text messages to me asking me to turn the music down. We haven't had a DJ in April intentionally to see if we would get complaints from the neighbor, as we are trying to build a genuine relationship with Garrick.

On Friday April 13, 2019 around 10pm Garrick texted and asked me to turn the music down. I informed him the music wasn't loud and we don't have a DJ, and that we are playing music from the Juke Box.

I went personally in the middle of the street immediately after I was texted to see if I could hear the music and was unsuccessful.

There have been times when the neighbor Garrick has stated his walls are shaking in his house because of the music from Lounge 340. I find that to be impossible when 95% of the time we are playing music from the Juke Box.

On Friday his complaint was he could hear everything from customers that stand out side to smoke and the security. That people were yelling down the street or laughing having conversations. I informed Garrick unfortunately we can't determine when a customer is talking loud or yelling down the street, however, we correct all situations as it relates to the noise immediately.

I informed the neighbor I would have the customers effective immediately smoke towards the rear of the building vs. standing in front of the building. That maybe this could prevent him hearing everything. I'm questioning if Garrick is sitting in the window or intentionally observing everything that takes place at the Lounge.

I informed Garrick on Friday when he requested that I turn the music down because it was loud, that the Lounge now seems like we were at the library. Garrick took that as sarcasm and became upset but I explained to Garrick that comment was me laughing to keep from crying.

Lounge 340 has bent over backwards trying to accommodate all his requests and try to establish a genuine relationship with everyone in the area.

It's ironic that Garrick is the only neighbor that has complaints about noise, security, and the customers.

Everyone in the area have Patrice and I contact information to inform us of any issues or concerns they might experience and we haven't received one complaint yet. The neighbors in the surrounding areas are actually supporting the lounge and providing feedback that they are excited to have the Lounge in the area.

The management and staff at Lounge 340 are questioning if we are being harassed by the neighbor Garrick. Garrick doesn't want a Lounge in his neighborhood. What I've discovered is every time Garrick text my phone he also emails City Hall when I've been under the impression that Garrick contacts the owners to resolve issues so he tells me and we immediately take care of Garrick's complaints to ensure all is well.

We will continue to be respectful neighbors and try to accommodate his request immediately.

I'm requesting info on a Police Liasion, or a Tavern Squad as we are starting to cry for help as we need additional assistance as we want to protect our investment.

In closing Lounge 340 has been a laid back environment where working class individuals have been patronizing the establishment and we haven't had any issues of violence in our almost 45 days of business.

We will have to stay prayed up regarding this situation in hopes we can create a peaceful environment for all parties involved.

Phillips Ave. MORGAN stated that he was inside his residence and could hear the music from the bar located across the street clearly/audibly from inside his residence which was disturbing his sleep/well being. MORGAN stated that it was shaking his windows. MORGAN continued stating that he had attempted to contact the tavern owners directly but was unable to. MORGAN stated this is an on-going problem with his tavern since it has been open and he will continue to call to be a complainant when the music is in excess. This report is written by PO David LETTEER, assigned to District 5 Late Power Shift, Sq. 5468 Tavern Squad.

On 10-25-19 at 11:34 p.m., my partner PO Russell MACRAE and I were dispatched to the location of 340 W. Reservoir Ave., Lounge 340, which is a licensed premise in the city of Milwaukee, for a noise nuisance. The caller Garrick L. MORGAN (w/m 02-19-94), who resides at 1847 N. Vel R. Phillips Ave., initially called the police at 9:47 p.m., stating that the bar is playing loud music and the patrons are being very disruptive. The caller was also willing to be a complainant for the noise. PO MACRAE and I were dispatched at 11:46 p.m. to the bar to investigate the noise complaint.

PO MACRAE called MORGAN and was informed that the music problem was going on throughout the night and that he could hear and feel the bass inside of his home. He stated he attempted to contact the bar regarding the music, but received no response.

Upon our arrival we parked our marked squad just to the east of the bar, on the south side of the street, in an alley and we also parked our squad to the south of the bar and listened for music. Initially we could hear the sound of bass coming from the bar, but once we were observed by the bar, the bass was turned down. As we continued to listen for the music, when the door to the bar was open, we could hear the music playing until the main door was closed.

As we were listening for the music, I observed Patrice DICKERSON (b/f 03-27-79) the agent of the bar standing outside. PO MACRAE and I spoke to DICKERSON who stated she was having a birthday party and that her music may have been loud. She stated when she realized it was too loud, she had the music was turned down. DICKERSON stated she was playing her jukebox tonight and did not have any other form of music playing tonight.

We informed DICKERSON that her neighbor had called the police and wanted a citation issued. DICKERSON stated we could drop the citation off at the bar and she would take care of the the citation. I asked DICKERSON if she had an upcoming court date for a noise citation and she stated she did, on 11-26 -19 for a noise related citation that PO MACRAE and I issued her in May of this year. While at the bar, we observed 5 vehicles parked across the street on the south side of the street, parked in a no parking zone. We have had discussions with DICKERSON in the past about people parking in no parking zones and that

while open, her security would make sure that people would not park in no parking zones around the bar.

On 10-30-19 I contacted MORGAN and asked him why he wanted a citation issued. He stated the bass from the bar was loud and that he had texted Kameshia, the Class B Manager of the bar, of the noise level. MORGAN stated he was texting her to let her know that the music needed to be turned down, but that he never received a reply from her. MORGAN stated he could hear and feel the bass inside of his residence, which is just across the street from the bar. He went on to tell me that things are good for a while, then things get bad to where he has to call the police to take care of the noise complaint.

MORGAN stated he could not go to sleep, but when he could fall asleep, he was woken up to the music from the bar and the main entrance door being open and closed. MORGAN stated normally security is outside, attempting to control what his being heard or seen outside, but since it has been getting cold, the security is staying inside of the bar. He also stated since it has started to get cold, that he can hear the people outside talking and yelling at each other more than he could when it was warm outside. MORGAN informed me that he does not want to keep calling on the bar, but if the noise is disruptive for him, he will have to.

I issued citation J980T6RP6Q to DICKERSON for Excessive Noise Prohibited (80-63-1), with a court date of 12-26-19 at 8:30 a.m. I advised MORGAN that if DICKERSON wished to contest the citation, he would receive a subpoena for a future court date.

Concordia Ave., when we observed several vehicles still parked in front of Green Ring II Liquor Store. We parked our marked squad car across the street from the store and observed the store. As we were sitting there, a black male had entered the store and exited shortly after. PO MACRAE and I were watching the clock on our squad computer and when the clock turned 9:00 p.m., we went out with a business check.

As we went out with our check there were 3 vehicles parked in front of the establishment. PO MACRAE attempted to enter the store, but the business agent, Isaac T. RAGSDALE (b/m 09-03-71) walked into the foyer and locked the front entrance door in front of him, so that PO MACRAE and myself could not enter the building, it appeared that in doing this, that RAGSDALE was in a hurry. RAGSDALE eventually let us inside of the store.

As we were inside of the establishment, there were 3 black males standing inside of the store, not doing anything. One of the individuals in the store, Davie J. STEWART (b/m 01-10-70) stated he was the "security" for the store and started at 2:00 p.m. PO MACRAE asked RAGSDALE when he hired the security and he stated 3 weeks ago. PO MACRAE asked if STEWART was licensed. STEWART stated he was working to make sure that people were not getting out of control.

The next individual was Ronnie L. PROPHET (b/m 05-12-71), who stated he was working at the store as a stocker and started work at 3:00 p.m. I then spoke to Jake K. COOK (b/m 09-29-88) who stated he was at the store working and helping on his spare time. As we were speaking to the 3 individuals, RAGSDALE then began getting upset, telling us that we were harassing him. He then stated that we were harassing his sister at Stewarts Bar. PO MACRAE then informed RAGSDALE we were investigating having people in the establishment at and after 9:00 p.m.

RAGSDALE stated we were the harassing him again. We did not know what he meant by this, but he went on to tell us that we were doing nothing but harassing the black owned stores and not harassing the "Arab Stores", he stated this at least twice. RAGSDALE stated that he felt PO LETTEER and I were being racist by conducting inspections at his location. I informed RAGSDALE that the constant people loitering in/outside of his store causing police's attention and due to recent homicides/shootings in the general area the police are in the area.

I conducted a wanted check of the 3 individuals and we let them leave the establishment. PO MACRAE informed RAGSDALE that we would be filing this report and issue a citation. While speaking to RAGSDALE, PO MACRAE asked him what he was doing about the loitering outside the store. We informed him that he had signs posted, but RAGSDALE asked us, what is he supposed to do about people loitering, due to him being the only one working at the store? RAGSDALE then stated to PO MACRAE that he had two workers in the store at and after 9:00 p.m. and another guy who was stuck in the store, who could not leave due to the police.

We left the establishment and eventually looked at when the last time the police were at the store. On 05-04-19 LIU was there, with 16 and 17 year old individuals, who were able to purchase a black and mild, even though under age to buy and possess tobacco.

Upon a check of the current license for the establishment, the current Class A Malt and Class A Liquor License is set to expire on 03/03/20.

- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
