No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. All,

On Saturday night/Sunday morning Squad 4237 along with 4460 (PO SCHLICKE, PO HANSEN), 4440 (PO BEATTIE, PO MAJEED), 4484 (PO CONNELL) and 4210 (SGT PANFIL) were assigned to monitor the special event at Kiss Ultra Lounge (7330 N 76th Street) where Milwaukee famous rappers Gwapo Chapo, Loonie Baby, and other affiliates would be performing.

To start out the night the parking lot management was unorganized and caused multiple vehicles to stop on N 76th Street and at some points block all northbound traffic. This created an unsafe environment and officers on scene had to step in multiple times to conduct traffic and keep the road clear. Squads addressed the lot attendants and advised them multiple times that cars could not block the street, which continued to happen. There was only one attendant assigned to the lot entrance who was unable and unwilling to keep up with the amount of traffic flowing in.

At approximately 1:06 AM subjects exited the club and stated that there were shots being fired inside. The following is an excerpt from my report regarding:

"On Sunday, July 7, 2019, at approximately 1:06 AM, while monitoring Kiss Ultra Lounge, 7330 N 76th Street, City and County of Milwaukee, Wisconsin, I was made aware via radio broadcast that a subject was possibly inside of the club shooting, per citizens leaving the club.

I observed multiple subjects running from inside out of both north side exit doors. The subjects were exiting in an extremely unorganized manner, running over each other and falling to the ground. It was not possible to gain entry to the club immediately to clear the inside, as officers would likely have been trampled over by the crowd. It was apparent that multiple subjects were caused to fear for their safety and be alarmed due to the unknown actor's actions.

Once officers were able to safely gain entry we cleared the club and did not observe any victims or evidence of shots fired. Multiple subjects stated to police that they heard a single firework go off near the dance floor.

I interviewed Christopher J HILL who was in the DJ booth in the main dance room, where the alleged firework went off. The DJ booth at Kiss is elevated and provides a view overlooking the dance floor. HILL stated he observed what he believed was a firework lit in the crowd, and then heard a "pop". HILL stated he did not see any firearms, nor did he believe it was a gunshot."

Report was filed as a Disorderly Conduct with an unknown actor, as there was no evidence of gunfire. A licensed premise report was also filed. The club closed early for the night as a result of the incident.

3. On 04/25/2015 Milwaukee police, along with a representative from the Department of Neighborhood Services, and agents from the Wisconsin Department of Revenue, conducted a licensed premise check at 7330 North 76<sup>th</sup> Street. During this check, it was discovered that the person working behind the bar, Shakira Loggin, does not have a valid Class D operator's license. 2 bottles of alcohol, 5 containers of tobacco and 4 cash register receipts were confiscated by state agents. The applicant was cited for Responsible Person on Premises Required.

- 4. On 07/26/2015 Milwaukee police responded to an accident at 7330 North 76<sup>th</sup> Street. Investigation revealed that a subject employed as security for the business (The Kiss Ultra Lounge) was helping to break up a fight when he was struck by a vehicle.
- 5. On 09/06/2015 at 2:15am Milwaukee police were monitoring Kiss Ultra Lounge (7330 North 76<sup>th</sup> Street) when they observed a male patron punch a female patron in the face. The male patron was arrested and issued a citation for assault and battery.

Item #3 previously reported, disposition added 11/11/2016.

- On 11/07/2015 Milwaukee police, who were assigned at Kiss Ultra Lounge, overheard patrons talking about a fight inside the tavern. One of the involved parties was cited for disorderly conduct.
- 7. On 11/29/2015 Milwaukee police were dispatched to a tavern check at 7330 North 76<sup>th</sup> Street (Kiss Ultra Lounge). While in route, officers were advised to hasten their response as several patrons had become unruly and disorderly. Moments later, squads began broadcasting that several gunshots had been fired in the area of North 76<sup>th</sup> Street and West Clinton Avenue. Employees of the business told officers that security had broken up a fight inside the bar and escorted the involved patrons out. The fight continued in the parking lot until security intervened. Moments after the involved subjects dispersed, several shots were heard. No additional evidence, complainants or witnesses were discovered.
- 8. On 12/06/2015 Milwaukee police were monitoring Kiss Ultra Lounge (7330 North 76<sup>th</sup> Street) when security notified them that several patrons were involved in a fight inside the business. Three subjects were cited for disorderly conduct. 8 Milwaukee police squads, in addition to the squad that had been monitoring, along with 2 Milwaukee police supervisors responded to assist in controlling the situation.
- 9. On 12/12/2015 Milwaukee police met with the applicant to address incidents that had occurred at Kiss Ultra Lounge recently. The applicant stated the following actions would be taken:
  - Both exits at the front of the business will be utilized.
  - The patio door will also be used as an exit for patrons.
  - Security gates will be set up in the parking lot.
  - An armed roaming security guard will be added.

Additionally, cameras have been installed at the entrance and inside the venue and two members of the security staff that had been doing a substandard job had been terminated and replaced.

- 10. On 01/08/2016 Milwaukee police met with the applicant regarding recent incidents at Kiss Ultra Lounge. The applicant stated that she had been hiring two off duty officers for Friday and Saturday evenings, but these officers had recently stopped coming. She asked that officers be notified and trained on how to sign up for this work detail. She further stated she had fired two security guards and she was willing to work with Milwaukee police in keeping her establishment safe.
- 11. On 01/10/2016 Milwaukee police were flagged down regarding a trouble with a subject complaint at 7330 North 76<sup>th</sup> Street (Kiss Ultra Lounge). Officers were told there had been a dispute inside the business and the involved parties were removed from the premises by security. These parties continued to argue in the parking lot of the business until security intervened along with Milwaukee police. The involved parties later cooperated with security and left the area. The officer reports that business staff was very cooperative and helpful.
- 12. On 02/07/2016 Milwaukee police were flagged down regarding a fight inside Kiss Ultra Lounge (7330 North 76<sup>th</sup> Street). Investigation revealed a patron of the business had been involved in a fight. Security for the business intervened and detained the subject until police arrived. This subject lied about his identity and threatened to "air the club out". This subject was arrested. During this encounter, Milwaukee police became aware there was a pending battery complaint that occurred at 76<sup>th</sup> and Mill Road. The officer responded to St. Joseph's hospital to investigate. The officer spoke to Brittany Morton who stated she had been a patron of Kiss Ultra Lounge (7330 North 76<sup>th</sup> Street) when she and a former friend got into a fight. One of the involved parties was struck in the head with a glass sustaining an injury to her head. Milwaukee police incident report #160380036 was filed.
- 13. On 02/13/2016 Milwaukee police were dispatched to St. Mary's hospital for a battery that occurred at 7330 North 76<sup>th</sup> Street (Kiss Ultra Lounge). The victim states she had been involved in a fight while in the main room of the bar. She sustained an abrasion to her forehead. Milwaukee police incident report #160440026 filed.
- 14. On 04/10/2016 Milwaukee police, who were working a special assignment at 7330 North 76<sup>th</sup> Street (Kiss Ultra Lounge), were asked by security personnel to assist with removal of a group of individuals from the business's parking lot. Officers discovered a group of approximately ten subjects in a circle fighting in the rear parking lot. These subjects scattered as officers approached which revealed a male lying on the ground bleeding from the head. This subject received medical attention from Milwaukee Fire Department Engine #39. The subject refused to speak to officers and walked away. Milwaukee police incident report #161010016 filed.

15. On 11/20/2016 officers responded to Kiss Ultra Lounge, 7330 N. 76<sup>th</sup> St for a Trouble with Subject complaint. The officers observed a subject holding open the door arguing with security. The subject was intoxicated and refused to pay the cover charge because he stated he paid for a VIP area. The subject did leave without incident. Security was cooperative and no violations were observed.

- 16. On 12/04/2016 at 2:05am officers were observing closing time at Kiss Ultra Lounge, 7330 N. 76<sup>th</sup> St. Patrons advised the officers that there were several people who were about to fight. The officers observed a subject yelling in another patrons face and that he was preparing to strike the patron. The subject was causing a disturbance and was cited for Disorderly Conduct.
- 17. On 04/02/2017 at 2:20am officers were monitoring traffic at Kiss Ultra Lounge, 7330 N. 76<sup>th</sup> St. The officer observed a group of 30 subjects surrounding a car. The car had a broken windshield and fled when the officer approached. The officer observed a subject carrying a large wooden table leg. The subject was arrested after a short foot chase. The manager, Craig BERRY, was cooperative and would press charges on the subject.
- 18. On 10/01/2017 officers received a call from Kiss Ultra Lounge that they were needed for trouble with subject. Upon arrival security was pointing at a subject in the parking lot stating that the subject had a gun. The officers stopped the two subjects by the car security was pointing at and recovered two firearms from the ground by the subjects. The manager, Craig BERRY, stated that he observed one of the subjects walking back and forth outside with a gun in his hand. Video surveillance was recovered which depicted the incident. Both subjects were arrested and no other violations were observed in the tavern.
- 19 The applicant has the following past due owed to the Milwaukee Police Department:

- 20. On 08/26/2018 officers were dispatched to Kiss Ultra Lounge, 7330 N. 76<sup>th</sup> St, for a traffic hazard. The officer observed several cars stopped on N. 76<sup>th</sup> St waiting to get in the lot. The officer was advised the lots were full, because there was live music that would end at 2:30am. The traffic was cleared and the officer monitored the scene. At 2:00am the show let out, and two females began fighting in the lot. Security broke up the fight and the manager stated he was closing for the night. The officer did not observe any violations inside the business and the management was cooperative.
- 21. On 11/01/2018 officers were dispatched to 7330 N. 76<sup>th</sup> St to investigate a battery complaint. The officers spoke with the victim, Marissa MARTIN, who stated she worked at the tavern and was walked out of the business by the manager, Otis MOORE. MARTIN stated MOORE got into a verbal argument with her and called her profanity. She stated he pushed her against her car. She stated she then asked for her last pay check because she was not going to work there anymore. MOORE stated he did walk her to her car because they walk all female employees to their cars. He stated he did not push her against her car and stated that there were words exchanged because MARTIN saw him with another woman. MARTIN did not want to prosecute.
- 22. On 12/21/2018 officers conducted a licensed premise check at Kiss Ultra Lounge, 7330 N. 76<sup>th</sup> St. regarding their plans for New Years Eve. The officers spoke with a security guard who stated the business would be open all night and would have 22 security officers working.
- 23. On 12/24/2019 a subject notified police that on 12/23/2018 he was in his car at Kiss Ultra lounge when he observed his friend in an altercation with security. The subject stepped in,

separated his friend from security and drove him home. While doing this his pistol fell out of his pocket and was left behind at the bar. The subject went back on 12/24/2018 to speak with security about the missing firearm. Security stated they turned a gun over to the owner of the bar. The officer went to the bar, recovered the gun and placed it on inventory.

- 24. On 05/11/2019 at 9:13pm officers were dispatched to a subject with gun complaint at Kiss Ultra Lounge. The officers were advised by dispatch there was approximately 200 juveniles fighting as well as shots being fired. Upon arrival officers spoke with security, who stated there was a Sweet 16 party going on that ended at 8:30pm. Security stated as they were shutting the party down when 2-3 females began fighting in the parking lot. During this time a vehicle drove by on N. 76<sup>th</sup> St, with a male sitting out the window holding a gun. This subject then discharged the gun 6-7 times. The co-owner of Kiss, Marc BROWN, was on scene and cooperative with the officers.
- 25. On 05/20/2019 at 2:10am officers were dispatched to a shots fired call at 7330 N. 76<sup>th</sup> St. The officers located 13 casings in the roadway in front of Kiss Ultra Lounge. The officers spoke with security-who stated at 2:00am he observed an argument in the parking lot between two individuals. The subjects stopped arguing and walked to a vehicle. The security guard went inside when the subjects separated and got into cars. After entering the building and the security guard heard gun shots outside and west of the location. The guard did not see who fired the shots. The officers checked the security cameras but they did not cover the roadway where the shots were fired.
- 26. On 07/07/2019 at 11:00pm officers were assigned to monitor a special event at Kiss Ultra Lounge, 7330 N. 76<sup>th</sup> St. The officers observed autos attempting to get in the parking lot blocking traffic on N. 76<sup>th</sup> St. The attendant assigned the lot entrance appeared unable to keep up with the amount of traffic entering the lot and the officers stepped in to get traffic flowing again. At 1:06am the officers were advised of possible shots fired inside and they observed a large amount of subjects exiting in an unorganized manor, running over each other. When the officers were able to safely enter they did not find any victims or any evidence of shots being fired. They spoke to the DJ who stated he observed a firework being lit in the crowd and heard a single pop, he did not see any firearms. The club closed early as a result of the incident.

This License Premise Report was typed by P.O. Ralph MCCLAIN, assigned to Squad 4374, District Four, Late Shift. On Monday, December 24th, 2018, at 12:05 am, I received a phone call at District Four from a subject that identified himself as Derrick D. CLARK, b/m, 11-19-93. The subject stated he arrived at Kiss Ultra Lounge (7330 N. 76th St) on Sunday, December 23rd, 2018 and observed the bar's security and his friend in a heated exchanged. CLARK stated he quickly exited his vehicle and went to intervene. CLARK stated that as he approached the front of the bar, the security grabbed his friend. CLARK stated he stepped in between the security and his friend and in the process, his black and silver Smith and Wesson SD40 VE 40 Caliber semi-automatic pistol fell out of his right pocket. CLARK stated that he did not notice that his firearm had fell out at that time. He stated that he grabbed his friend and put him into his vehicle and drove away from the bar.

CLARK returned to the bar on Sunday night, December 23rd, 2018 and spoke to a security regarding his missing firearm. Security stated that they had turned the firearm over the owner. I conducted a brief follow up with the bar and spoke with the security personnel who stated they did have a firearm in their possession that was taken in the incident where a patron was escorted out of the bar for being disorderly.

CLARK stated that he had CCW permit but that it may be expired. A check of the NCIC system revealed that CLARK did not have a permit to carry a weapon. It should be noted CLARK stated his first name is spelled "Derrick". CLARK came back in the DOT and NCIC system as "Dedrrick" (same date of birth).

CLARK's firearm and accessories will be inventoried as safekeeping and sent to the B of I division for DNA, fingerprints and to be fumed. Inventory # 18047320 and 18047322.

Additional follow-up will be conducted to obtain a statement for those present during the incident on December 23rd, 2018. There will also be a check for possible video footage.

This report was written by PO Jason DAERING assigned to District 4, Late Power Shift, Squad 4485 with PO Shane BISHOP. On 5-11-19 at 9:13PM, PO BISHOP and I responded to a subject with gun complaint at the location of N. 76th St. and W. Good Hope Rd., later identified as being 7330 N. 76th St. (Kiss Ultra Lounge) within the City and County of Milwaukee. It was while en route that District 4 Dispatcher did notify responding squads that there were approximately 200 juveniles that were fighting as well as having guns and shooting.

Upon arrival, I spoke with the Owner/Operator of the security at Kiss Ultra Lounge. The subject was identified as Jieire A. VANCE(B/M 6-24-84). The name of the security outfit was Guarantee Protective Services with a phone #(414)397-8828. VANCE stated that there was a "Sweet 16" party at the location, which does have a posted 674 person capacity limit. The name of the party was "Kennedi's Sweet 16" "Big Drip" which was evident by the banner located on the exterior wall of Kiss Ultra Lounge's northeastern most entranceway. With regard to the capacity, VANCE did not know how many juveniles were at the party as it was not monitored, however, it did appear to exceed 100 by the amount of juveniles walking southbound on N. 76th St. towards W. Good Hope Rd. while PO BISHOP and I were arriving on scene initially.

VANCE stated that the event was slated to end at 8:30PM and while he and his employees started to shut the party down and escort the party to the parking lot, he stated that a verbal, turn physical fight did break out in the parking lot between 2-3 females. During this fight, he and his security team started to intervene and escort some of the involved parties off premise. It was during this time that, according to VANCE, that a tan Audi or Infiniti 4dr auto with unknown registration plates did travel northbound on N. 76th St. from having come from the area of W. Good Hope Rd. While this vehicle was traveling north on N. 76th St., VANCE stated that he observed an unknown light complexion black male sitting on the sill of the exterior rear passenger side window. This subject sitting outside the window, while passing Kiss Ultra Lounge, proceeded to discharge 6-7 shots from a firearm. The vehicle proceeded north on N. 76th St. until out of sight.

After speaking with VANCE, I obtained the Public Entertainment Premises License(PEP-0005599) as well as reviewing the Class B Tavern License(BTAVN-0206813) with expiration 1-21-20 and Class D Operators License(BART-0230140) with expiration 12-31-20. The owner/partner of Kiss Ultra Lounge, identified as Marc A. BROWN(B/M 4-5-70) was on scene and cooperative.

On Monday, May 20, 2019 at approximately 2:10am, my partner PO Matthew BOUZEK, and I, while on Squad 4340 were dispatched to a shots fired complaint at the address of 7330 N 76th St., which is located in the City and County of Milwaukee.

Upon arrival I observed 13 spent casing scattered on N. 76th Street located in front of Kiss Ultra Lounge (7330 N. 76th St). I spoke to the security guard identified as Theron T. ROGERS (M/B, 06-05-1985) who stated at approximately 2:01am, an argument started between unknown subjects located in the parking lot. The unknown subjects then stopped arguing and walked to an unknown vehicle. ROGERS stated he entered back into the business and proceeded to hear multiple gunshots to the west of the location. ROGERS stated the police were then called. ROGERS stated he didn't observe anyone discharge a firearm nor seen any physical altercation while he was outside.

I reviewed the video from the tavern and was unable to observe any vehicles that may have been involved or any potential suspects. The video surveillance does not show the road way where we located the spent casings.

I canvassed the area and did not locate any victims with any injuries.

On Saturday night/Sunday morning Squad 4237 along with 4460 (PO SCHLICKE, PO HANSEN), 4440 (PO BEATTIE, PO MAJEED), 4484 (PO CONNELL) and 4210 (SGT PANFIL) were assigned to monitor the special event at Kiss Ultra Lounge (7330 N 76th Street) where Milwaukee famous rappers Gwapo Chapo, Loonie Baby, and other affiliates would be performing.

To start out the night the parking lot management was unorganized and caused multiple vehicles to stop on N-76th Street and at some points block all northbound traffic. This created an unsafe environment and officers on scene had to step in multiple times to conduct traffic and keep the road clear. Squads addressed the lot attendants and advised them multiple times that cars could not block the street, which continued to happen. There was only one attendant assigned to the lot entrance who was unable and unwilling to keep up with the amount of traffic flowing in.

At 1:06 AM, while monitoring Kiss Ultra Lounge, 7330 N 76th Street, City and County of Milwaukee, Wisconsin, I was made aware via radio broadcast that a subject was possibly inside of the club shooting, per citizens leaving the club.

I observed multiple subjects running from Inside out of both north side exit doors. The subjects were exiting in an extremely unorganized manner, running over each other and falling to the ground. It was not possible to gain entry to the club immediately to clear the inside, as officers would likely have been trampled over by the crowd. It was apparent that multiple subjects were caused to fear for their safety and be alarmed due to the unknown actor's actions.

Once officers were able to safely gain entry we cleared the club and did not observe any victims or evidence of shots fired. Multiple subjects stated to police that they heard a single firework go off near the dance floor.

I interviewed Christopher J HILL (B/M 09-29-1985) who was in the DJ booth in the main dance room, where the alleged firework went off. The DJ booth at Kiss is elevated and provides a view overlooking the dance floor. HILL stated he observed what he believed was a firework lit in the crowd, and then heard a "pop". HILL stated he did not see any firearms, nor did he believe it was a gunshot."

Report #19-188-0024 was filed as a Disorderly Conduct with an unknown actor, as there was no evidence of gunfire. The club closed early for the night as a result of the incident.

Brown Deer Road, which is located in the city and county of Milwaukee WI. Upon arrival, at 2:22 PM we were met by caller and complainant Roderick J. JOHNSON who stated that the store owner "pulled a gun on me and my nephew because I was ten cents short on my purchase." A large group of other people was on scene as well, including "King Rick" of the local chapter of the Black Panthers to voice their support for JOHNSON.

#### INTERVIEW OF MAHMOOD

The store was operated by Hamid MAHMOOD (W/M 10/13/1959 3838 S. Kinickinic Ave, St. Francis WI 53235. 414-202-7866 He stated that at 11:45AM, JOHNSON and a small child were in the store and he was buying a "Swisher" style cigar wrapper. MAHMOOD stated that JOHNSON was ten cents short of the total amount, but JOHNSON already had possession of the cigar wrapper before he finished counting the change. MAHMOOD stated he told JOHNSON he was ten cents short, but JOHNSON began walking away. MAHMOOD stated he said "This is not the way this works buddy," and then an argument about lack of money began. MAHMOOD noticed the child with a candy bar in his hand and MAHMOOD told JOHNSON to pay for the candy or put it back. MAHMOOD stated that he and JOHNSON began arguing and using profanity towards each other at which point he asked them to leave the store. JOHNSON and the child began to exit the store when JOHNSON threw the candy bar behind his shoulder and exited the store. MAHMOOD said that JOHNSON then came back into the store with the child and JOHNSON stood in the door way while the child retrieved the candy bar from the floor, picked it up, threw it again on the floor and stated "Suck my dick." MAHMOOD stated that JOHNSON stated "I should start tearing up your whole store right now." At which point MAHMOOD stated that he retrieved a 9mm Beretta from a cabinet behind the counter and placed it in his right pants pocket. He then came out from behind the cash register room and approached the exit of the store where JOHNSON was standing. He told JOHNSON "no, that's not going to happen, you need to leave the store now." MAHMOOD stated that he then pulled the pistol from his pocket and kept it at his side with the muzzle facing down, and continued to order JOHNSON to leave the store. JOHNSON and the child then left the store. MAHMOOD stated he feared his merchandise was going to be destroyed and damaged and he was going pick up the candy bar and lock the door after JOHNSON left.

#### INTERVIEW OF JOHNSON

Roderick J. JOHNSON (B/M 12/8/1982 7661 N. 78th street unit three, 53224 414-346-6162) stated that he knew he was ten cents short for the cigar wrapper and said the clerk (MAHMOOD) was aware of this and he always pays him back later when he is short of money and he is a regular customer. He said his nephew was looking at the candy and not stealing it. He stated he argued with MAHMOOD because he was using racial slurs and making derogatory comments towards him. He stated that MAHMOOD came out from behind the security glass and racked a gun in the direction of his nephew. JOHNSON stated he did not call police at the time of the incident (11:45AM) but went home and "Googled the Black Panther's information because the incident was bothering him and he couldn't let it go because a gun was pulled on me and he called me racial slurs." Johnson then returned to the store around 2:00 PM with a large group of individuals.

On Tuesday, July 9th, 2019, Squad 4240 (P.O. Ryan WEBB and myself, in full duty uniform and operating a marked MPD vehicle) was dispatched to 6330 W. Silver Spring Dr. for a "battery" complaint. This address is located in the City and County of Milwaukee, WI.

Squad 4240 arrived on scene at approximately 4:39 PM. Upon arrival, I interviewed victim and reporting person Baljinder SINGH (a/m, 04/17/81). The following is a synopsis of my interview of SINGH. For the full interview, refer to my Axon Body Camera footage.

SINGH stated that he has had trouble with subjects coming into the store in the past and taking items. SINGH stated that on this date, 3 suspects had taken items from the store without paying for them. SINGH stated that one of the subjects had thrown candy at him and had hit him in the left side of his face. SINGH refused medical attention.

SINGH showed me the video surveillance of the store, and recognizes these subjects from around the area. The following is the approximate timeline of the video. (It should be noted that the displayed camera time is 1 hour fast relative to real time). SINGH was on the telephone with license holder and owner Balvir SINGH (a/m, 10/01/62) at this time for the camera, and was so notified.

4:35 PM, Suspect 1 enters the store for the first time. Suspect 1 can be seen throwing items at SINGH. 4:38 PM, Suspects 1,2,3 enter the store. Suspects can be seen taking items from the shelves.

Suspect 3 is a black male, approximately 16-21 years old, wearing a blue hooded sweatshirt, black pants with a silver stripe, and a white t shirt.

SINGH informed me that the Items taken were Now and Later brand candy, Beef Jerky, and "Honeybuns" (pastries) worth a total approximate retail value of \$50.

I issued SINGH a PV-17 regarding this investigation.

P.O. WEBB and I searched the surrounding area but did not locate anyone that matched the description of the suspects.

This case is pending.

It should be noted that business agent and licensed person / premises were cooperative with police.

Suspect 3 remained outside of the store during this incident.

All suspects then fled eastbound on W Silver Spring Dr.
