



# Sign specifications

The RWB sign will have a routed face with clear push thru RWB letters with translucent white vinyl that is printed in a red scatter pattern.

The Buckhead sign will have a routed sign face (letters and logo) backed with translucent white polycarbonate and translucent vinyl graphics.

Both signs are internally illuminated with white LEDs

One (1) Round - 48\* Dia. x 5\* Deep Sign Cabinet, LED Internally Illuminated, with push-thru clear acrylic "RWB" face decorated letters. Secondary Graphics are Opaque and do not illuminate.

One (1) Oval - 56"long x39" high x 5" deep Sign Cabinet w/CNC Routed Lettering / Logo Area, backed with White polycarbonate that has applied translucent graphics to the logo area. Complete cabinet is InternallyIlluminated with White LED's.
