This report is written by PO David LETTEER, assigned to the District 5 Tavern Squad. On 10-31-18 I was assigned to Sq. 5448 with PO PESQUEIRA. At 11:40p.m., we responded to the 2800 block of N. 27th St. for a Milwaukee Police Department (MPD) chase involving a white 4-dr. Nissan Altima, which crashed into another vehicle. The other vehicle was a Yellow Taxi #739. The vehicle was a 2009 Ford Crown Vic, bearing WI plate 818-XYP.

The taxi was driven by Devione J. SADDLER (b/m 06-04-94), who has a valid Public Passenger License (DRN 207217). His taxi was occupied in the rear passenger seat by Maliyahia NESLON (b/f 12-01-96) and Donta T. IETER (b/f 06-27-15).

Based on watching the squad camera, the taxi was traveling southbound on N. 27th St. in the 2800 block, entering the 2700 block, as the Altima was traveling northbound on N. 27th St. entering the southbound lane, in order to get around a truck that was in front of the Altima, in the attempt to evade police who were involved in an active pursuit of the Altima. As the Altima swerved around the truck, the vehicle drove into the southbound lane, sideswiping the taxi at 2773 N. 27th St., causing the taxi to spin around and causing the driver's side rear wheel to come free of the vehicle and come to a rest in the intersection of W. Hadley St. and N. 27th St., destroying the driver's side of the vehicle.

Upon examining the vehicle, I did not observe a child seat in the vehicle for the 3 year old. It is unknown at this time if they were wearing their seat belts or if there was actually a car seat in the vehicle at the time of the accident.
