


City Concentration Map



The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 11/02/2017 at 2:01am officers investigated a shots fired Complaint in the area of E. Mason St and N. Broadway St. While on scene a shooting victim arrived at St Mary's Hospital. The investigation revealed the victim was at the District Night Club earlier with a group of friends. During the night an unknown subject bought her a drink. The same subject later touched her breast. After closing the situation escalated outside which resulted in shots being fired by both parties. The District was cooperative with the officers and provided video surveillance footage. The District pats down all patrons prior to them being allowed inside and the subjects involved had obtained their guns from their cars.
- 2. On 11/13/2018 officers investigated a Battery DV that started at 628 N. Water St in line waiting for the District Bar. The victim was in line with the suspect who was kicked out of the line by security for smoking and a dress code violation. The victim and suspect walked off and the suspect hit the victim in the head. The victim asked security to help her get her keys from the suspect but they refused stating she would need the Police to do that. The victim then leaves the scene. The tavern supplied video to the officers.
- 3. On 12/14/2017 at 3:07am a subject went to District One to report an incident that occurred at The District, 628 N. Water St. The victim stated she was standing at the bar when a subject came up behind her and pulled up her skirt exposing her underwear. She reported the incident to security who confronted the subject and kicked him out. The victim observed him return at closing time and be allowed back in the bar. The officer made attempts to follow up at the tavern but it was closed.

4. On 01/09/2018 a meeting was held at District 1 regarding incidents at The District, 628 N. Water St. Captain Rowe suggested an ID scanner and a staggered or early release to avoid problems with 618Live closing at the same time. Security cameras were discussed. The applicant stated she has 6 cameras inside and 2-3 outside. She stated the footage is saved for 7 days. The applicant was reminded to call the Police when incidents occur. She stated she has hired a new General Manager but he doesn't have his manager's license yet.

- 5. On 02/28/2018 an officer met with the applicant regarding safety updates. The applicant advised the officer of the new ID scanner which is connect to a data base that track people kicked out of taverns nationwide. She also showed him new security cameras installed inside and outside. She stated that she has added two security officers outside in a car that are capable of going mobile if needed.
- 6. On 10/06/2018 officers responded to St Mary's Hospital to investigate a battery that occurred at District on Water, 628 N. Water St. The victim stated she was inside when a subject pushed her. When she confronted the person about the push she was punched in the face by a third subject. the Police responded to District on Water and spoke with the applicant. The officers were shown the ID scanner which had a picture of the subjects ID but could not view the video surveillance because nobody, including the applicant, knew how to operate the system. The suspect was located and arrested.
- 7. On 11/04/2018 officers were monitoring District on Water, 628 N. Water St. The Officers reported there were shots fired inside the tavern and located a victim, who is 18 years old. The victim was inside the tavern with her 17 year old friend. The investigation revealed the victim and her friend used an ID that belonged to someone else to get in the tavern. The employees were cooperative with the investigation and provided a copy of the video to the officers. The officer estimated there were 300 patrons inside and saw the posted capacity was 225. The officer used the video surveillance on the front door to count the patrons as they left and had a count of 383 when the video stopped at 1:20am, prior to all patrons exiting. This count was 158 over capacity. While watching the cameras the officer observed patrons walking around with full bottles of liquor. The business manager was not able to provide names of security personal on scene, he could only give nicknames. The officer also observed a smell of marijuana by the hooka pots and packaging for marijuana that tested positive for THC: The applicant was issued a citation for over capacity.

8. On 11/09/2018 a meeting was held at District 1 regarding District on Water. The issues discussed included: over capacity, marijuana recovered by the hooka, not knowing the names of security officers, using a promoter, and underage patrons. The applicant stated they do not use a promoter, they have a subject on staff the promotes the business on Facebook and would install a metal detector.

- 9. On 12/06/2018 at 2:05am officer conducted a tavern check on District on Water, 628 N. water St. The officer observed a patron leaving after hours. The officer went in and spoke with the applicant who stated the subject was having trouble closing his tab and another person was waiting to give an employee a ride home. The applicant was advised a PA33 would be written.
- 10. On 12/28/2018 officers, along with an inspector from the health department, conducted an inspection at District on Water, 628 N. Water St. The applicant was on scene.
- 11. On 01/26/2019 officers were dispatched to a battery cutting at District on Water, 628 N. Water St. The officer spoke with the applicant who stated she did not know of any problem in the tavern. she then remembered a friend who had a cut on his head from a broken bottle. The officers returned later and spoke with the bar manager who provided video of the victim leaving the business with the cut on his head.

- 12. On 06/15/2019 at 2:00am officers were monitoring the bars in the 600 block of N. Water St. The officers heard a loud argument in the area and located a subject on the ground unconscious at 600 N. Water St. The witnesses stated the subject was leaving the bar at 628 N. Water St and got into a fight with another patron of the same bar. The fight had originated from inside the bar. The suspect hit the patron one time knocking him to the ground. The victim was taken to the hospital where he died from his injury. On 06/26/2019 the officers attempted to contact the applicant at the business but it was closed. They called her by phone and she stated she would help in any way possible.
- 13. On 08/03/2019 at 12:43am while on foot patrol in the 600 block of N. Water St, officers observed a fight in front of 628 N. Water St, The District Nightclub. The officers interviewed one of the subjects who stated he was inside the tavern ordering drinks when an unknown actor began hitting him from behind for no reason. The subject stated he was defending himself when security pushed both parties outside, where the fight continued. The officer interviewed security who stated an unknown actor struck the victim from behind while outside the tavern, he did not mention that the fight had started inside.
- 14. On 08/10/2019 at 12:00am The District Nightclub, 628 N. Water St, reached capacity and the applicant advised security to not allow anyone else inside. At 1:57am a fight between two patrons of the District started outside in front of The District. Security separated the subjects and assisted police. Security cleared the sidewalks after closing and there were no further incidents.

On Friday, June 14th, 2019, from the hours of 11:00PM to approximately 3:00AM, I was assigned to the Code R.E.D. (Responsible Entertainment District) Deployment as squad 1424, with my partner P.O. Terrell VELAZQUEZ. Our area of focus was the 600 block of N Water St. The purpose of the deployment is to monitor and address any issues that arise from the taverns on this block. The normal practice of this particular location is to maintain a high presence in front of the taverns until bar close, and then to relocate to a neighboring parking lot where patrons go to after bar close.

At approximately 2:00AM, the bars were near empty, and most of the patrons had left the area. As a result of this, we relocated to the parking lot. While patrolling the lot, I heard what I suspected to be loud verbal arguing that appeared to originate from the location of 600 N Water St. Upon investigating, we observed a Hispanic male, lying on the ground, unconscious, but still breathing. It was told to us by witnesses that the victim was punched one time to the head, and fell to the ground. Witnesses stated that they were attempting to leave the bar located at 628 N Water St; "District IV". Witnesses stated the suspect in this incident was also a patron of the same bar, and they believed the conflict between the suspect and victim originated from inside the bar. The victim was conveyed to Froedtert Hospital for his injuries, which was determined to be a subdural hematoma, of which he did not recover from, and died. As a result, this became a Homicide Investigation.

On Wednesday, June 26th, 2019, at approximately 8:00PM, I, along with Sgt. Justin JOLIFF (Squad 2415), responded to the address of 628 N Water St, located in the City and County, to conduct a license premise check of the establishment located at this address. The establishment is licensed as "District IV", but was not open for operation at the time of the check. A public internet check the business provided a guide for hours of operation, which were 4:30PM- 1:30AM, and a phone number of 414-252-0145. A voicemail was left for this phone number regarding the license premise check which needed to be completed.

I then returned to the District #2 station were I was able to obtain the license information from the City of Milwaukee License Search. The search provided the valid class B Liquor License for "District IV", with a license number of BTAVN 205962. The license also provided the identity and cell phone number for the owner of the business. The sole owner was identified as Patsy SMITH-JAMES (F/W, 08-30-1942), with a phone number of 414-614-7349.

I called this number and was greeted by a subject who identified herself as "Patsy". (It should be noted that the telephone conversation with SMITH-JAMES was recorded via my departmentally issued body worn camera.) I informed SMITH-JAMES that a license premise report was going to be created regarding the homicide investigation that stemmed from a conflict between patrons within her business. SMITH-JAMES stated that she understood, and she did not have any questions at this time. SMITH-JAMES was very cooperative during the phone call, and willing to help in any way she could. SMITH-JAMES also informed me to use her cell phone number should the need arise again to contact her, as she always answers this phone number.

On Saturday, August 4, 2019 at 12:43 pm, P.O. Joseph LASPIZA and I squad 1424 were assigned to 600 N. Water St. for code red.

While on our park and walk patrol I observed 2 males fighting on the sidewalk directly in front of The District Nightclub (628 N. Water St.). After separating the 2 males the victim Marco A. ORTEGA-ARECHIGA (h/m 01-28-1997) stated that he was attacked by an unknown male from behind for no apparent reason. ORTEGA-ARECHIGA declined medical attention and also declined to press charges.

I also Interviewed the door bouncer Quentyn A JACKSON (b/m 12-28-1995) who stated that the unknown male attacked the victim from behind and he did not know what started the fight. JACKSON stated that the victim and the unknown actor exited The District nightclub and started fighting.

P.O. LASPIZA remained with ORTEGA-ARECHIGA, while I interviewed the bouncer. Per P.O. MFD administered Narcan to HOLMES to revive him. Once he was awake HOLMES then informed me that the he came to the area to locate drugs. HOLMES stated that he received 4 percocet (Oxycodone hydrochloride) 30 mg pills from a friend.

HOLMES stated that after receiving the pills he went into the BP gas station located at 405 N 27th street and used the restroom. HOLMES stated that he then grounded up 1.5 pills and snorted the residue into his nostrils. After checking HOLMES information through NCIC it revealed that he is in violation of his probationary orders, which states that HOLES shall maintain absolute sobriety and must not possess, ingest alcohol or drugs with out a valid prescription.

After conducting a search incident to arrest I located two pills in HOLMES wallet, which were later identified through pill identifier (drugs .com) as a schedule 2 drug Oxcodone Hydrocloride. HOLMES was transported to Mt. Sinai Hosptial by Curtis Ambulance 315. After medical clearance HOLMES was transported to district 3 for processing.

On Sunday, 10-27-19, Squad 3255 (P.O. WEILAND and I) was dispatched at 11:39 AM to a DOE at 405 N 27th St (BP Gas Station) along with Squad 3113 (Sgt. WASHINGTON). Upon arrival MFD Med 14 was on scene with the deceased inside of the gas station near the front counter. I spoke with Lt. OBERG who stated it appeared the deceased identified as Christopher GREENE (B/M 10-09-65) suffered from cardiac arrest and collapsed onto the floor. MFD stated nothing appeared suspicious regarding the death. GREENE was pronounced at 11:22 AM by Doctor# 0092. There was a prior call placed by the gas station clerk, Vishaldeep S. DHAMI (W/M 09-21-2000) at 10:49 AM to 911 where DHAMI stated GREENE collapsed at the location and was having difficulty breathing. MFD was then dispatched and found GREENE laying on the floor upon their arrival and performed life saving measures but were unable to resuscitate GREENE.

I observed video of the incident detailing the following,

At 10:49 AM GREENE walked into the store going westbound. GREENE then proceeds to purchase a newspaper at the front counter from DHAMI. GREENE then walks back towards the candy aisles then back toward the front counter facing the exit door. GREENE then suddenly leans forward then proceeded to collapse falling backwards onto the ground. DHAMI then called the 911 and GREENE remained on the ground up until MFD arrived on scene.

I notified Lt. BABICH who stated CIB would not be responding and it was ours to file. Medical Examiner Cori MANYEN then arrived on scene. Next of kin notification was made to GREENE'S brother, Bob GREENE (B/M 04-25-55) who lives in Albuquerque, New Mexico. Bob stated his brother did have medical problems and had blood clots. We then changed locations to speak with GREENE'S sister, Evette GREENE (B/F 09-29-57), at her residence at 437 N 33rd St. Evette made a positive identification of GREENE and stated GREENE did have blood clots, high blood pressure, and was recently in a car accident that caused health issues. Evette stated GREENE did go to the doctor's office regularly but was not good about taking his medications. Evette was unable to provide the names of what medications her brother was taking. I provided Evette with the Medical Examiner's information and the report number.

P.O. Michael WEILAND took nine photographs depicting the scene. Forensic Investigator HINKEL arrived on scene to recover video of the incident and provided us with a CD copy which was delivered to the Medical Examiner.
