1. Description of Grant Project/Program (Include Target Locations and Populations):

The City of Milwaukee Community Development Block Grant Administration and City of Milwaukee Health Department Division of Home Environmental Health received an award of \$5,000,000 in Lead Hazard Reduction Funds and \$600,000 in Healthy Homes funds to address health and safety issues in Milwaukee's housing in order to improve the health of Milwaukee's children. The result of this grant would be 260 properties assessed for lead, 250 units enrolled and abated and 40 contractors trained and hired. At least 114 units would receive healthy homes services. Information about lead poisoning would be shared at least 84 community events and 1,200 individuals would be reached through community outreach education events.

2. Relationship to City-wide Strategic Goals and Departmental Objectives:

Continued collaboration with DNS to improve the number of safe and habitable housing units in Milwaukee and incorporating Community Lead Outreach through a partnership with Sixteenth Street and Social Development Commission.

3. Need for Grant Funds and Impact on Other Departmental Operations (Applies only to Programs): Amended

With 2,200 to 2500 or 9 to 10% of children under 6 being reported annually with elevated blood lead (EBL) levels and nearly half of all children living in poverty there is significant need for Lead Hazard Reduction Program funds. Though any child with an EBL will be eligible for participation, prioritization will be given to:

- 1) High Priority EBL Levels children with EBLs >15µg/dL;
- 2) Properties associated with multiple EBLs (current and historical);
- 3) Properties associated with other federal housing programs, e.g. Section 8 and
- 4) Properties associated with the highest needs areas of the City of Milwaukee

This grant will support the following positions:

- 1) Program Director (25%)
- 2) Program Manager (75%)
- 3) Two Lead Risk Inspectors (75%)
- 4) HEH Coordinator (75%)
- 5) Lead Project Specialist (75%)

4. Results Measurement/Progress Report (Applies only to Programs):

250 housing units are to receive lead abatement within the 42 month grant.

5. Grant Period, Timetable and Program Phase-out Plan:

42 months from award with 90 day grant closeout period.
