



- 0. Scope:
  - 0.1. The project covers two buildings.
  - 0.2. The repairs to 2724-26 were ordered by the City of Milwaukee Building Inspector. The order requires completion by June 26<sup>th</sup>, 2019 plus extensions.
  - 0.3. The top approximately 18" of foundation is precast concrete block. We anticipate the existing precast stone will be evaluated and replaced as needed during a complete restoration project at a later date.
  - 0.4. The entire foundation is to be parged just below grade to include all visible surface area. The finish should match the building at 2732-34 West Burnham.
  - 0.5. Provide material data sheets for all products used on this project in duplicate.
