The revaluation for 2020 is moving forward – on a modified schedule Some of the factors relating to the timing of the revaluation include:

1) In 2002 the Mayor and Common Council determined that revaluations should occur every year

2) The Wisconsin DOR issued <u>Property Assessment and Taxation Information</u> related to COVID-19 specifically stating that COVID-19 does not delay 2020 assessments

3) there are Statutory deadlines for assessment activities for cities of the 1<sup>st</sup> class

## Highlights of Milwaukee 2020 Revaluation Schedule

March 23 – Milwaukee Health Commissioner issued <u>"Stay at Home" order</u> effective 12:01 am on 3/25/2020 with no end date designated March 24 – Governor Evers issued <u>"Safer at Home"</u> order mandating people to stay at home until April 24th. – effective 8:00 a.m. March 25, 2020 March 24 – Wisconsin DOR issued <u>Property Assessment and Taxation Information</u> related to COVID-19 specifically stating that COVID-19 does not delay 2020 assessments April 10 – Good Friday – city hall closed April 7 revised to April 14<sup>th</sup> – Last day to make value changes April 8 – revised to April 15<sup>th</sup> Data files sent to printer for printing, folding, stuffing and mailing April 17 revised to April 24<sup>th</sup> – Assessment change notices will be mailed

April 24 – proposed end of <u>"Safer at Home"</u> order from Governor Evers

April 20 revised to April 27<sup>th</sup> – 1<sup>st</sup> day of Open Book – Open book will be handled only via phone calls or electronically - if the Go-to-meeting software can be set up and implemented

May  $11 - 2^{nd}$  Monday in May - Statutory deadline for making assessments available to the commissioner, see <u>Statute 70.07 (1)</u>

May 11 – 1<sup>st</sup> meeting of Board of Assessors (generally there are 12-13 meetings per year) - <u>Statute 70.07 (2)</u> determines the date

May 18 – Last day of Open Book

May 18 – Statutory deadline for appeals to be filed – see Statute 70.47 (16)

May  $28 - 1^{st}$  day of Board of Review – Required timing is spelled out in <u>Statute</u> 70.47

May 28 – Annual meeting for Board of Review

June 8 – Second Monday of June reports are due to DOR

October 7 – Last meeting of Board of Assessors

October 12 – Statutory deadline for roll to be submitted to BOR – see <u>Statute</u> 70.07 (6)
