Hi Jodi,

I appreciate you taking time to hear out my concern, and your willingness to pass it along to Alderman Robert Bauman. My personal information was correctly recorded; and, I would like to add a written complaint to the licensing file against **Silk Gentlemen's Club at 730 N Old World Third St.** Below I will provide a summary of a few of the troubling incidents I've witnessed over the past year, in which I've

Most prominent of which occurred around the early morning of this past Sunday. If you would like any additional information/have any questions, please contact me.

Around 2 am this past Sunday morning, I was beaten up/jumped by 4-6 people, which included at least 3 Silk Gentlemen's Club employees(Uniformed Security Guard, bouncers, etc). This incident began, as I was walking home alone from Water Street & Juneau. As I was walking home southbound on third-street, I approached Silk Gentlemen's Club, and asked one of the bouncer's if the metered parking spots, located right out front, are really there's to use for valet, as they choose. I have asked this same question politely before, and have been threatened to be "put on world star" (Website with videos of people being beaten up) by the security guard, without any answer. Once again, I didn't receive an answer. Instead, I was confronted by 3-4 motorcyclists' whose vehicles' were parked in the Valet, as well as, at least 3 silk employees, who seemed to know the aforementioned motorcyclists. I know for a fact that one of the Silk employees involved was a uniformed Security Guard, and at least one of the other's, works as a bouncer.

The verbal argument began outside of Silk, and quickly turned physical, as I was pushed back continuously on the side-walk, south. Knowing my apartment was located about a half a block south, I tried to make sure I was being pushed towards the front of my apartment to hopefully steer them away from attacking me. Unfortunately, the 4-6 men(motorcyclists and silk employees), continued to follow me down the street off their premises, where I was first stuck outside of the convenient store attached to the Grand Wisconsin Apartment. The men proceeded to tackle me right outside my apartment, kick me and punch me several times in the face, head, ribs, neck, chest, and more. All I could do was lie on the ground, with my hands covering my face, as best as I could. This beating went on for about 20-30 seconds. After, they finally were pulled off by others' nearby, I got up quickly and went immediately to the lobby of my apartment. My roommate, who heard commotion while inside of our Apartment room, and saw "someone being jumped", came downstairs and found out it was me who was had been beaten.

I used his phone to call the police, as I was bleeding from several parts on my head, chin, elbows, knee, back and more, and wanted my injuries documented. The police arrived 1.5 hours later, and I let them into the to explain what happened. I gave details regarding how I was jumped outside of by 4-6 men, following a verbal argument that started outside of Silk. They subsequently went outside to investigate the area where I was beaten, and to ask questions to the employees at Silk.

After 30-45 minutes of asking questions to the employees of silk, most of which I could the officers' returned to speak with me. They indicated that at least 3 employees admitted to "roughing me up", and they "found blood" right outside of the front entrance of the Grand Wisconsin Apartment. The officers' took video & pictures of most of my injuries, and informed me that based on everything presented to them, 3 Silk employees will be charged/receive a citation for "Assault/battery". While, because I was involved in an argument, outside, I was given a citation for "disorderly conduct". They stated however, if Silk wouldn't provide a video of their surveillance camera by the Sunday night, they would dismiss my charge. I have tried to follow up with the officers' regarding the camera & to make sure the employees' are still being charged with "battery"; however, I just found out today that both officers only work from 12am to 7am, so I will have to get up early tomorrow morning to reach them.

The night of the incident, I was unable to go to bed due to the pounding headache I had & other soreness throughout my body. The next day, I went to an Aurora Urgent Care facility where they helped clean-up my cuts, relayed that "I likely sustained a concussion", and "needed stitches on my chin". Quite simply, I should have went to be checked on immediately at an ER facility, but I declined treatment at the time due fear of the financial burden it may put me in.

This is not the first time, in which my roommate and I have been woken up to see a fight taking place, involving Bouncers' and Security Guards' at this Silk location. Aforementioned,

a clearly drunk individual who just got kicked out of Silk, was followed in the middle of the road on third st. & tackled to the ground by bouncers'. After this incident, I was upset that they didn't handle the situation properly, by not just letting the customer walk away, and left two voicemail's with the management of Silk regarding the incident. I never heard back.

In short, in just the 1 year I've lived it has become a normality to see/hear loud arguments, fights, and unprofessional actions performed by employees at Silk. I feel/fear they believe they are untouchable, when it comes to facing consequences for their actions. This has proven through past events, and most recently with what I endured this past weekend. The uniformed Security Guard threatened to "put me on WorldStar", showing how confident he is that he will face no consequences. I was beaten right in front of clearly located off their premises. It has reached the point where I don't necessarily feel safe to even live nearby, especially as they know so close. I will admit that I was wrong to continue the conversation, once it started to turn into a heated argument. But, that is never grounds for 4-6 guys(Including Silk employees on the clock) to follow me , and beat me senseless. Kicks & punches to my head and body while I'm curled up on the ground, could have killed me or caused serious permanent damage. Fortunately, I walked away with just several abrasions/cuts and contusions on my head and body, and stitches on my chin.

I apologize for the length of this "summary", but I wanted to be as honest and clear as possible. I fear that if something is not done to address these occurrences with Silk management/ownership, these reckless, negligent violent actions will continue, placing numerous other peoples' lives in jeopardy. Thank you for hearing me out, and please reach out with any follow-up questions regarding any other incidents' I have mentioned in this summary.

The Milwaukee Police Department's investigation regarding this application revealed the following:

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit,

1. On 06/17/2013 the Wisconsin Department of Transportation revoked Joseph Modl's driver's license for 6 months for Operating While Intoxicated. Joseph Modl is listed on the application as 38% shareholder.

2. On 12/10/2018 officers were dispatched to a fight at Silk, 730 N. Old World Third St. The officers interviewed the victim who stated he was punched by a security guard as he was leaving, causing a cut lip. The manager, Perry WILK, stated he saw pushing by the front door but does not know what happened outside. The manager could not operate the surveillance system that night. The owner, John FERRARO, provided a copy of the video the next night. The video showed staff having difficulty getting a group of people to leave. Outside the camera shows a patron punching a subject who fell to the ground. Another fight starts and a security guard punches the victim three times. WILK advised the guard worked for a third party firm and has been fired.

3. On 08/08/2019 officers conducted a licensed premise check at Silk Exotic, 730 N. Old World Third St., based on a complaint that patrons were smoking Hookah and vaping. The officers

- spoke with the manager, who stated they only use water based hookah, which they are licensed for and he will have the employees enforce the no vaping rules.
- 4. On 09/08/2019 at 3:07am officers were dispatched to a battery at 720 N. Old World Third St. The caller stated he was assaulted by security from Silk Exotic, 730 N. Old World Third St. He stated he was walking home from a bar and as he walked by Silk he was followed by security and was attacked by six security personnel and a uniformed guard. He stated he did not know why they assaulted him. The officer spoke with the security guard, Montel JACKSON, who stated the victim was arguing with several bikers parked in front of Silk. JACKSON stated he was able to push the victim out of the area but the victim was attempting to bite him. JACKSON stated he did not assault the victim but refused to state who did. The officer spoke with the manager who stated he could not review the security footage because he did not have access. The officers spoke to a security officer, Shane HOEFT, who stated there were motorcycles parked outside and the victim came out yelling when they started up to leave. HOEFT stated he took the victim to the ground when the victim attempted to bite JACKSON. While on the ground everyone kind of piled on and he didn't see what happened. On 09/11/2019 the officers were provided with a copy of the video surveillance. The video showed the victim arguing with the security guards, who pushed him away. The victim then comes back and pushed a security guard. The victim is pushed off toward his residence. JACKSON follows the victim and an argument occurs. The victim pushed the guard again and more security officers leave the front door of Silk to assist JACKSON. JACKSON punches the victim and HOEFT tackles the victim to the ground where he is seen kicking something out of view of the camera. The victim is cited for Disorderly Conduct and the security guards are cited for Assault and Battery.
- 5. On 09/14/2019 officers were dispatched to a battery at Silk Exotic, 730 N. Old World Third St. The victim stated he attempted to go to a VIP room and was denied by the bouncer for not having enough money, so he calmly left. He stated later in the night he approached the bouncer to tell him he was rude and unprofessional, at which point the bouncer pushed him to the door causing him to fall down the stairs injuring his knee. The bouncer stated the victim began shouting profanity when he was denied entry to the VIP room and was causing a disturbance so he was escorted out. He stated that both he and the victim fell down the stairs as he was escorted out. The manager was not able to view the video of the incident that night but emailed the officer the video on 09/15/2019 and 09/17/2019. The video shows the bouncer removing a drink from the victim's hand in an aggressive manor. The bouncer then approaches the victim and pushes him to the door causing him to fall down the stairs. The bouncer was issued a citation for Assault and Battery and the victim was issued a citation for Disorderly Conduct.



This report is written by PO Raymond DEBRASKA, assigned to District 1 Late Power Shift.

On Thursday, 08/08/18 at 1:11am, Sgt. Timothy Gauerke (Squad 1410), PO's Kristopher SARDINA and Michael BUDISZEWSKI (Squad 1430) and PO Michael CONNELL and I (Squad 1440) did a tavern check at 730 N Old World Third St (Silk Exotic). A citizen recently made a complaint that patrons were smoking hookah and vaping inside the business.

We spoke with the on-duty manager, Ryan PARKS, regarding the complaint. PARKS was aware of the regulations regarding hookah and informed us that they use the water based system which is allowed and they are licensed for. While speaking with PARKS we observed a subject near the stage/bar area vaping. We advised PARKS that vaping of any sort was not allowed inside the business. PARKS stated that he would advise the staff to enforce this from now on and had an announcement made over the intercom system stating no vaping was allowed inside the business.

INITIAL INVESTIGATION

This report is written by P.O. Daniel O'CONNELL assigned to District 1, Late Shift and equipped with a body worn camera.

On Sunday September 8, 2019, I responded to 720 N Old World Third Street at approximately 3:07 AM, along with Squad 1323 P.O. Jacob ROECKER, regarding a battery complaint. The caller, who was later identified as Ryan S MCBRIDE (W/M, 03-17-95), stated that he had been hit by the bouncers of Silk Downtown which is located at 730 N Old World Third Street at approximately 2:00 AM.

Upon our arrival, we met with MCBRIDE in the lobby of 720 N Old World Third Street which is MCBRIDE's apartment building. I observed MCBRIDE wearing a bloody white t-shirt, several abrasions on his elbows, neck, and chin with contusions on the top, back and side his head. He also had abrasions on the contusions. I also noted that MCBRIDE appeared to be heavily intoxicated. I asked if MCBRIDE needed medical attention which he declined numerous times.

MCBRIDE stated that as he was walking home from a bar, he walked by Silk when he was followed by the bouncers and a uniformed security guard who employed by Silk, and was assaulted by the door to his apartment building. He did not know why he was assaulted but knew that at least six security personnel from Silk had jumped him and beat him up. I asked if there was any altercation leading up to the assault, MCBRIDE stated he did not know what had happened leading up to it but knew that the subjects were employed by silk. I asked how he knew that they were employees and he stated that the uniformed security guard was the main guy and a guy with slicked back hair.

I told MCBRIDE to stay inside the lobby and we would go speak with the staff at Silk. We then initially spoke with the uniformed security guard who is employed by Cole Private Security and contracted to work at that location. The guard, Montel S JACKSON (B/M, 04-24-92), stated that he had some interaction with MCBRIDE earlier in the evening. JACKSON stated that MCBRIDE had been walking home intoxicated when he walked by Silk, he started to get into an argument with several bikers who were patrons of the bar and parked outside.

JACKSON stated that MCBRIDE became more and more aggressive with the bikers causing a disturbance outside of the establishment. JACKSON explained he attempted to move MCBRIDE out of the area and towards MCBRIDE's residence to try and diffuse the situation but MCBRIDE wouldn't listen and continued to try and fight with the bikers. JACKSON stated he was able to move MCBRIDE out of the area but MCBRIDE kept talking shit to the bikers. JACKSON stated he was guiding MCBRIDE away from the establishment and was pushing or guiding him away. At one point, MCBRIDE had attempted to bite JACKSON. JACKSON stated that he would have been bit by MCBRIDE had he not had moved his head out of the way and push him.

JACKSON stated he had nothing to do with MCBRIDE being assault but wouldn't state who had assaulted him because he (JACKSON) wasn't going to help that guy (MCBRIDE) out at all. I said if he knew who had attacked MCBRIDE he should tell me who it was because MCBRIDE was alleging the employees of silk had attacked him and JACKSON could clear this up by telling me who had attacked MCBRIDE if it was not him

or other employees. JACKSON wouldn't answer the question. I pointed out that there was blood on the sidewalk, MCBRIDE was beat up and that JACKSON should just be honest about what happened. JACKSON stated that MCBRIDE got tuned up but it wasn't his doing. I again asked who did it and JACKSON just shook his head no.

I then asked if any other employees were still present. JACKSON then summoned Perry A WILK (W/M, 02 -06-86) who is the general manager of the establishment. I spoke with WILK and explained the situation to him and requested to see the surveillance video as there were two cameras on the exterior of the the building. WILK informed me that they did not have access to the cameras because their IT professional was the only person who had access and would not answer if we called. I requested we try but WILK declined to do so. WILK did state that the owner of the business would be in tomorrow and could get the video.

I then requested to speak with any other security personnel that were still present at the bar. WILK led myself and P.O. ROECKER inside the establishment where we then spoke with several members of the security team. Please see P.O. ROECKER's supplemental report for further details.

I next spoke with Alan H BAUER (W/M, 06-26076) who is a security employee who had been working during this event. BAUER stated that he had been working in the inner foyer for most of the night and occasionally checked IDs outside. I asked if he had been checking IDs around bar close or saw anyone acting disorderly outside the establishment around that time. BAUER initially was hesitant to say had gone on outside of the bar but stated that there were a few drunks starting things outside and they were moved along. He said he saw the bikers outside but that the customers were not the issue and the passing drunks were the issue. I asked about someone matching MCBRIDE's description causing a disturbance. BAUER said he wasn't sure about that because he didn't think he was outside during that time. BAUER stated he didn't have much more to add regarding this incident.

I then spoke with Joseph C MILLER (A/M, 04-13-77) who stated that he is part of the security team and he was working inside all night. He did not observe anything relevant to this investigation.

I also spoke with Shane T HOEFT (W/M, 08-15-78) who stated that there were motorcycles parked outside of the bar and they started up. MCBRIDE came out yelling for them to shut them off and get "the fuck out of here". They were trying to get him away from the customers and they were able to move him south past the alleyway. Then at some point, according to HOEFT, MCBRIDE attempted to bite or head but JACKSON at which point HOEFT ran over while JACKSON and MCBRIDE were pushing each other and HOEFT took him down. After that according to HOEFT, "everyone kind of piled on top of him" so he didn't see much of what happened after that. HOEFT began to tell of past incidents with MCBRIDE and how much of a problem he is for the business.

After conferring with P.O. ROECKER regarding what Joshua A BAIER (W/M, 10-16-79) stated regarding this incident, we issued citations to the following subjects:

After learning that they were going to be receiving citations JACKSON, HOEFT, and BAIER began to alter their narrative of events. JACKSON stated that he was assaulted and that he felt MCBRIDE's teeth on his head. But later stated that MCBRIDE attempted to bite him because he moved his head in time so no biting occurred. JACKSON then claimed that never touched the guy despite stating earlier that he had pushed MCBRIDE away from him in an earlier narrative of events.

On Wednesday September 11, 2019, I received surveillance video from P.O. Jesse MATTSON, who had received a SansDisk flash drive containing the surveillance video from this incident from WILK. WILK had flagged down MATTSON regarding. I then reviewed the video and then made copies of the video and placed a DVD copy as well as the SansDisk Flash drive on MPD inventory number 19-251-1000. A brief summary of the video surveillance is as follows.

At 1:53 AM camera time (please note as this was provided by the business without being viewed by an officer, I can not confirm if the camera time is accurate) MCBRIDE is observed walking into frame south on N Old World Third Street towards his residence. MCBRIDE stops and then returns towards Silk and appears to start arguing about the motorcycles parked in front of Silk. MCBRIDE continues to argue with JACKSON and BAIER in front of silk, continually pointing at the motorcycles. MCBRIDE also argues with the owners of the motorcycles.

At 1:55:34 AM BAIER grabs/pushes MCBRIDE towards the alleyway. MCBRIDE keeps his footing after the push. MCBRIDE continues to argue with BAIER. During this argument a large group of subjects gathers to watch MCBRIDE. MCBRIDE then approaches BAIER at 1:56:40 AM at which time BAIER pushes MCBRIDE again and out of the frame into the alleyway. When MCBRIDE returns to view, MCBRIDE is observed pushing BAIER back.

MCBRIDE begins to back up towards his residence while still yelling at BAIER. Additional subjects continue to watch the altercation continue. BAIER eventually returns to the front door of Silk but JACKSON continues to follow MCBRIDE. They both stop in front of his residence and with both arguing. At 1:58:01 AM MCBRIDE pushes JACKSON at which point HOEFT and BAUER ran down towards JACKSON and MCBRIDE leaving the front door of silk. MCBRIDE then begins to argue with JACKSON, HOEFT, and BAUER.

BAUER and HOEFT move back towards Silk while JACKSON remains near MCBRIDE who continues to cause a disturbance yelling. at 1:59:01 AM JACKSON punches MCBRIDE at which point BAUER, HOEFT, and BAIER all run down towards MCBRIDE and HOEFT in front of 720 N Old World Third Street.

HOEFT then tackles MCBRIDE to the ground at 1:59:05 AM which point what occurs is obscured by subjects standing and watching the altercation. HOEFT is observed kicking at something out of view of the camera at 1:59:35 AM. At 1:59:54 AM the altercation is over and MCBRIDE is observed walking back into his apartment with BAUER, BAIER, JACKSON, and HOEFT walking back to Silk where they remain until the end of the video.

This Report is written by P.O. Justin ARREDONDO, assigned to District One, Late Shift.

On Saturday, September 14th, 2019, at approximately 12:58 A.M., I (myself, in full-duty uniform, and operating marked MPD Squad 119, as Squad 1340, and wearing department-issue AXON body camera) was dispatched to a Battery Complaint at 730 N. Old World Third Street; Silk Exotic Gentleman's Club. Upon arrival, I was met by the alleged victim and caller; later identified as Joseph K. FRASCELLO (w/m, 10 -26-92) who stated that he was battered by a bouncer at the club over disputes regarding cover charges to enter a VIP room, FRASCELLO alleged that he attempted to gain entry to the VIP area, but was denied by a bouncer due to lack of funds, in which he stated that he calmly tried to walk away. Shortly after, FRASCELLO stated that he attempted to address the bouncer and tell him that he believed the bouncer's conduct to be very rude and unprofessional, at which point the bouncer began to escort him out by pushing him. FRASCELLO alleged that the bouncer pushed him down the stairs, causing pain to his knees, then stood over him, telling him to get up in an intimidating fashion. FRASCELLO attempted to get up, in which the bouncer pushed him down a second time, escorting him out of the club. It should be noted that FRASCELLO's demeanor was antagonistic and confrontational against any statements made by officers about how this investigation was being handled.

I then spoke to the manager named Perry A. WILK (w/m, 02-06-86), who advised me that FRASCELLO was removed from the location due to FRASCELLO being extremely confrontational with staff over lack of proper payment, and his overall demeanor. I asked WILK to provide me with copies of the video for

further review, in which he advised me that due to recent burglaries, he moved his video recovery to upload saved data to an off-site location, and would later e-mail them to me. WILK provided entry to the club for myself and other officers, and requested the bouncer who was involved to meet me on the floor. I then spoke to George A. HUMBLET (w/m, 06-07-78), who was the bouncer who directly removed FRANSCELLO. According to HUMBLET, FRANSCELLO attempted to gain access to a VIP Room, but presented \$40 for entry. HUMBLET advised him that it costed much more to gain a VIP room, in which FRANSCELLO then presented his credit card. HUMBLET requested an I.D. to verify his identity before chargining his card, at which point FRANSCELLO began shouting profanities toward him, and causing a disturbance. HUMBLET stated that the dancer he was attempting to gain a VIP Room with was attempting to pull FRANSCELLO away and lead him to the floor in order to calm him down. This dancer was unidentified, and no longer on scene due to the club being closed. HUMBLET determined that FRANSCELLO's demeanor was unacceptable, and began to escort him out, at which point both he and FRANSCELLO fell to the floor after going down the stairs.

On 09-15-19, I received an e-mail attachment from WILK containing 4 video segments of this incident. One of this segments depict the dance floor in which HUMBLET and FRANSCELLO were partially observed to fall to the ground at the bottom of a short staircase, it should be noted that they were not on the stairs, as alleged by FRANSCELLO, and at not point did I observe HUMBLET push him down a second time. FRANSCELLO was escorted out of the establishment from behind. WILK and HUMBLET were both cooperative with this investigation, and I did not observe any violations within the establishment.

On 09-017-2019, I received an additional video depicting the VIP Floor, and the entire incident. Time-stamped at 01:53:30, HUMBLEt can be seen removing a beverage from FRASCELLO's hands in an aggressive fashion, and then approaching FRASCELLO. Shortly after, FRASCELLO falls to the ground, undetermined due to visual obstructions by dancers. HUMBLET is observed to stand over FRANSCELLO momentarily, before picked FRASCELLO up by his clothing. At time-stamp 01:53:42, HUMBLET was observed to push FRANSCELLO forward with his right arm, causing FRASCELLO to fall down a short flight of stairs, in which FRASCELLO stated had caused pain to his knees. As a result, I have since issued a NTC Citation to HUMBLET under Citation Number M580ZN3P3G for violation of Ordinance Number 105-2 ADULT - ASSAULT AND BATTERY. FRASCELLO was notified by phone via VoiceMail of the listed court date. Due to being changed to working in the district as Acting Desk Sergeant, I was not able to immediately issue this citation in person, instead I enlisted Squad 1340; P.O. Jacob ROECKER, to deliver this citation in my place. A separate citation was issued via Certified Mail to FRASCELLO for Ordinance Number 106-1-1; ADULT - DISORDERLY CONDUCT, for his disruptive behavior which resulted in FRASCELLO being escorted from the club. This NTC Citation Number is M580ZN3P3H.



- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
