The past week has shown the Milwaukee Police Department repeatedly using intimidation tactics and instigating violence towards peaceful protesters, with implicit support from the Mayor and MPD leadership. Protests by day are peaceful, full of hope, and supported by local businesses. By night protestors are harmed, police feel the need to escalate to violence unprovoked, and curfews are put in place to give police free reign to terrorize anyone outside. Bus service being stopped harms people working outside of 9-5 hours or who may depend on busses to get to essential services. Public transportation being taken away, at short notice, not be used as an intimidation tactic, and only gives police more targets of their cruel behavior.

MPD's budget needs to be cut and redistributed to community programs that will help reduce crime organically. Overtime needs to be regulated far more strongly, preventing overwork and reducing stress in the officers, and militarization of the police needs to be eliminated entirely.

My name is Sean Anderson. I am writing to you as a citizen of Milwaukee, Wisconsin in regard to the violent response from the Milwaukee Police Department during peaceful protests and other affairs that require police presence.

I urge you to change policing policies in order to appropriately and effectively protect and serve our community. Data proves that together, the *following eight policies can decrease police violence by 72%*. Here are the eight policies that must be implemented *immediately*.

1. Ban chokeholds and strangleholds.

- 2. Require de-escalation to allow officers more time, distance, space, and tactical flexibility during dynamic situations on the street.
- 3. Require warning before firing ANY weapon (automatic weapons, mace, rubber bullet rifles, teargas, etc.).

4. Exhaust ALL other means before firing ANY weapon.

- 5. Duty to intervene; to hold officers liable for failing to rescue another party who could face potential injury or death without intervention.
- 6. Ban shooting at moving targets, vehicles.
- 7. Require use of force continuum (infographic attached).
- 8. Require comprehensive reporting.

We must act now.

Dear Committee Members,

I am writing in response to the request for community input regarding item 200214.

Although I recognize some of the intent behind the recent curfews, these actions were clearly ineffective and counter-productive. Watching the local media reports during the curfews, it was immediately clear that the excessive police and military presence, which was located only blocks from my home, was producing far more danger than protection. This became especially clear as my wife left for work to perform her third-shift, essential job at a local hospital during the curfew. Our family felt threatened by the police presence -- not the protesters. As a white family living in an affluent neighborhood, we began to imagine just a fraction of the fear that so many families of color endure when they encounter a Milwaukee Police Department presence near their homes.

More broadly, the local media has clearly documented police officers' escalation of violence in multiple situations. Because these protests are largely rooted in a justifiably angry response to systemic racism and police brutality -- both of which are undeniably a part of Milwaukee's past and present -- these police actions have amplified, rather than improved, the situation.

The local government and police leaders must vocally renounce and reject any further violence against lawful protesters. As an initial step toward peace, the unnecessary use of tear gas and rubber bullets on our city's own citizens must be banned. And because it is clear that the curfews served to label peaceful protesters as "unlawful," their fines must be revoked.

More importantly, the city must begin to defund the Milwaukee police department. During these protests, this police department has proven it is not interested in resolving its issues; instead, it has sought more violence against those demanding justice. Reforms have proven ineffective against the systematic racist policing in our city. Funding must be redirected and invested in alternative forms of constructive programs, which seek justice and fight racism.

I am sending this email to the City Clerk as a comment for this Friday's special committee of the Public Safety and Health Committee. It is a copy of an email I sent to other elected officials. Thank you.

I am writing to express my concern about the way the Milwaukee Police Department is handling the current series of peaceful protests in our city.

First of all, I want to say I do not have first-hand knowledge of the situation, and I try hard not to draw easy or quick conclusions. I have been monitoring news reports, social media feeds, and firsthand accounts. I've heard from friends and contacts whose opinions I respect, and who are not prone to knee-jerk reactions.

I also want to say that, as a white educated female who has experienced good fortune over her lifetime, I don't have any personal cause to complain about our police department, and indeed am inclined to support the department for the many positive things they do in the community.

But right now, I am concerned. I am concerned that tear gas, rubber bullets, and other methods are being used unnecessarily.

I am concerned that our Police Chief is not using this as an opportunity to demonstrate visible, tangible shows of support for those who have legitimate issues with law enforcement. I am concerned that this is giving rise — and perhaps cause — for escalation of activities. Those who are pre-disposed to believe the worst are being given ample material to keep believing it, and that material gets amplified on social media as you well know.

Some are calling for the resignation of Chief Morales, or demanding that he be fired. I don't think a public feud between elected officials and the Chief of Police is helpful right now, but I'm starting to doubt myself.

Please consider this letter a request to put all pressure possible on the Police Chief to de-escalate, offer a show of sympathy where it's merited, and direct his attentions more toward the minority that are causing violence and destruction. All parts of our community need to believe they are being heard and respected.

Hello,

My name is Joshua Backes and I'm an educator and musician that has lived in Milwaukee since 1999. I love this town, but I have always disliked the situation that some of my fellow citizens are in due to their skin color.

We have all seen the national situation regarding policing African American communities vs other communities and it is reflected in our city and state at a higher intensity. For years politicians have spoken about it, NPR talked about it, local papers have mentioned it, yet no real policy action has been accomplished. Why is this?

I have witnessed in my life the militarization of the police, here in Milwaukee and across the nation. Where is the need for this? Would this money not be better spent on crime prevention, education and uplift for the community so as to render this equipment useless?

I know someone that works at the LaFollette Public school here in town. It has children with so many issues including PTSD and behavior is a real problem. It is a long complex story that there is not space to go into here, but suffice to say those teachers and social workers need help. It has been suggested that lowering the student/teacher ratio would go a long way to help more of these students get the education they need. Would this not be a better way to spend the money? Do the police really need armored cars? How many teachers/assistants salaries could be paid for instead of military grade equipment for a metro police department? If we improve our neighborhoods, would this not help the police be and feel safer and therefore preventing all of this mess?

There has been some documented police behaviour in recent days that is VERY troubling. My friends have been witnesses and I have seen the tapes myself. This is NOT how policing a protest is supposed to be and I seriously doubt that a protest for any other issue would be handled in this way. I think controlling looting and property damage is fine, but tear gas (banned in warfare by Geneva) essentially unprovoked should result in a serious investigation and consequences for those responsible.

We need to see policy action that takes into account the views and needs of the community. There is no need for such aggressive policing. The following list should be seriously considered, it is adapted from one shared by a friend online:

- 1. Ban chokeholds and strangleholds.
- 2. Require de-escalation tactics to be taught and used.
- 3. Require officers to exhaust all other means (including de-escalation tactics) before shooting.
- 4. Ban shooting at moving vehicles in all cases.
- 5. Require comprehensive reporting of all use of force, including pointing a weapon at civilians.

Can I also suggest that we LOOK TO OTHER NATIONS and OTHER POLICE DEPARTMENTS for inspiration for new training and tactics. Why not?

We can do better, and I hope this committee is successful in its mission to improve this situation.

Dear Public Safety and Health Committee,

My name is Stephanie Baghai and I live in District 13 in the City of Milwaukee. I am writing in regards to the current protests occurring within our City and across the nation responding to the murder of George Floyd, demanding an end to police brutality and the systemic racism upon which current policing and so many other systems and policies currently operate within our nation and our own City.

The enactment of curfews, especially without proper notice, is encouragement for police officers to act aggressively and arrest peaceful protestors. It is an inefficient ordinance and should no longer be enacted.

In your discussions about the operational definition of "civil unrest," please understand that the people who have been marching on the streets the past week are peaceful protestors demanding racial justice. Calling the current happenings civil unrest is sending a message loud and clear: the leaders of our City and the MPD care about physical property over Black lives. Property can be replaced. Black lives cannot.

The current enforcement of these peaceful protests by MPD is unlawful and is NOT protecting Milwaukee's civilians. Issuing tickets, citations, and arrests is unlawful. Detaining peaceful protestors without food, water, a phone call, and no rights read is unlawful. The use of tear gas, a chemical banned in war, being used during a global pandemic of a respiratory virus is unlawful. The use of rubber bullets is unlawful. This needs to stop immediately. The residents of our City have a right to protest peacefully in our streets without facing the very same police aggression that they are protesting against.

The City of Milwaukee is reacting to Black pain by calling more police on our communities. This is not the solution.

If you as the Common Council on this committee believe in investing in Milwaukee's communities, especially our Black, Brown, and Indigenous communities, I implore you to demand the Milwaukee Police Department and National Guard end the use of tear gas and rubber bullets on peaceful protestors. It is clear that major reform needs to happen with the policing in our country and in the City of Milwaukee, but the first step is to immediately call on the Milwaukee Police Department to end their use of force on peaceful protestors.

We want our voices heard and an end to these unlawful actions immediately. I am hopeful the committee, who is dedicated to the public safety and health of Milwaukeeans, will agree and will voice these same demands.

**Policing Policy Agenda Discussion Items** 

Hello, Mr. Owczarski,

Thank you for opening the floor to the public as you discuss police policies. After much thought, reflection, and conversation, we have created a list of a few ideas related to your agenda items that we wish to have considered. Please find our points below:

#### Item 1: Circumstances under which a curfew is declared

• In the scenario where a curfew is put into place, the city must ensure that proper notification is sent to the public--via text, public alert, etc.-- with at least 2 hours prior notice.

 When enacting a curfew, additional information needs to be provided surrounding the protocol for people who need to go out for purposes such as work or other essential tasks.

#### Item 2: Policies used to enforce it

 Enforcing curfew should not ever require the use of excessive force via methods such as tear gas, rubber bullets, etc.

• In order to properly enforce a curfew, we need to determine the purpose behind a curfew. If the ultimate purpose centers around public safety and the people breaking curfew are not posing any immediate threat to public safety, then using force becomes superfluous and a reminder that a curfew is in place is all that should be needed.

# Item 3: An operational definition of the phrase "civil unrest"

Civil unrest can be defined as an activity that arises from a large demonstration in which the majority of
participants become hostile in a manner that puts people, property and/or authorities in immediate
danger. It should be made very clear that if a small subset of the group becomes disorderly, this does
not qualify as civil unrest.

Excessive force via methods such as tear gas, rubber bullets, etc. in response to civil unrest is
inappropriate and often serves to worsen the situation, rather than to deescalate it. It is not productive
to meet aggression with aggression when the ultimate goal is peace.

We appreciate this opportunity to share our observations and thoughts on ways to move forward as a greater Milwaukee community. Ultimately, this is about finding solutions that will protect everyone, regardless of race, religion, gender, or any other discriminatory bases. We believe our police force can still serve to protect, but steps need to be taken so that all feel protected instead of targeted. Thank you in advance for the steps you're taking to reach this goal.

Dear Mr. Owczarski,

Thank you to the Mayor, police department and fire and police commission for holding this hearing. You are addressing "the operational definition of the phrase 'civil unrest' and the manner in which it is enforced."

I hope that you agree that the right of the people to speak and be heard is paramount. The recent demonstrations have provided many examples from across the country of how NOT to "police" protests. Unless there is abiding need to protect citizens through a curfew, curfews provide opportunities to interfere with that free speech and should be avoided.

Most of the advances in civil rights in this country have come about through civil disobedience. Therefore, if a curfew is in place, I think the city's handling curfews without arrests (a warning or citation might be a de-escalating response to protesters and bystanders if police find they need to clear an area for public safety) and certainly without chemical weapons being deployed or batons being used is one way to proceed.

The rage at police immunity from prosecution and the killings of black men that have resulted is legitimate. Something needs to change. Has Milwaukee outlawed chokeholds and strangleholds? If not, they must do so immediately. Are Milwaukee police shielded from prosecution? If so, this must change. Is there appropriate citizen oversight of police activities?

Milwaukee needs input from its citizens. I hope the Mayor and police proceed in a way to get that input as soon as possible and in as accessible a forum as is possible now. At the same time, I hope those in charge will examine their policing policies and see where changes can be made.

Having been a resident of southeastern Wisconsin for most of my life, and a resident of Milwaukee for four years, I have seen first hand how the MPD has interacted with poor, primarily black and brown communities for years. The disregard for life that we have seen over the last few days in response to the people's uprising, led in large part by the Black Lives Matter movement, is the most recent example of egregious behavior. As such, the local government of Milwaukee needs to take steps now to radically defund the police.

# Concrete steps could include:

- 1. Suspend the use of paid administrative leave for officers under investigation;

Hello, Mr. Owczarski,

Thank you for opening the floor to the public as you discuss police policies. After much thought, reflection, and conversation, we have created a list of a few ideas related to your agenda items that we wish to have considered. Please find our points below:

# Item 1: Circumstances under which a curfew is declared

- In the scenario where a curfew is put into place, the city must ensure that proper notification is sent to the public--via text, public alert, etc.-- with at least 2 hours prior notice.
- When enacting a curfew, additional information needs to be provided surrounding the protocol for people who need to go out for purposes such as work or other essential tasks.

#### Item 2: Policies used to enforce it

- Enforcing curfew should not ever require the use of excessive force via methods such as tear gas, rubber bullets, etc.
- In order to properly enforce a curfew, we need to determine the purpose behind a curfew. If the
  ultimate purpose centers around public safety and the people breaking curfew are not posing any
  immediate threat to public safety, then using force becomes superfluous and a reminder that a curfew
  is in place is all that should be needed.

# Item 3: An operational definition of the phrase "civil unrest"

- Civil unrest can be defined as an activity that arises from a large demonstration in which the majority of
  participants become hostile in a manner that puts people, property and/or authorities in immediate
  danger. It should be made very clear that if a small subset of the group becomes disorderly, this does
  not qualify as civil unrest.
- Excessive force via methods such as tear gas, rubber bullets, etc. in response to civil unrest is
  inappropriate and often serves to worsen the situation, rather than to deescalate it. It is not productive
  to meet aggression with aggression when the ultimate goal is peace.

We appreciate this opportunity to share our observations and thoughts on ways to move forward as a greater Milwaukee community. Ultimately, this is about finding solutions that will protect everyone, regardless of race, religion, gender, or any other discriminatory bases. We believe our police force can still serve to protect, but steps need to be taken so that all feel protected instead of targeted. Thank you in advance for the steps you're taking to reach this goal.

Hello,

As a Milwaukee resident I want to note by concern surrounding the use of force by the MPD and Sheriff's Department over the last week (particularly on the evening of June 2nd). Their stated justification -- that protestors were throwing water bottles, glass, and a "molotov cocktail" -- is dubious and, if we take them at their word, still does not remotely give cause for tear gassing and firing less-lethal bullets into a peaceful crowd -- two methods of crowd control that have been proven to cause permanent injury.

While the report of an unexploded "molotov cocktail" (which, while I'm extremely skeptical of the claim since the provided evidence does not meet any definition of a molotov cocktail) could justify some crowd control measures, the timeline presented by the MPD on Twitter doesn't make sense. They report that the bottle was thrown after 8 PM, long after they had begun tear gassing and firing bullets into the crowd.

While I don't condone throwing water bottles at police officers, responding to that with dangerous force against an almost exclusively peaceful crowd cannot be deemed acceptable. This event can't be viewed as a one-time "accident", either. These officers willingly endangered the safety of Milwaukee citizens. They undermine the credibility of both the MPD and the city as a whole. If they are not fired the city risks further rupturing the public's trust.

#### Dear committee members,

I would like to address the mayor's curfews. The curfews, as no doubt you have seen now, have been largely ineffective. What the curfews have provided is rationale for further police action against the peaceful protestors, as well as allowing police action against citizens who need to walk home from bus stops, work, or other locations to comply with the curfews. I understand the ideas behind enacting the curfews, but based on the evidence we have seen, they are not effective measures for stopping protestors. Nor should we want to silence the peaceful protestors who are pushing for important police reforms. No more curfews.

Second, I want to address the clear cases of police aggression that have been documented by local activists, politicians, and the media. The police have been documented escalating crises by surrounding protestors, preventing them from dispersing when ordered to do so. Police then use this non-dispersal to justify spraying protestors with tear-gas, which causes more chaos. This is unacceptable behavior. Furthermore, the unacceptable fabrication of evidence (a Molotov cocktail made from a crushed plastic bottle?) is concerning and further demonstrates the police's desire to escalate what have otherwise been peaceful protests. Police Chief Alfonso Morales's management of the department has been unacceptable and he must resign, or at the very least not be reappointed to the position following his performance review.

Third, the constant circling of helicopters overhead is absolutely unacceptable. This is the sort of thing one might expect in a police state (which based on recent actions, we perhaps find ourselves in). Not all of these helicopters are news copters. Some are police helicopters and some are national guard helicopters. These aircraft are disrupting people's sleep, preventing people from feeling comfortable in their own homes, and make citizens feel like they are being constantly surveilled. Stop flying helicopters over our neighborhoods.

Finally, a word about our protests: Milwaukee has had its own share of police murders of black folks that have gone without justice. To protest police brutality only to have the police respond as brutally as they have been is unacceptable and highlights the multitude of ways in which the Milwaukee Police Department desperately needs reform. I am pushing for five easy reforms that will readily make all residents safer:

- 1 Ban chokeholds and strangleholds.
- 2. Require de-escalation tactics to be taught and used.
- 3. Require officers to exhaust all other means (including de-escalation tactics) before shooting.
- 4. Ban shooting at moving vehicles in all cases.
- 5. Require comprehensive reporting of all use of force, including pointing a weapon at civilians.

### Good morning,

I am emailing you my 1st hand experience of what happened at the peaceful black lives matter protest on Tuesday, June 1st at McKinley and 6th. I would like to address the unnecessary and violent force that was used against us. Please let me know if you need anymore information from me. I would also greatly appreciate a response so I know my email made it through to you! Thank you.

I was a apart of the peacful protest that was enticed by police on Tuesday June 1st 2020. Before even getting to the point in which you are discussing on the corner of McKinley and 6th street. I would like to bring up what happened while entering the Hoan bridge.

#### Incident 1:

Protesters had made it on the bridge and were peaful protesting heading south bound. Police ran infront to block protesters from continuing. I could see fatigue and stress in the eyes of the police officers as they ran to get in front of us. As soon and the police officers reached a point in front of us they began to throw tear gas. This caused the crowd to quick disperse and lots of confusion. 100's of people running in all directions some temporarily blinded by the tear gas. This was a terrifying and dangerous situation being on a 120ft tall bridge with 100s of people running to get away from the fumes. Someone could have easily fallen off and. Been killed. I have attached a video of the tear gas pouring off the Hoan bridge after a citizen tossed it to protect the protesters. This happened at 6:30pm

#### Incident 2:

In our second case with the police on Tuesday June 1st we were at the corner of Mckinley and 6th. Their were easily more armed officers than protesters and multiple military tanks. We were headed west down McKinley infront of the free way entrance. The police were blocking the freeway. Protesters got their knees to show we were peacful. Then we got up and decided to head north on 6th street turning our backs and walking away from police. That's when tear gas and gas canisters were thrown again. This caused the crowed to panic and run. We were attacked while retreating. We were able to get away from the gas and then went back on our knees and chanted "We are peacful". At this point an announcement was made by police one time and was not heard. We were unaware of what the police wanted from us. Soon the police linked arms and walked towards us and started chanting "move back" we got off our knees and put our hands up and chanted "we are peaceful" while moving

backwards away from police. One man on a bike who was documenting what was happening through video. He stayed in his place on his bike with both hands on his phone taking a video. For no clear reason one police officer from the back of the line of officers pushed his way to the front. The man on the bike tried to ride away from the panicked officer when he was tackled. The other officers responded by covering and blocking the man so that no one could see what was happening. This can be seen on TMJ4s live thread at 25 minutes in. You can also see several officer reach to stop the panicked officer before they decide to help him take the innocent man into custody. There is no clear reason why the man was being attacked and taken into custody. While this occurred other police officers continued to throw tear gas and shot rubber bullets at the crowed that was retreating with hands up. Several people were shot with rubber bullets leaving welts on their stomachs. This is also seen in the TMJ4 live stream at the 28th min. This incident happened around 8pm.

I believe that the police were acting out of stress and fear and injured several innocent law abiding citizens. The police force needs more training and screenings in how to handle these kinds of stressful situations WITHOUT violence. I am fearful for my city and that the police will kill more innocent people if something is not done. Please help us reform our corrupt system!

#### Good Afternoon,

Thank you for taking the time to ask the people what they believe is the proper course of action regarding our city, curfews, and the definition of 'civil unrest'. First, I think many can agree that the curfew has not been observed and is ineffective in preventing people from leaving their houses to protest or otherwise. What it does appear to do is reinforce the public's opinion that the law enforcement in their communities are looking to quash down their rights to demonstrate and limit their rights to freedom of speech within the commonly accepted "public forum". I do not believe suspending bus services is a good idea, as many of our community members rely on bus transportation, and have a right to safe transit through our city. The suspending of the bus service has been overwhelmingly viewed as a direct attack on the rights of Milwaukee citizens, and further evidence of law enforcements intent to inhibit the public's first amendment rights. These actions encourage distrust within the very community petitioning to be heard by law enforcement, and will more than likely be a major setback for keeping the peace in Milwaukee.

Naturally, the topic of 'civil unrest' comes out of these issues. The city, our communities, the country as a whole is hurting. The tactics the police use to 'protect' and 'keep the peace' are anything but peaceful. You cannot show up to a protest under the guise of "keeping the peace" while dressed for a fight. The outcry of rage and distrust from our communities is palpable at these demonstrations when peaceful protesters are met by officers in riot gear carrying weapons that many can't even identify, purchased by our tax money from wholesale military auctions. Seeing those who are charged to "keep the peace" roll in on their armored vehicles with weapons drawn and directed at those watching is nothing but fodder for potential civil rights violations. Having officers obstruct their badge numbers or shoulder cams by any means is a sign that they no longer are seeking to keep the peace and serve their citizens, and the evidence of this abuse is compiling rapidly by legal observers and the protesters themselves. This is not keeping the peace, this is inciting civil unrest, this is encouraging the public to distrust law enforcement, and this can no longer be tolerated.

The community is watching, collecting evidence of abuse of power and building cases to see social change. Organizations like the ACLU are being handed evidence of police abuse on a silver platter by the rampant use of extreme force. We are in the middle of a pandemic, and any aggressive tactics used such as tear gas can exacerbate the symptoms of Covid-19 in carriers, and doctors around the country are aware of this and petitioning law enforcement to use peaceful means to disperse a crowd. The gross abuse of power is evident and documented, and now would be a good time to address the situation before things get worse and our community is injured further both physically and in their ability to rely and trust in law enforcement.

#### Good morning,

My name is Dan Chojnacki, I am a 36 year old White man and mental health counselor living and working in the City of Milwaukee since 2008, and I have lived in Milwaukee County for all but 6 years of my life.

I am committed to the present movement to erase racial injustice, starting with ending the role of Milwaukee's police force in perpetuating into the present day the legacy of slavery, jim crow, segregation and most importantly, the deeply ingrained cultural bias that Black persons are less than fully human, upon which our nation's society and economy were founded, and which must be ripped out by the root everywhere it grows.

While I recognize that broader solutions related to access to quality education, health care, jobs, and safe communities must accompany radical changes in policing, at this point we can no longer turn away from the central role that over-policing plays in both threatening innocent lives and stifling dissent within a society that desperately needs protest at this time to survive the existential threat posed by Trump and his allies.

I am disgusted to see our taxpayer funds deployed via militarized police presence at protests to brutalize peaceful protestors, apparently trying to make an example out of these fearless youth and adults willing to risk their own safety to fight racial inequality and racist violence BY THE POLICE! How is it that in 2020, we have learned so little about police being a support to the community, rather than a threatening presence? How do we not see that even police officers themselves are placed in grave danger by operating from a warrior mentality instead of a community building, servant leader mentality?

Efforts to reform our police department through existing channels like advanced training and accountability through the Fire and Police commission have failed for far too long to be seen as a credible path to meaningful change in the violence perpetrated against Black and Brown communities by police who are rarely disciplined, let alone fired, charged or convicted. The complicity of the three officers who abetted Chauvin in murdering George Floyd on May 25, 2020 says just as much about the culture of policing as Chauvin's actions do.

The trust has been broken. The time has come to recognize that simply characterizing police brutality as the work of a few bad apples does not begin to account for the culture of racism, brutality and militarized engagement in our most vulnerable communities that has come to characterize our police force, and police departments across the country.

Leaders across the political spectrum have visibly acknowledged both the grotesque violence of George Floyd's murder by officer Derek Chauvin and the righteous pain, anger and demands for meaningful change from the Black community and allies. Nonetheless, police forces have consistently played the role of antagonizing protestors carrying the same message as these elected officials into the streets, and police have consistently escalated peaceful protests into violent clashes, even further obliterating any semblance of trust that might still remain with the community. In repeated displays of gross incompetence and aggression, police have beaten, tear gassed, and drawn weapons on peaceful protestors protecting our constitution and our society when those elected to protect it have failed.

I call on the leaders of conscience in this city to immediately fire Chief Morales, remove all police from schools, cut the police budget in half, and invest these much needed funds where they can actually build our community, instead of attacking it: in anti-racism initiatives, improved social services like trauma counseling, restorative justice practices in schools, support for healthy families, and economic solutions led by persons of color.

We do not need these changes tomorrow or next year, we need them today. We are already more than 400 years overdue, and again today, and tomorrow, and the next day, real humans will suffer at the hands of our current system, until it is dismantled.

I remained silent, and in the days since then I've realized that I should have immediately echoed her sentiment, so I am doing it now. Tom, Milwaukee needs to hear your voice.

Milwaukee needs its leader. I need you to be the loudest voice advocating change in response to these protests. I need you to be willing to change.

Milwaukee has the potential to become one of the greatest cities on the planet. You and I love this city just as much, if not more, than anyone else that lives here. It will never realize its full potential on its current path. Milwaukee could become a beacon of hope for the rest of the world to follow. Milwaukee, and the entire world, needs to hear your voice.

I'm writing in response to your statement on May 30th. I agree with most of the things you said in that statement, but I'd like to help shift your focus slightly. I've had to do this with my own father, and with many other older European Americans this past week.

In your statement you said "To all those individuals who are angry about what they saw in this country, I share that anger. But, we cannot allow it to just be a moment of anger. It has to be a moment when we come together and say we will create more jobs, we will have more stable housing and we will address healthcare needs so that African American individuals can have a better life."

Now, while I don't disagree with any of that, I do hope to help you see that you're focusing on the wrong issue right now. Individuals are angry because so many immoral and illegal things go unchecked by law enforcement. This is the moment when we come together, not to say let's create jobs, fair housing, and better healthcare. That needs to happen, but this is the moment when we come together to say "We need law enforcement to be held accountable for immoral and criminal activity. We need law enforcement to be better at protecting and serving the city." I need to hear your voice say that.

Your statement went on to say "We cannot allow what happened to Mr. Floyd, these injustices which are real, which are angering and which are frustrating, to be defeated by people who are violating the law and destroying property in our neighborhoods. If we take businesses away from the good people who live in our neighborhoods, or if we allow others to take them away, who are we hurting?"

Again, I'm concerned about where you are focusing the conversation. Of course I agree that violating the law and destroying property is wrong and counterproductive. It pains me greatly to see violence, property damage, and unlawful activity negate the work of the peaceful protests. No citizen or small business owner should have to live in fear of destruction or violence here in Milwaukee. What I would like to hear your voice say in the future is "We cannot allow what happened to Mr. Floyd, these injustices which are real, which are angering and

which are frustrating, to be defeated by law enforcement officers who are violating the law and protocol in our neighborhoods. If we do not hold these people accountable for their actions, who are we hurting?"

I do not envy you or your job today. I know you're under tremendous pressure to keep the community safe in the face of a global pandemic, to help reopen businesses, and to address the concerns of these protests. I need you to be successful at your job.

I'm hearing a lot of concern about the decision to reopen bars this week as a distraction from the protests. Whether or not that's true, I need to hear your voice say that decision was not a diversion tactic, and that you will make some real change happen regarding the protests. I know yesterday you announced the creation of a commission to help you. I need you to act with the full authority of your office to show Milwaukee that you are fighting as hard as you can for them. It's going to take all your courage, and balls, to make a stand for morality in the face of institutional law enforcement habits. For the love of God Almighty, use what he gave you Tom.

If you don't step up and make your voice loud in this historic moment, there are other patriotic citizens and public servants ready to step up. This city just reelected you, please do everything you can do be its leader.

Also, it would be great if you could help get Frank Nitty II's felony charges dropped from earlier this week. He's leading peaceful, lawful protests and I don't appreciate the way he's been treated by law enforcement.

My name is Cara Cribari. I am writing to you as a citizen of Milwaukee, Wisconsin in regard to the violent response from the Milwaukee Police Department during peaceful protests and other affairs that require police presence.

I urge you to change policing policies in order to appropriately and effectively protect and serve our community. Data proves that together, the following eight policies can decrease police violence by 72%. Here are the eight policies that must be implemented immediately.

1. Ban chokeholds and strangleholds.

- 2. Require de-escalation to allow officers more time, distance, space, and tactical flexibility during dynamic situations on the street.
- 3. Require warning before firing ANY weapon (automatic weapons, mace, rubber bullet rifles, teargas, etc.).

4. Exhaust ALL other means before firing ANY weapon.

#### To Whom this May Concern,

My name is Sara Cuadra and I am medical student living in Milwaukee. I have been deeply disturbed by law enforcement's response to peaceful protesting and value of the Black Lives Matter movement in Milwaukee. Racism is a public health crisis and nowhere is this more relevant than in Wisconsin where "as of the 2010 census, Wisconsin had the highest incarceration rate of black males nationwide, locking up 12.8 percent of black male residents compared to the country's 6.7 percent average at that time" and "more than half of all African-American men in their thirties and early forties in Milwaukee County have at some point been incarcerated in state correctional facilities, according to a 2013 University of Wisconsin Milwaukee study." The American Journal of Public Health published a study in 2018 that concluded "police homicide risk is higher than suggested by official data. Black and Latino men are at higher risk for death than are White men, and these disparities vary markedly across place."

It is the Milwaukee Police Department's job to protect and serve the people, but when the majority of people are Black and are facing discrimination and unjust practices by the MPD how can this be? I hear the argument to defend the women and men who risk their lives everyday by serving in the MPD but I ask you to consider the Black women and men who put their lives at risk every time they interact with an officer. In light of this I ask that you support the following reform measures as drafted by another classmate:

- 1. Stricter measures to require that all police force (not just deadly force) be reported and reviewed by independent agencies rather than supervisors within the department.
- 2. Banning the use of choke-hold, strangle-hold, and other pressure on the neck.
- 3. Preventing the use of police force unless there is a threat to human life or health. The assault on peaceful protesters that I have witnessed in Milwaukee is unacceptable for a department that has vowed to "protect and serve."
- 4. Defunding and demilitarizing the police force. The enormous budget of our police system is unnecessary and can be put to better use revitalizing disenfranchised communities across Milwaukee.

As someone who will be a practicing resident physician a little over a year from now and working to protect the health of Black and Brown bodies, I ask that the MPD does the same.

Thank you for taking questions on this important issue. My husband and I live in Bayview with our young child. We both work in the city of Milwaukee. We were not born and raised here, but have both come to love the city we've chosen to make our home. I'm deeply concerned about the use of force, including chemical weapons, against our citizens. For the safety of my daughter, who is a young innocent child and my husband who has asthma, along with countless others whose safety is threatened by police conduct, I must demand police, national guard, sheriffs, and any other security force to cease using brutal weapons of war like tear gas. Use of these weapons must be investigated, and if the Chief or other authority insists on authorizing their use, they must be removed.

I am against any and all curfew or emergency rule that allows for the use of force in any event or individuality pursuing the cause of justice for peace. I refuse to be 1- bound to my own home in my neighborhood while my neighbors are crying for help 2- used as a prop - read: property owner - to justify police harassment and brutality.

Additionally, I must demand the firing of Mr. Mattioli who has been charged in the reckless homicide of Joel Acevedo. If the Chief will not or cannot fire Mr. Mattioli, it is this commission's duty to do so now. The additional delay in his termination will almost certainly increase the pressure of the civilian protests for police reform and or abolition.

Finally, please work to remove armed patrols from our streets, not just when we are upset we have allowed another black person to be brutalized or murdered, but always so that we are free from fear of them. Please push to remove the national guard and other security forces from our streets. Black helicopters circle our neighborhoods and terrify our children. Please work to stop the terror committed by our police forces and military forces on our communities.

I'm certain this is a better choice and will produce more peace than pursuing a further hoarding of power and wealth in police institutions so they can continue to protect the wealthiest and whitest of society from the poor black and brown folks they stole it from. This is the end effect of any curfew, emergency rule, or armed patrol that is designed to police our neighborhoods.

These aircraft are disrupting people's sleep, preventing people from feeling comfortable in their own homes, and make citizens feel like they are being constantly surveilled. Stop flying helicopters over our neighborhoods.

Fourth, the violence inflicted on members of the media by the police, witnessed around the country as well as in Milwaukee, must stop. It is the duty of the press to report on the protests and other public events in order to shed light on the messages and actions of all involved. This is constitutional matter, protected under the First Amendment of the United States, and cannot be infringed.

Finally, a word about our protests: Milwaukee has had its own share of police murders of black folks that have gone without justice. To protest police brutality only to have the police respond as brutally as they have been is unacceptable and highlights the multitude of ways in which the Milwaukee Police Department desperately needs reform. I and others are pushing for five easy reforms that will readily make all residents safer:

- 1. Ban chokeholds and strangleholds.
- 2. Require de-escalation tactics to be taught and used.
- 3. Require officers to exhaust all other means (including de-escalation tactics) before shooting.
- 4. Ban shooting at moving vehicles in all cases.
- 5. Require comprehensive reporting of all use of force, including pointing a weapon at civilians.

Additionally, we need to reduce funding for the police department and redirect that funding towards community development and restoration in order to repair the communities that police brutality has devastated. Particularly, this money needs to go towards assisting the black communities the police have been brutalizing for years.

Marina, thanks for posting the note to get some feedback to the City Clerk by Friday at 2:30 p.m. I just wanted to message each of you personally. Marina, I live at 2354 S. Howell. Jose, thanks for all of your support for our students over the years.

As a resident of MKE and a school principal, I am constantly at a loss for the gap between **restorative practices** as a proven psychological method for justice and healing and **punitive practices** a proven method of escalation and making small things really big.

I'm constantly training myself as both a foster parent and educational leader to be more restorative rather than punitive. Across the board, this is a key. The only limit is me.

Over and over again, I see our police doing well at this in peace time. This is not the case in times of stress such as the last two weeks. Yesterday, I witnessed a group of protestors peacefully approach a line of state and city police to ask them questions and engage them in a restorative conversation. The police remained silent, refused response, and refused eye contact.

Protestors displayed a valid and positive intention for restorative conversation. In return, they were silenced. I have no idea what the intentions of the police in that line were. But, I witnessed first hand the effect that their silence had on the crowd: To not affirm or even acknowledge the voice of the angry crowd, infuriated them even more. The police single handedly sustained and exaggerated the sense of "us vs. them" that pre-existed the moment. The protesters created the conditions to absolve that sense. All the police had to do was acknowledge.

What I'm looking for is more upward pressure from you, our mayor, and then back down to our police to be the restorative, front lines, support systems needed. If this is possible, true listening could transpire. If not, I am confident the outrage will only expand. Happy to share more on how this change could transpire from a leadership and restorative justice perspective.

I am emailing to tell my account as well as provide a video showing the inappropriate use of police force that took place on Tuesday, June 3rd starting around 7:15 at 6th St and McKinley Ave.

When we were gathered, I remember hearing the police making some sort of announcement, but not being able to hear what was being said, despite being towards the front of the protesters. I later found out they had announced that we were 'unlawfully' gathering, and ordering we disperse, but most of the crowd was unable to hear the announcement. Shortly after, smoke bombs were fired at us, as well as projectiles. At around the 0:30 mark in the video, as protesters are attempting to help an injured fellow protester, we are even more aggressively shot at once again (not everyone knew the difference between smoke bombs and tear gas). I know I only saw a couple plastic water bottles thrown, nothing else. This level of force was completely unprovoked and unacceptable. The other video I have attached, in which we are kneeling to show we are peacefully protesting, takes place less than two minutes before the video in which we are attacked.

Hello, Mr. Owczarski,

Thank you for opening the floor to the public as you discuss police policies. After much thought, reflection, and conversation, we have created a list of a few ideas related to your agenda items that we wish to have considered. Please find our points below:

#### Item 1: Circumstances under which a curfew is declared

- In the scenario where a curfew is put into place, the city must ensure that proper notification is sent to the public--via text, public alert, etc.-- with at least 2 hours prior notice.
- When enacting a curfew, additional information needs to be provided surrounding the protocol for people who need to go out for purposes such as work or other essential tasks.

#### Item 2: Policies used to enforce it

- Enforcing curfew should not ever require the use of excessive force via methods such as tear gas, rubber bullets, etc.
- In order to properly enforce a curfew, we need to determine the purpose behind a curfew. If the
  ultimate purpose centers around public safety and the people breaking curfew are not posing any
  immediate threat to public safety, then using force becomes superfluous and a reminder that a curfew
  is in place is all that should be needed.

### Item 3: An operational definition of the phrase "civil unrest"

- Civil unrest can be defined as an activity that arises from a large demonstration in which the majority of
  participants become hostile in a manner that puts people, property and/or authorities in immediate
  danger. It should be made very clear that if a small subset of the group becomes disorderly, this does
  not qualify as civil unrest.
- Excessive force via methods such as tear gas, rubber bullets, etc. in response to civil unrest is
  inappropriate and often serves to worsen the situation, rather than to deescalate it. It is not productive
  to meet aggression with aggression when the ultimate goal is peace.

We appreciate this opportunity to share our observations and thoughts on ways to move forward as a greater Milwaukee community. Ultimately, this is about finding solutions that will protect everyone, regardless of race, religion, gender, or any other discriminatory bases. We believe our police force can still serve to protect, but steps need to be taken so that all feel protected instead of targeted. Thank you in advance for the steps you're taking to reach this goal.

Yet, what I see is an extreme bias from the police not only to be selective in that safety, but also to completely disregard it for peaceful protesters, and even to directly harm them.

"I no longer trust the police." - My father, a former civilian LEO and a veteran MP for the United States Air Force

My partner and I have watched the video and feeds for the last week with anxiety. Law enforcement officers brutalizing their own citizens. Fargo, Buffalo, Atlanta, Seattle, LA, Milwaukee, Chicago, Minneapolis, the list goes on. No state has escaped the fervor felt by the death of George Floyd. I've watched journalists arrested live, shot at. Protesters have lost eyes due to "non-lethal" rounds. People have been shot on their own porch by patrols. The citizens of Milwaukee has been terrorized by helicopters buzzing their rooftops. This is a military tactic. They want us tired, either too tired to fight or too tired to work that we blame those actively protesting. We have no choice but to feel we're under occupation. This is not our city, but law enforcements.

This can no longer continue. We cannot be held under siege in our homes by individuals that act under the guise of protecting us. They're not protecting us, but themselves. Increasingly military like aggression and tactics have been used to train officers. They answer peace with punches. They aggressively police neighborhoods of color and wonder why citizens aren't forthcoming with investigative information. They arrest MPS students and wonder why our students aren't achieving high marks. POC especially are under the constant shadow officers from the cradle to the grave and we wonder why they're traumatized.

We as a city need assurances that this brutality, this intimidation will stop. That police will not be used to monitor our schools. That they won't be used aggressively for low-level drug offenses. We will not be placated. This is not a job where "bad apples" can exist. There needs to be top to bottom reform on how we view the role of police in our society. If policing as it currently stands in the United States and the city of Milwaukee is to be rewritten, they need to be extensions of communities. Not the enforcers. More officers need to live in the city limits. Officers cannot maintain immunity to punish citizens with impunity.

What are you going to do as a Common Council to ensure that these needs are addressed and met for the future? How can you make sure we feel safe from those who do us harm backed with the badge?

## To Whom it May Concern,

I am writing today to discuss the question of a when and if curfews are appropriate for dealing with city emergencies.

Curfews, unlike lesser measures such as "stay at home" orders, are extreme violations of the freedom of expression, association and individual liberty. As such, their use must be rare.

The City's use of measures like curfews must be extremely conservative -- they must only be used in emergencies where their use will diminish rather than exacerbate emergency conditions.

Extensions of curfews: since curfews are such an extreme violation of constitutional liberties, their extension must be the subject of public and democratic debate. While the initial use of curfews may require executive action, any extension of such an extreme measure must be open to public debate.

The curfew passed last week in Milwaukee is one that did not meet the requirements of such an extreme measure. The curfew did not stop the so-called emergency conditions in question, nor did it improve conditions on the ground. That the curfew exacerbated existing emergency conditions is clear through the arrest of at least one County Supervisor and dozens of others whose only crime was being out after the time of the curfew. These curfew-induced actions exacerbated the existing public health crisis (COVID-19) and the existing political problem in Milwaukee and in the United states of police brutality, lawlessness and unaccountability to civilian authorities. Extreme uses of governmental power undermine rather than support the rule of law and the safety of the people.

The extension of the curfew, and the mayor's threat to extend the curfew at short notice on Tuesday (6/2) were extremely poor examples of good governance. Uncertainty exacerbates public trust and the non-democratic extension of the curfew invites worries of authoritarian executive powers. This is precisely what happened.

We have a further issue with the secondary harms of curfews and declaring emergencies, which is the de facto expansion of powers, lack of oversight, and calling in of undertrained reserve police forces (from other jurisdictions, for example). Each of these caused harm.

Expanding the police presence in the city of Milwaukee by calling in police from jurisdiction far from the city of Milwaukee has led to even further problems with racial discrimination and violence by police. The incident of the Sheriff's department brutalizing Frank Nitty is a good example of this.

We have a police brutality and police racism problem in Milwaukee -- that is an emergency, but it's not one that is served by a curfew. Our democratic political structure, which underwrites the rule of law is shaken when executive authorities misuse their power and seek to curb liberty through the threat of emergency.

Again, the conditions for using emergency powers must be extremely limited: curfews must only be used in emergencies wherein their use will diminish rather than exacerbate emergency conditions.

Greetings City Clerk Jim, members of Common Council and Public Safety and Health Committee:

It is my understanding that a special committee meeting is being held. I, like many others in my neighborhood, am extremely concerned about the police response to the protests/peaceful approach of those who are engaging in these events.

I have been horrified by the violent and militarized response of the police to the protests over the last several days. Can we do away with military helicopters, tanks in the streets, full riot gear, rubber bullets, and tear gas?

On a personal level, as someone living in the Riverwest neighborhood, I have been feeling as though I live in a military warzone over the last several evenings. For hours at a time, very large helicopters (not local news choppers) circle and hover over our houses with sounds and vibrations that are extremely anxiety-provoking. For what reason? I cannot think of one other than what seems to be an aim to exert unecessary authority over people who are doing nothing unlawful. It sounds intense, violent, and scary.

In addition, there have been claims that protesters threw glass and dangerous items at the police lines, which has led to a response of rubber bullets and tear gas. Yet, news and other first hand live videos of this highlight that these protests have been peaceful and not throwing dangerous items. Again, it seems the police are resorting to tactics that exceed the aggression necessary with an aim to incite fear.

People are taking to the streets in support of the unjust killing of George Floyd, yet also the too many long-standing systems and circumstances in place that discount the rights of our black citizens. It's present right here in our Milwaukee community, not just beyond the city elsewhere. I do not discount that there needs to be a response to protests, and there needs to be a police system in place. Hi Jim.

I want to express my outrage as a resident of Milwaukee in the 53202 zip code regarding Milwaukee's use of curfew and militarized police presence to control our civil right to peaceful assembly and freedom of speech.

Municipal tickets can have a life changing negative impact on low income communities, who disproportionately are black and brown communities. The fines associated with tickets can plunge a person into poverty or hold them there. The very communities who are speaking out against the injustices they are shown due to systemic racism in institutions, such as local government and the police, are the same communities that are most negatively impacted by these tickets. It is transparent that this is a cruel tactic to further silence and oppress these communities by turning what is a civil right to peaceful protest into a violation.

Furthermore, the militarized way you are deploying the police force on people after curfew is shameful and the exact reason these people are in the streets in the first place. It is clear that increased police and National Guard presence heightens tensions and causes violent outburst. Our police force and National Guard is not trusted by the people, nor should it be. Until you address the issues that are at the root of these demonstrations, the police and National Guard presence will be unwelcome and counter productive to keeping the peace.

In addition, closing the bus routes at night is a health and safety risk for evening and night workers who had no notice and were likely already at their places of work and may now be stranded. Just another example of something to harm the communities who are simply trying to point out how you harm them and ask you to stop. It's cruel and shameful.

Last for this message but not least for your transgressions, opening up bars and restaurants with little notice, clarity, guidelines, or reason during this pandemic is another clear distraction aimed at getting people off the streets.

You are viewing those who are simply asking to be treated as human as your enemy. You are taking coordinated steps to limit and decrease their health and safety. This moment will go down in history. How will you be remembered?

I hope you consider changing your practices. As the body tasked with considering our health and safety, you have failed us. It is time to own your failure and commit to doing better.



## Dear committee members,

First, I would like to address the mayor's curfews. The curfews, as no doubt you have seen now, have been largely ineffective. What the curfews have provided is rationale for further police action against the peaceful protestors, as well as allowing police action against citizens who need to walk home from bus stops, work, or other locations to comply with the curfews. These curfews are an action to take away the right of the peaceful protestors to do just that, peacefully protest, and who are pushing for important police reforms. No more curfews.

Second, I want to address the clear cases of police aggression that have been documented by local activists, politicians, and the media. The police have been documented escalating crises by surrounding protestors, preventing them from dispersing when ordered to do so. Police then use this non-dispersal to justify spraying protestors with tear-gas, which causes more chaos. This is unacceptable behavior. I myself have witnessed and taken videos of such actions. Furthermore, the unacceptable fabrication of evidence (a Molotov cocktail made from a crushed plastic bottle?) is concerning and further demonstrates the police's desire to escalate what have otherwise been peaceful protests. Police Chief Alfonso Morales's management of the department has been unacceptable and he must resign, or at the very least not be reappointed to the position following his performance review.

Third, the constant circling of helicopters overhead is absolutely unacceptable. This is the sort of thing one might expect in a police state (which based on recent actions, we perhaps find ourselves in). Not all of these helicopters are news copters. Some are police helicopters and some are national guard helicopters. These aircraft are disrupting people's sleep, preventing people from feeling comfortable in their own homes, and make citizens feel like they are being constantly surveilled. Particularly at a time when they are screaming, begging, to be listened to. Stop flying helicopters over our neighborhoods.

Finally, a word about our protests: Milwaukee has had its own share of police murders of black folks that have gone without justice. To protest police brutality only to have the police respond as brutally as they have been is unacceptable and highlights the multitude of ways in which the Milwaukee Police Department desperately needs reform.

The current enforcement of these peaceful protests by MPD is unlawful and is NOT protecting Milwaukee's civilians. Issuing tickets, citations, and arrests is unlawful. Detaining peaceful protestors without food, water, a phone call, and no rights read is unlawful. The use of tear gas, a chemical banned in war, being used during a global pandemic of a respiratory virus is unlawful. The use of rubber bullets is unlawful. This needs to stop immediately. The residents of our City have a right to protest peacefully in our streets without facing the very same police aggression that they are protesting against.

Additionally, we need to reduce funding for the police department and redirect that funding towards community development and restoration in order to repair the communities that police brutality has devastated. Particularly, this money needs to go towards assisting the black communities the police have been brutalizing for years. Our city needs a change. Defund the police and introduce substantial reforms to make our communities safer.

The City of Milwaukee is reacting to Black pain by calling more police on our communities. This is not the solution. Please LISTEN TO and ENGAGE WITH the community you are representing.

## Good morning,

I am a constituent of Milwaukee emailing in regards to today's public health and safety committee meeting discussing the role of the Milwaukee police department in peaceful protesting.

Thus far the role of the MPD has only been to intimidate and instill fear in the hearts of protesters completely in their right to speak out against the senseless murder of Black people and endangering of Black communities. We were tear gassed while kneeling and shot with rubber bullets. Police continually trapped us and utilized the National Guard for no reason that I could see. Wednesday night, one young man was hit by a squad car and suffered three broken ribs and a broken pelvis. Another night several friends of mine were arrested across the street from their house going home. And yes, they were all people of color. I am disgusted by how we have been met with violence from the police when they are supposed to protect our right to protest.

In addition, the use of tear gas is inexcusable at any time but especially during a global respiratory illness pandemic. The use of tear gas puts vulnerable communities at risk by causing inflammation in the lungs that can worsen health outcomes for COVID-19. Let alone that Black people already die from COVID-19 at 3x the rate of White people. Milwaukee is THE MOST SEGREGATED CITY IN THE UNITED STATES and our most vulnerable communities are constantly policed. Every single individual in Milwaukee deserves safety and the police are NOT keeping them safe. Ever since the beginning of the quarantine I have seen police pulling people over without masks and standing close to people, including during protests. The MPD is showing up to protests dressed in riot gear when no riot occurs and they are inciting violence.

Finally I come to the fact that the MPD lied about molotov cocktails being thrown at them. I was present for the moment that they claimed a molotov cocktail was thrown. Yes, white people were throwing water bottles. But these were water bottles full of water and posed no serious threat to police officers. If the MPD is sworn to risk their lives to protect us, then why were they so quick to jump to violence at a simple water bottle? And why, then, were they so peaceful when crowds of White people swarmed the capitol armed with rifles to protest orders to remain inside due to COVID-19? White supremacy, institutionalized racism, and racism deeply ingrained in the police force.

I stand with the people of Milwaukee in demanding that the police allow peaceful protests without gathering the National Guard. We demand that tear gas use be eradicated, particularly in the time of a global pandemic. We demand that no curfew be imposed as this is simply an excuse to arrest innocent protesters and use unnecessary violence. We demand that the Milwaukee Police department be defunded and that these funds be allocated towards community services that provide housing, education, and mental health services. We demand that the MPD be removed from MPS systems as they are only there to service the school to prison pipeline.

We will not rest until the people of Milwaukee are entirely safe. Black Lives Matter.

I'm Mitchell Henke, a resident in your district. I'm writing to you as a response to the request for public comments for today's meeting of the Public Safety and Health Committee meeting about the Milwaukee Police Department's response to the recent protests.

The City of Milwaukee's and the Milwaukee Police Department's response to implement curfews curbing civil protests, sending military helicopters to circle over the city, and tear gassing peaceful protestors is abhorrent and they have yet to answer for any of it. MPD has also falsely claimed protestors threw a "molotov cocktail", but there is zero evidence it was any more than a water bottle and water filter. Residents are protesting these abuses and lack of accountability, and MPD have not responded with any understanding of that.

The Milwaukee Police Department commands a budget greater than the city's property tax levy, and the MPD budget is set to grow tens of millions more in 2023. Their budget dwarfs that of the Health Department by more than 20 times. The police have the budget to quickly deploy dozens of officers in full riot gear to a peaceful protest to tear gas them. The Health Department was only able to set up a handful of testing centers a number of weeks into a global pandemic that's killed hundreds of disproportionately Black and Latino residents. Our city's priorities are extremely far off, and our budget shows it.

As the chair of this committee, you should be listening to and implementing the demands from community groups like Leaders Igniting Transformation, the African-American Roundtable, and Black Leaders Organizing for Communities. These demands include shifting \$75 million from the Police Department into public health and housing and respecting and ensuring no harm comes to protestors. Two days ago, on June 3rd, 2020, an armed white supremacist group was spotted at a Black Lives Matter protest on Prospect Ave. They identify themselves as the "boogaloo movement," a far-right extremist movement. According to the Anti-Defamation League, the "boogaloo" typically promote their movement as a war against liberals. They also promote their movement as a race war or a white revolution (1). The members of the movement, "Boogaloo Bois," (2) identify themselves with military fatigues, weapons, and "Hawaiian" print. These "Boogaloo Bois" were in attendance at recent Black Lives Matter protests. Attached are images taken of them on Prospect Ave. I have attached the photos from the protest below.

As City Clerk, I ask you to forward this concern to the Public Safety and Health Committee for their meeting on June 5th, as this is a public health concern. Ensuring that the boogaloo's presence persists at Black Lives Matter protests endangers marginalized groups, especially black people. If the safety of people of color is a concern to you, I would like to have these questions answered after the meeting: Will the presence of armed extremists be tolerated? What will the City of Milwaukee do in regards to this situation? Will the City of Milwaukee ensure that these Boogaloo Bois are removed from public demonstrations, to ensure the safety of marginalized communities?

Dear Sir, please address the following during today's proceedings:

1. The use of rubber bullets and tear gas as a standard operating procedure for peaceful protests. This occurred without provocation prior to curfew hours and is utterly unacceptable. Use of tear gas in warfare, as with all other chemical weapons, was prohibited by the Geneva Protocol of 1925; why is it allowed domestically?

2. The incessant and ominous hovering of military helicopters over densely populated residential areas during the evening, making sleep impossible due to the noise of rattling windows and the stress of a

militaristic presence.

3. The police response has not been one of problem solving, conflict resolution, or community building.

Please tell me why our city government has allowed this to happen.

4. The use of 'kettling' to trap protesters who have not been violent. Protesting is allowed so why is it being treated as a criminal offense? Why not allow them to disperse naturally? It appears to be a deliberate escalation and intimidation tactic by the police.

5. What our city needs is trust building. What are your intentions for regaining the trust of our

community?

- 6. Why were protesters retained and held without masks and in close proximity during a global pandemic? What wasn't more care exercised in protecting their health and the lives of all those they encounter?
- 7. How are you holding yourselves accountable for the civil unrest we are currently experiencing?
- 8. How are you addressing the systemic toxicity that leads to police brutality? How are the mental health requirements of a person in such a role being protected? Are we offering positive role models and solutions that equip officers to diffuse tense situations without resulting to force? Are they trained to recognize their own limitations and inclinations to succumb to a mentality defined in the Stanford Prison Experiment?

Please know that I understand the complexity of the questions I have posed but it is your duty to uphold the health of all people in this city and I expect more from you than boiler plate language and defensive tactics. I want real work done here, work that can redefine the narrative of our city. Work that includes all and respects all and is transparent and honest.

It is time.

#### Hello

My name is Nicole Hughes and I am emailing you in regards to the policies and police intervention tactics that have been used in light of recent events to stop peaceful protestors. The excessive use of force I have witnessed firsthand is not only jarring, but unconstitutional. These people have gathered peacefully to protest police brutality, and is being met with even more police brutality. These citizens are well within their First Amendment rights and are being met with tear gas, which is a WAR CRIME and the use of it was prohibited in the Geneva Protocol of 1925. How can you justify banning it in international warfare but continue to use it on your own citizens, on their own streets, while they fight for the right to breathe, DURING a global pandemic with a virus that attacks the respiratory system? Genuine question.

I have watched time and time again, as another unarmed black person is killed by police and the officer gets paid administrative leave while they "investigate". Usually coming up with several excuses as to how the person either a) deserved it or b) it was "inevitable" anyway due to "health issues". To that, I say no more. No more tax dollars being used to keep these murderers from behind bars. No more use of excessive force. No more innocent black lives being lost over a "counterfeit" \$20 bill (George Floyd), attending a social gathering (Joel Acevedo), existing in your own home (Breonna Taylor), a traffic stop (Sandra Bland. Philando Castile.) and many other horribly unjust "reasons". How is it that police can take extreme threats like Dylann Roof into custody without a scratch, and we have black and brown people out here begging for their lives over a routine traffic stop for speeding?
