This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 04/25/07 at 2:58 am, Milwaukee Police were dispatched to 5806 N 76<sup>th</sup> Street for a Armed Robbery Complaint. Investigation revealed that earlier, at about 1:30 am, the victim was at the gas station at 2707 W Burleigh getting gas and when he was getting back into his car, three men entered his auto and one held a gun to his back demanding the victims car. Officers spoke to the gas station manager who stated he was unaware of the robbery. Officers were able to view videotape that the manager provided officers.
- 2. On 04/27/07, Milwaukee Police along with an agent from the Department of Revenue were conducting tobacco enforcement investigations at 2707 W Burleigh. The agent found that there were no invoices for the cigarettes or blunt wraps. Some of the stamps were unreadable on the boxes of cigarettes. The agent confiscated the above items.

3. On 07/24/08 at 4:26 pm, Milwaukee police were conducting sales of tobacco products to underage persons and had a 15 year-old subject enter 2707 W Burleigh. The clerk, later identified as Asghar Choudry, sold a pack of Newport 100's without first asking for any ID. Choudry was uncooperative with police and at first refused to provide his ID when asked by police. A citation was issued to Choudry for Underage Tobacco Sale.

4. On 02/27/08 at 1:17 pm, Milwaukee police were dispatched to 2707 W Burleigh Street for an Armed Robbery complaint. Investigation found the victim pumped gas and left his car running while he ran inside to pay for gas. As the victim exited the store, he observed a subject running towards his car when the victim approach said subject, the subject then pulled a gun and pointed it at the victim firing several times but no shots were fired. The suspect then entered the victims' car and fled the scene. No injuries were reported.

#### Disposition added to item #3 02/19/2010

- 5. On 02/21/2009 at 1:43am Milwaukee Police, while on routine patrol, were flagged down by a citizen in the parking lot of the business at 2707 West Burleigh Street (A and I Petroleum). The citizen informed officers that he had observed 3 subjects running through the yards away from this location and that one of the subjects appeared to be armed with a handgun. Investigation revealed the business had been robbed at gunpoint (the weapon used was a BB gun) and that three actors had fled on foot. Police incident report #090520032 filed.
- 6. On 06/24/2009 at 4:00pm a 16-year-old subject, working in conjunction with Milwaukee Police on the Wisconsin WINS tobacco initiative, was able to purchase a pack of tobacco product from a clerk at 2707 West Burleigh Street (A and I Petroleum). The clerk, Asghar A. Choudhry, was cited for Sale of Cigarettes to Minor/Underage. This citation was later dismissed without prejudice in Milwaukee Municipal Court. The applicant was not cited.
- 7. On 01/26/2010 the applicant met with Lieutenant James MacGillis, Officer Minisha Howard and Officer Ray Robakowski, all of the Milwaukee Police Department, in the conference room at Milwaukee Police District #5 concerning the illegal activity around the licensee's properties. The applicant indicated he had recently installed drop safes in his businesses and that he makes cash pick-ups from the businesses during the day. He further stated that this business has 16 digital security cameras at the business with 4 of those cameras being outside and he welcomes additional police presence. The applicant states he has assisted police previously by providing DVD copies of surveillance footage from his security cameras and that he encourages his employees to both cooperate with police and to call if there are any problems. The applicant was provided with contact information for District #5 and the Community Prosecution Unit.

- 8. On 04/26/2012 Milwaukee police responded to a Battery/Robbery complaint at 2707 West Burleigh Street. Investigation revealed the victim was purchasing items from the business when the suspect attempted to take her purse from her auto. When the victim's boyfriend intervened, the suspect struck him in the head with a glass bottle. Milwaukee police incident report #121170024 filed.
- 9. On 01/12/2012 Milwaukee police conducted a security survey at 2707 West Burleigh Street in an attempt to combat some of the violent crime occurring in the area.
- 10. On 06/12/13 at 9:45am, a Milwaukee Police Officer along with an agent from the Wisconsin Department of Revenue conducted a licensed premises check at 2707 W. Burleigh St. (Gas Depot). The employee on duty was able to provide the agent invoices for cigarette and tobacco purchases. The licenses were current and posted. No violations were found.

11. On 09/23/19 Milwaukee Police were flagged down for a complaint of multiple subjects dealing drugs in front of the gas station located at 2707 W. Burleigh St. On arrival officers observed 6-8 subjects loitering in front of the location, who upon sight of the officers began to walk away. Upon entering the business officers interviewed a male sitting on top of a ice cream cooler. The subject was wearing a plain white t-shirt and blue jeans and notified officers he was security. The subject referred officers to a female in the store who he identified as being in charge. The female stated she owns the security company. Both individuals were uncooperative with police, refusing to identify themselves. The agent was notified via telephone and the subjects eventually provided identification. The clerk on scene was cooperative.

On 09/23/19 at 11:34pm, PO Joshua HERMANN and I (SQ#5466) were flagged down by a citizen in our squad car who stated that there were multiple subjects dealing drugs in front of the gas station. PO HERMANN and I turned around and drove into the parking lot. I observed (6-8) subjects loitering in front of the entrance door who immediately upon sight of police began to walk away or behind the store. I did not observe any security on the property or inside the store upon arrival.

I observed a man identified as Joe R. TAYLOR (B/M 03/31/94) sitting on top of an ice cream cooler. I asked TAYLOR if he worked at the store, TAYLOR stated he was security. TAYLOR was wearing a plain white tee-shirt without any identifying markings/characters stating that he was security and blue jeans. I asked TAYLOR why we were being flagged down by citizens regarding drug dealing in front of the store. TAYLOR stated that he did not observed any drug dealing. I began to inform TAYLOR of the complaint and asked who he worked for. TAYLOR stated "he's security" and that he "helps out". I asked TAYLOR how he assists. TAYLOR stated "I keep everything died down so there are no altercations."

I asked what he does when there is a large group congregating in front of the store and that he should tell them to disperse. TAYLOR replied "Don't you think I do that?" I asked why he does not call police at that point. TAYLOR stated "She's in charge of that." (Referring to the other security guard). TAYLOR continued that stated that it was her job to call us. I informed TAYLOR that the business hired security to prevent possible problems from occurring and to ensure that people are not loitering in front of the business. TAYLOR replied "I do what is in my job description". I asked TAYLOR what his job description was. At that time, a woman later identified as Tiaira A. TURNER (B/F 04/02/93) walked up to TAYLOR and I and stated "He's Security". I asked TURNER what they do for security. TURNER stated "Patrol, watch the store" I asked TURNER what they do about the subjects dealing drugs in front of the store. TURNER stated "We move them around, that's why when you pulled up I was actually..." I informed TURNER that when PO HERMANN and I arrived, I observed her (TURNER) talking on her cell phone in the parking lot. I asked TURNER what security company they work for. TURNER stated "For myself". I asked TURNER if she owned a security company. TURNER stated yes. I asked what the name of the company was.

TURNER stated "Slabe Security". TURNER was wearing a gray security type shirt (no patch or badge), black pants, and a multi-colored hair wrap.

I asked TURNER if she had her required WI-Security Persons License on her. TURNER stated that she had a license however did not have it on her person. I asked how long her company was employed by the gas station. TURNER became argumentative regarding and stated that her company has been at the gas station for approximately (9) month. I informed TURNER that was incorrect due to my recent contact with a different hired security company within (2) months prior to tonight.

I asked both TAYLOR and TURNER for their WI-IDs. TURNER asked "For what?" I informed TURNER that it was for my report due to a call for service. I further stated that they are both employed by the business and that they are required to provide myself with their information for my license report. TURNER stated that she would not identify herself to me. I informed TURNER that I would be notifying the owner Younas MOHAMMAD (A/M 11/02/59) regarding this incident and that it will look negative against the business due to their noncooperation. TURNER then pulled her cell phone out and called MOHAMMAD. I asked TAYLOR for his identification. TAYLOR refused. I informed both TAYLOR and

TURNER that they were legally detained for my investigation and not free to leave.

TURNER passed her cell phone to me. I began speaking with MOHAMMAD on the phone. I informed him of why we were at the business and that nature that we were flagged down by a citizen regarding the drug dealing complaint. I informed MOHAMMAD that my report would reflect their noncooperation and that it would be in the businesses' best interest for them to comply. When I passed the cell phone back to TURNER, MOHAMMAD informed her to identify herself to me regarding. TAYLOR and TURNER both gave me their information at that time. TURNER began to explain that TAYLOR was "training" and that he was not in a position to have a uniform at this time. TURNER then stated that "not everyone that works security here wears a uniform." I informed TURNER that it would be a good option for all security to wear uniforms to identify themselves as security. s

I made contact with the store clerk identified as Dilpreet SINGH (A/M 10/12/00) regarding the complaint. SINGH was very cooperative.

Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
