This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/26/2011 at 9:15pm Milwaukee police responded to a theft/disorderly conduct complaint at 5501 N. Lovers Land Rd. (Mobil Gas Station). Investigation revealed that 7-9 subjects created a disturbance inside the business by knocking items from store shelves. These same subjects then fled the store with approximately \$100.00 worth of unpaid for merchandise. Milwaukee police incident report #113540107 filed.

2. On 09/29/2018 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a Black and Mild cigar from the clerk at Hwy 45 Mobil, 5501 N. Lovers Lane Rd. The clerk did not ask for ID. The clerk admitted the sale, saying the juvenile looked old enough. The applicant was mailed a MARTS enrollment package.

3. On 03/23/20 at 10:15pm, Milwaukee Police were dispatched to 5501 N. Lovers Lane Road for a shooting complaint. Investigation revealed, through surveillance footage, the victim and another subject enter a vehicle on the north side of the filling station. After about a minute, both subjects exited the vehicle very quickly and the victim entered the station with a gunshot wound to the leg. The other subject left camera view running and the suspects' vehicle fled the parking lot of the station. The clerk said she heard what she though was a gunshot and a short time later the victim entered the establishment with a gunshot wound, so she called police. The employees were cooperative with the investigation.

This report is written by P.O. Jason FINLEY, assigned to District Four, Late Power Shift, Squad 4486.

On Monday, March 23, 2020 at approximately 10:15 PM my partner, P.O. Lee XIONG and I (in full duty uniform, marked MPD squad, and equipped with AXON 2 body cameras) were dispatched to 5501 N. Lovers Lane Rd. (Silver Spring Highway 45 Mobile) located in the City and County of Milwaukee, Wisconsin for a shooting complaint. (PLEASE REFERENCE SHOOTING CAD:200832549/ IR:200830139 FOR A DETAILED REPORT OF THE INCIDENT)

Upon arrival, it was determined there was a confirmed shooting that took place in the parking lot of the gas station. The victim, identified as Christopher K. EASLEY (m/b, 06/30/98) was inside the gas station laying on the floor in front of the window to the clerk. EASLEY stated he had been shot outside the gas station in the parking lot by an unknown subject.

I was able to review the video from the gas station, which showed EASLEY and another subject enter a black, possible Toyota Camry, 4DR, with no window tint on the north side of the gas station. EASLEY enters the front driver's seat of the vehicle, and the unknown subject gets in the right rear passenger seat. Both EASLEY and the subject are in the vehicle for approximately (1) minute before exiting the vehicle very quickly. Both EASLEY and the subject he was with, then took off running towards the front entrance of the store. The unknown subject leaves camera view, and I observed EASLEY enter the store bleeding and holding his leg. EASLEY waited in the store until police and the Milwaukee Fire Department arrived. The suspect and the suspect vehicle, then fled the location north on N. Lovers Lane Rd.

I spoke with the clerk at the time of the incident, who identified herself as Latia M. BALL (f/b, 07/22/80) who stated she was working behind the counter when one of her friends had came to pick her up because it was almost time for her to go home. She stated she was inside with her friend, when she heard what she believed to be a gun shot. BALL stated before she knew it, the subject who was shot (EASLEY) was inside the gas station asking her and her friend to call 911 because he had been shot, and that they were trying to rob him. BALL stated she and her friend, immediately called 911 regarding the incident. BALL stated she did not look outside, and that she was actually ducking slightly behind the counter because she did not know where the shooter was and or if her/she was going to be coming in the store.

BALL was very cooperative with the investigation and stated she did not have access to the cameras, but did contact Zelda R. SPEARS (f/b, 12/08/86) who is one of the managers of the gas station. SPEARS responded to the scene, and was able to access the cameras for us. SPEARS was also very cooperative with police and the investigation.

The gas station is licensed for the following:

Cigarette and Tobacco, Extender Hours, Filling Station, Food Dealer Retailer, and Weights and Measures. All licenses were properly displayed, and all licenses are valid until 06/30/2020.

The hearing before the Licenses Committee will take place virtually on 6/2/2020 at 9:30 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
